- A. <u>735 737 Columbia Street</u>: Site plan application submitted by Carla Kaya Perez-Gallardo seeking approval to convert the existing auto service center into a restaurant and event space. As stated by the City of Hudson's CEO, the property is in the General Commercial Transitional (GCT) zoning district and is permitted to use.
- B. <u>A. Colarusso & Son, 175 South Front Street:</u> The Public Hearing has been cancelled. There is no planned discussion other than to reschedule the public hearing for September 27, 2023.
- C. <u>6-12 Hudson Ave.</u>: Site plan application submitted by owner, Walter Chatham to subdivide the parcel and create 16 building lots for eight detached single-family dwellings and eight attached rowhouses.
