**A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT  
BETWEEN CITY OF HUDSON YOUTH CENTER AND COLUMBIA COUNTY  
RECOVERY KITCHEN, INC.**

**WHEREAS**, the City of Hudson Youth Center (“HYC”) desires to enter into an Agreement with Columbia County Recovery Kitchen, Inc. (“CCRK”), for the supply of meals for children at Christ Church Episcopal and the Youth Center; and

**WHEREAS**, CCRK has agreed to provide 60 meals per day, Monday through Friday, for HYC starting September 9, 2024. HYC staff members will pick up and sign for the meals. The cost of each meal, which will be individually prepared and packaged, will be \$7.00 per meal. 20 meals will be prepared for the children at Christ Church Episcopal and 40 meals for the children at HYC. Additional meals, if needed, can be added to this contract upon request; and

**WHEREAS**, CCRK agrees to provide HYC with meals that meet the CACFP requirements. Beverages will not be provided with the meals. HYC agrees to CCRK for all meals under the terms of this agreement and will be invoiced monthly; and

**WHEREAS**, the Common Council for the City of Hudson now desires to approve the aforementioned Agreement between HYC and CCRK as outlined in the annexed Agreement.

**NOW, THEREFORE BE IT RESOLVED**, that the Mayor is authorized to execute the annexed Agreement between the City of Hudson Youth Center and Columbia County Recovery Kitchen, Inc. for the provision of meals to children at the Christ Church Episcopal and Hudson Youth Center beginning on September 9, 2024.

## AGREEMENT

City of Hudson Youth Center & Columbia County Recovery Kitchen, Inc.

This is an agreement between the Columbia County Recovery Kitchen, Inc. PO Box 268, Hudson, New York 12534 and the Hudson Youth Center, 18 South Third Street, Hudson, New York 12534.

The agreement will be in effect from September 9, 2024 until the CACFP contract with the Hudson Youth Center is finalized. This contract may be terminated by mutual consent or by each party for Reasons of cause with at least 15 days' notice.

Columbia County Recovery Kitchen, Inc. (CCRK) agrees to provide 60 meals per day, Monday through Friday, for the Hudson Youth Center (HYC) starting September 9, 2024. HYC staff members will pick up and sign for the meals. The cost of each meal, which will be individually prepared and packaged, will be \$7.00 per meal. 20 meals will be prepared for the children at Christ Church Episcopal and 40 meals for the children at the Youth Center.

Additional meals, if needed can be added to this contract upon request.

CCRK agrees to provide HYC with meals that meet the CACFP requirements. Beverages will not be provided with the meals. HYC agrees to CCRK for all meals under the terms of this agreement and will be invoiced monthly.
