

UPDATED TO INCLUDE, WHERE APPLICABLE, DELINQUENT 2024 SCHOOL TAX AND DELINQUENT 1ST AND/OR 2ND QUARTERS OF 2025 CITY/COUNTY TAX

While delinquent 2024 school and any delinquent 2025 city/county do not themselves trigger inclusion on the list of parcels at risk of foreclosure, they must be paid in full before any payments can be applied to the prior year balances. We are required by law to apply payment to the most recent delinquent balances first, and work backward.
