Comments provided during the hearing will be considered during preparation of the City's Fiscal Year 2024-25 Annual Action Plan, which is a document that combines into a single submission the planning and application aspects of the Community Development Block Grant (CDBG) and HOME Investment Partnerships (HOME) programs. The public hearing also serves to assess whether changes in perception of community development and housing needs or implementing projects have occurred since adoption of the Five-Year Consolidated Plan for Fiscal 2020-21 – 2024-25. Residents and agencies serving low- and moderate-income populations in Huntington Beach are invited to participate in the public hearing and present their comments and/or write to the City of Huntington Beach, Community Enhancement Division at 2000 Main Street, 5th Floor, Huntington Beach, CA 92648 before the CPAB public hearing on January 18, 2024.

Special accommodations for disabilities and/or language barriers are available upon request, including translation services, as required by the City's Citizen Participation Plan.
