THE MOTION TO APPROVE THE ITEMS ON THE CONSENT AGENDA CARRIED UNANIMOUSLY. Absent: Commissioners Lawrence, Polsdofer, and Willis.

1. <u>Sheriff's Office</u> – Resolution to Authorize the Ingham County Sheriff's Office to Continue the Employee Firearms Purchase Program

MOVED BY COMM. PEÑA, SUPPORTED BY COMM. SCHAFER, TO APPROVE THE RESOLUTION.

Commissioner Trubac stated they would like some additional background information.

Andrew Bouck, Undersheriff, stated the Employee Firearms Purchase Program allowed Sheriff's Office licensed and unlicensed Corrections Deputies to purchase firearms and accessories via a payroll deduction. Undersheriff Bouck further stated that the benefit was that they could purchase state of the art firearms specific to their assignments with updated optics and accessories, which would otherwise cost the County a lot of money to update each time a new generation came out.

Undersheriff Bouck stated that it was important that optics and specifications of firearms were fit to the individual's specifications.

Commissioner Trubac asked for clarification that this program was directed towards Deputies assigned to the Hospital Guard Team, and if that meant the folks who took inmates to the hospital.

Undersheriff Bouck stated confirmation and that the Corrections Deputies assigned were in charge of guarding inmates who went off-site to the hospital, and at which point their body armor, gun belt, and firearm were put on. Undersheriff Bouck further stated that the program provided the opportunity to purchase their own firearms via payroll deduction with their own optics and specifications, instead of the County purchasing the firearms they would use.

Undersheriff Bouck clarified there were no guns in the jail, and the Corrections Deputies only wore their firearms when they went off-site in an unsecure environment.

Commissioner Trubac asked if those firearms were the only weapons the Corrections Deputies had or if they were assigned a weapon by the County.

Undersheriff Bouck stated they would be assigned a weapon, but if they chose to participate in the program, they would not use it, and the firearm would go back into the armory until it either needed to be traded in or used elsewhere. Undersheriff Bouck further stated those who participated were limited on what firearm they could purchase and that they were same firearms that would have been issued to them without the optics and other accessories.

Commissioner Trubac asked for clarification between the licensed and unlicensed Deputies.

Undersheriff Bouck stated that the Corrections Deputies were Deputy Sheriff's, but they were not licensed Law Enforcement Officers and they did not have arrest authority, rather they had the authority to guard and protect inmates in the care and custody of the Sheriff's Office.

THE MOTION TO APPROVE THE RESOLUTION CARRIED UNANIMOUSLY. Absent: Commissioners Lawrence, Polsdofer, and Willis.

#### **Announcements**

Director, as it seemed that they were doing many different things to raise funds and that they were putting a lot of passion into it, so it made it easier for her as a Commissioner to match their funding down the road if needed.

Chairperson Johnson stated they had recently visited the Thumb Correctional Facility in Lapeer County and that it was an interesting experience, especially after visiting the Ingham County Jail. Chairperson Johnson further stated they had the opportunity to try the food and speak to 150 inmates with Martel Smith, Senior Juvenile Court Officer.

# RESOLUTION TO AUTHORIZE A THREE-MONTH EXTENSION OF THE LEASE AGREEMENT FOR THE TEMPORARY PUBLIC DEFENDER'S OFFICE SPACE AT 300 SOUTH WASHINGTON SQUARE, SUITE 315

WHEREAS, the Ingham County Public Defender's Office requires continued temporary office space while awaiting completion of its permanent location; and

WHEREAS, the County previously entered into a six-month lease agreement with Eyde Knapp Development, LLC for Suite 315 at 300 South Washington Square, Lansing, Michigan; and

WHEREAS, the lease term is set to expire in April 2025, but an additional three-month extension is available under the agreement; and

WHEREAS, the County seeks to extend the lease through July 2025 to ensure uninterrupted operations for the Public Defender's Office; and

WHEREAS, the monthly rent shall remain at \$7,500, and all other terms of the lease shall remain unchanged.

THEREFORE BE IT RESOLVED, that the Ingham County Board of Commissioners authorizes a three-month lease extension with Eyde Knapp Development, LLC for Suite 315 at 300 South Washington Square, Lansing, MI through July 2025 for \$7,500 per month.

BE IT FURTHER RESOLVED, that all payments for this lease agreement will be made to Eyde Knapp Development, LLC, with funds available through the Michigan Indigent Defense Commission (MIDC) grant for the fiscal year 2024-2025.

BE IT FURTHER RESOLVED, that the Board Chairperson is authorized to sign any necessary documents consistent with this resolution, subject to review and approval by the County Attorney.

As you see in the table below, I have googled adjacent counties in our vicinity for comparison of fees.

County	Sterilized	Non-sterilized
Clinton	\$10	\$15
Eaton	\$15	\$20
Jackson	\$10	\$20
Livingston	\$10	\$25
Shiawassee* One time fee	\$10	\$30

These fees separated at a greater rate (become more out of line) when compared to a three year fee program.

Here are a few questions that I believe need to be considered:

- Are our dogs more destructive than those in adjacent counties?
- 2. Are they prone to more diseases?
- 3. Or are they just a victim of poor monetary practices?

In closing, pet owners love their fur babies and will do what is necessary for their health and safety. Those who are neglect in payment will do so no matter how outlandish the fees may be. Also <u>remember that fees are taxes on citizens</u> – do you feel we are overtaxed?
