### **Ingham County Fair Youth Livestock Show General Rules**

- 1. Participation in Youth Livestock Departments is open to youth who are members of clubs in Ingham County including but not limited to 4-H, FFA, Boy Scouts, Girl Scouts, Religious Youth Organizations, Community Youth Organizations, School Clubs, sports clubs. While there is not an Ingham County residency requirement, there is an Ingham County Club requirement. The Club must be indicated when registering for classes on ShoWorks.
  - A. New clubs that have not previously registered with the Fair must submit a club application and get approval from the fair office by April 15<sup>th</sup> to be eligible to show and sell. The club application can be found at <a href="https://www.Fair.ingham.org">www.Fair.ingham.org</a>.
- 2. Exhibitors must be between the ages of 5 and 19 as of January 1<sup>st</sup> of the current Fair year unless specified otherwise in specific project rules.
  - A. 5 6 years of age: Pee Wee Classes (able to show another exhibitors animal)
  - B. 7 19 years of age: able to show their own animal and sell in the auction.
- 3. Exhibitors may not show the same project in more than one Fair in the same year.
- 4. Fair entries & fees are due by June 20<sup>th</sup> through ShoWorks. If you need assistance registering, please contact the Fair Office. There will be no judging of exhibits which have not been entered.
- 5. Admission into the Fair will cost youth exhibitors \$12 for the week. Siblings to exhibitors under age 18 are eligible for \$12 admission wristbands.
  - A. There will be a \$15.00 fee for replacement of lost wristbands.

- 6. **EXHIBITS BY YOUTH WITH DISABILITY CONDITIONS:** All youth regardless of disability conditions or lack thereof must meet all requirements as announced in the Premium Book. Entry Tags on Exhibits made by Youth with disability conditions should include a handwritten letter "D" clearly visible to Fair Officials at time of judging. Participants 26 years of age or younger, who have been determined to be eligible for special education services by the local school district, will be able to exhibit in Youth Livestock Departments.
- 7. Exhibitors should wear neat, clean outfits & appropriate footwear. No shorts allowed while showing.
- 8. YQCA certificates must be turned in at check- in for all large animals.
- 9. Exhibitors must have their livestock projects in their possession by the date specified in each specific project area of the Fair Premium Book.
- 10. Exhibitors shall show their own animals, unless special permission from the Superintendent is given for a substitution. All market livestock exhibitors must be the owner of their animals. For showmanship classes a member must show their own animal & this animal must be shown in another market or breed class by the same member. Arrangements may be made with the superintendent (at animal check-in) in the case of extenuating circumstances if a member will not be able to exhibit their own animal.
- 11. First & second place winners in Sheep, Swine, Beef, Dairy, Dairy Market & Goat showmanship classes and the two highest placed members in the Horse showmanship are eligible to compete in the Large Animal Little International Contest. First place winners in the Rabbit, Cavy, Poultry, and Dog showmanship classes are eligible to compete in the Small Animal Little International Contest.
- 12. All livestock must conform to the most current Health Requirements from the Michigan Department of Agriculture.
- 13. All livestock exhibitors, superintendents, & leaders are expected to read & follow the Ingham County Fair <u>Animal</u> Health Plan.
- 14. Exhibitors must furnish their own feed, bedding, water pails, troughs & pitchforks.
- 15. All exhibitors are expected to assist with the set-up & tear-down of pens, cages, & exhibit areas on the designated day & time for each species they exhibit. Dates & times will be announced by each superintendent & published by the Fair Office.
  - A. See Superintendent about assigned stalls for your club.
- 16. Clubs are held responsible for cleaning stall space assigned to them. Animals of each club will be stalled together by species as much as possible. Clubs are required to house beef & dairy separately.
- 17. All livestock will be washed & fed in designated areas only. Exhibitors using any area other than the designated wash rack for washing of animals and/or feed pans will be asked to remove their animals from the Fairgrounds immediately.
- 18. All livestock will be judged in the order the superintendent posts. Judges may alternate breeds by Classes. All market classes are divided by superintendent according to weight.
- 19. Ribbons will be given according to placing marked in the judge's records. THE JUDGE'S RECORDS ARE FINAL.
- 20. NO JUDGE SHALL JUDGE ANY EXHIBIT IN WHICH SHE/HE HAS A FINANCIAL OR IMMEDIATE FAMILY INTEREST.

### **Release of Exhibits**

- 1. All take home animal exhibits (including tack & displays) will be released between 8:00 a.m. and 10:00 a.m. on Sunday August 3<sup>rd</sup>, unless otherwise noted. All animals MUST have access to water & food until they are released.
- 2. If an animal or exhibit is removed from the fair early without permission from the species superintendent, the exhibitor will forfeit all awards and sale money and will not be allowed to show the following year.

### **Code of Conduct**

- The Ingham County Junior Livestock Association and Fair Board are committed to a safe and respectful show environment and experience that respects the rights of each and every attendee. All exhibitors' parents, and other spectators are expected to exhibit outstanding sportsmanship as well as abide by the standards of the Code of Conduct.
- 2. The ICJLA Code of Conduct requires exhibitors, their parents, leaders, spectators, etc. to refrain from the following:

  A. Behavior that is unruly, disruptive or illegal in nature.

- B. Any possession or consumption of alcoholic beverages in the areas where animals are being penned or handled.
- C. Intoxication or other signs of alcohol or substance impairment resulting in poor behavior.
- D. Foul, obscene, threatening, offensive or abusive language, gestures or actions.
- E. Interfering with the progress of the show.
- F. Failing to follow the instructions of show personnel.
- G. Fighting or physical violence of any type.
- H. Conduct that endangers any other person.
- 3. Violators of the ICJLA Code of Conduct, as well as their immediate family members, are subject to disciplinary action included but not limited to cancellations of all premiums as well as suspension from current and future ICJLA events, at the sole discretion of the Superintendents/Directors.
- 4. Under no circumstances should a leader, exhibitor or a parent be confrontational, verbally harass, or argue with a judge or a Superintendent, nor complain to people in the area. Complaints & suggestions are taken at The Fair Office. Please remember that showing at the Fair implies that you are asking for the judge's opinion & agreeing to accept it. See Enforcement & Handling Disputes on the following page.

### Livestock Health, Care & Ethics Rules

- Each exhibitor is responsible for the complete care of their animals at the fair. If animals are found not watered, fed, milked, or pens/stalls not cleaned, the exhibitor & animal may be excused from the fairgrounds & forfeit ability to show next year at the discretion of the Junior Livestock Association & Fair Manager or designee. The exhibitor may forfeit all awards earned!
- 2. It is the expectation of the fair management that all animals, exhibit areas & pens will be cleaned <u>daily</u> & animals are fed by 8:00 a.m. or prior to the species show, whichever is earlier. Exhibitors may complete evening chores after the conclusion of the show activities for the day. Exhibit animals are on display to the public—exhibitors should strive to always maintain cleanliness.

### Homegrown Livestock (Beef, Sheep, Swine)

- 1. The learning objective of the homegrown class is for youth to have the opportunity to experience the market animal project from birth through marketing of the animal. Exhibitors should gain & be able to demonstrate skills in animal husbandry, critical thinking, decision-making, & record keeping through their animal project.
- 2. Youth must be in possession of & own or lease (with written documentation) the mother of the animal being exhibited at the time of birth of the project animal.
- 3. Youth must complete the Homegrown verification form and turn into superintendent no later than March 15th.
- 4. The project animal & Dam must be housed on the property of the youth's immediate family (parents or grandparents) throughout the duration of the entire project cycle.
- 5. Youth is to provide at least 80% of management & labor for project animals.

### **Livestock Auction General Rules**

- 1. No exhibitor is permitted to act as bidder on any animal in the sale.
- Youth exhibitors may not sell the same species in livestock sales in two different counties.
- 3. Animals MUST be shown to sell; the animals' placing in market class will determine sale order. Animals not shown on show day cannot be sold in the sale. Any disqualified animals will not be sold at the auction. Judges, Superintendents, and ICJLA Representatives may also prohibit animals from being sold if declared unfit.
- 4. It is the responsibility of all exhibitors to get their animals to the sale ring. Members must sell their own animal unless authorized by the Superintendent to do otherwise.
- 5. Any animal entered in the sale and printed on the sale bill must be sold unless declared unfit by the superintendent. If not, that member will not be eligible for the next year's animal auction. Confirm with your superintendent if your animal will not be sold in the auction before Tuesday (it will be assumed all animals entered in market classes will be entered in the auction; small animals must complete auction entry cards at check-in); be sure to indicate post-fair shipping destinations.

- 6. Members are responsible to care for their animals until they are claimed by buyers or shipped. Animals must always have access to feed and water.
- 7. All animals are required to have safe & effective halters on until the buyer claims them or are sent to market. Exhibitors may not remove any ear tags or identification from animals exhibited, including Ingham County Fair tags. Check with the superintendent if you have questions.
- 8. Members must write a letter of appreciation to the buyers of their stock.
- 9. A commission rate of \$25,000 or 5%, whichever is lower, and does not include Add On's, on all stock and milk sold will be deducted from the selling price to cover expenses.
- 10. Show attire MUST be worn in the sale ring.
- 11. Market animals will not be released from the Fairgrounds no earlier than 8:00 a.m. Sunday (animals trucked to a terminal market by the ICJLA will be loaded out prior to take home animal release.)
- 12. Sale weight for all animals will be fair weigh-in weight.
- 13. Exhibitors winning Grand and Reserve Grand Champion awards in each species are required to sell. A member may sell a maximum of two lots per auction, unless the member has more than 2 Grand Champion or Reserve Grand Champion animals. If an exhibitor chooses to show 3 or more lots (per auction), they must sell all receiving "Grand" designation; if they receive 3 "Grand's", they must sell all 3 lots. If they do not receive "Grand" on all lots, they must sell all lots that receive "Grand" and may choose to sell an additional animal up to the allowable 2 sale lots per auction. A lot is considered 1 individual beef steer, dairy feeder, dairy steer, and 2 swine or sheep.

# LARGE ANIMAL SALE Thursday, July 31<sup>st</sup> at 12:00 p.m. Main Arena Building SALE ORDER FOR 2025: Dairy Steers, Beef Steers, Milk, Sheep, Swine, Dairy Feeders

- 1. Animals required to sell: Grand Champion and Reserve Grand Champion in the following species—swine, sheep, beef, dairy steer, dairy feeder, dairy milk, and beef carcass; Grand Champion and Reserve Grand Champion pens in the following species.
- 2. Exhibitors that choose to sell two individuals in the sheep or swine species will have their animals listed consecutively in the sale bill, thus selling both of their animals in the sale arena at the same time (superintendent or sale chairperson may instruct exhibitors to bring only one of the two animals they are selling). The exhibitor's order in the sale bill will be determined by the higher placing animal of the two individuals. Exhibitors will bring only one of the two animals they are selling to the arena unless the exhibitor is selling a Grand or Reserve Champion sheep or swine. A sale lot consists of one or two individual animals in the sheep or swine project.

# SMALL ANIMAL SALE Saturday, August 2<sup>nd</sup> at 11:00 a.m. Main Arena Building SALE ORDER FOR 2025: Goat Milk, Poultry, Rabbits, Goats

- 1. Animals will sell per head. Animals sold in the Small Animal Sale or for Resale are sold as is.
- 2. Pedigree papers on purebred animals must be presented to the Sale Committee before the sale.
- 3. Protected or licensed birds are not eligible for the sale.
- 4. In the event animals are resold in the auction, 100% of the price will go back to the Junior Livestock Association.
- Members must sign up with the Superintendent to sell in sale by Tuesday
- 6. Meat animals plus breeding stock in the following areas may be sold: Poultry, Waterfowl, Rabbits, Turkeys; also meat goats and goat milk.

### **Livestock Drug Testing Policy/Procedure**

Policies for the Fair and/or Executive Director/Livestock Supervisor

### **POLICY:**

Ingham County Fair shall reserve the right to drug test any or all livestock entered the Ingham County fair at the
discretion of the Fair Management or the Livestock Superintendent and/or his/her designated representative.
(Exhibitors are required to administer only substances approved by the Federal Food and Drug Administration, the
United States Department of Agriculture and/or the Ingham County Fair for any animal/s.

- 2. Use of any drug, chemical or feed additive must be per the legal use of the approved chemicals/compounds and the applicable withdrawal period as recognized by the FDA must have expired prior to departure. The Fair's veterinarian authorized representative may collect urine, blood, hair, tissue and/or other samples as needed in order to conduct the test/s.
- 3. The expense for the drug testing, including lab and collection fees, shall go to the person/s owning the animal/s if the test results show proof of the improper/illegal drug use/residue of the drugs. They will also forfeit any ribbons, trophies, and/or premium monies. The expense of the drug testing, including lab collection fees will go to the person(s) owning the animal(s) if the test shows proof of the improper/illegal drug use/residue of the drugs. They will also forfeit any ribbons, trophies and/or premium monies. This violation will result in a one year suspension from the Ingham County Fair. In order to be permitted to show at the Ingham County Fair after the one year suspension, all animals brought by that exhibitor must pass a drug test prior to the Fair at the expense of the owner/exhibitor for the next three years. If the said animal/s is determined to be negative for any improper/illegal drug use/residues, the expense of the testing including lab and collection fees will be the responsibility of the initiating party.
- 4. Complaints must be filed within 2 hours of the show ending. A \$1,000 fee will be required to be paid to the Fair office by the complainant at the time the complaint is filed by cash only. If an exhibitor/parents' wishes to lodge a complaint against more than one exhibitor or multiple animals for the same exhibitor, the fee is \$1,000 per animal.
- 5. The exhibitor and/or parents who the complaint is against will have the opportunity to read the written complaint.
- 6. Unethical & inappropriate, otherwise inhumane treatment of animals for show preparation is not acceptable. ANY VIOLATION OF THE FOLLOWING RULES WILL AUTOMATICALLY RESULT IN DISQUALIFICATION and subject to further review by the JLA executive committee, fair representative, and superintendent. and penalties.
  - A. Drug use policy & procedures: Refer to Livestock Drug Testing Policy/Procedure in the General rule section of the Fair Book.
  - B. Any attempt to change the natural color of an animal, either purebred or crossbred, by changing the color of hair, fleece or skin at any point, spot or areas of the animal's body. False switches are not permitted.
  - C. Misrepresenting the age of the animal for the class in which it is shown.
  - D. Minimizing the effects of cramping by feeding or injecting drugs, depressants or applying packs or using any artificial contrivance or therapeutic treatment except normal exercise.
  - E. Striking the animal to cause swelling in a depressed area.
  - F. Surgery of any kind performed to change the natural contour or appearance of the animal's body or hide.
  - G. Insertion of foreign material under the skin.
  - H. The use of alcoholic beverages in the feed or administered as a drench.
  - I. Criticizing or interfering with the judge, exhibitors, superintendents, & other show officials or other conduct detrimental to the exhibition or show.

### **PROCEDURES:**

- 1. Request the animal drug testing supplies from the Michigan Department of Agriculture, Laboratory Division, at least thirty days prior to the event.
  - A. The request must be made by mail or FAX 517-337-5094. For questions or information, contact Gina Dewitt, Equine Drug Testing Section at 517-203-1356 or 517-337-5082.
- 2. Ensure that exhibitors are informed "well in advance" that drug testing may be conducted on their animals. Notification of the Fair's drug testing policy/procedure shall be included in the premium book.
  - A. NOTE: The fair has legal authority to require drug testing under the Animal Industry Act, Act 466 of 1988, as amended, in Section 40(3):" A fair, exhibition, exposition, or show authority may require additional testing or vaccination of animals before entry and during the fair, exhibition, exposition or show."
- 3. Ensure that the exhibitors and their parents/guardian sign a Livestock Drug Testing Affidavit form (obtained from Fair Office) when a drug test occurs.
- 4. Ensure that a Fair's veterinarian/authorized representative conducts the drug testing.
- 5. Ensure that the exhibitor, parent/guardian and or animal representative accompany their animal at all times during the collection procedure. If the exhibitor has a representative accompany the animal for collection, make sure the exhibitor and his representative sign the "Exhibitor Representative" form. Forms are available at the Fair office
- 6. Disqualify any animal, live or slaughtered, found in violation of the use of drugs, chemicals or feed additives.

7. The Fair's veterinarian/authorized representative may collect urine, blood, hair, tissue and/or other test samples as needed.

### **ENFORCEMENT & HANDLING DISPUTES:**

- 1. The project superintendent or their designated species representative from the Junior Livestock Association or Fair Board reserves the right to reject any exhibit in violation of rules. This includes species specific rules printed in this Fair book contained under general or specific project sections. Should there be a dispute regarding handling of a rule violation the complainant should first:
  - A. Contact the appropriate superintendent or their representative to discuss concerns and determine if rules have been violated.
  - B. If there is not satisfaction with the determination or resolution of the rules violation, a committee consisting of the superintendent, and three representatives from the ICJLA shall be designated to collectively review the rule violation.
  - C. The Fair Manager or their designee shall be kept informed of what decisions are being made should it be considered this may impact the Fair management/board.
  - D. The dispute resolution should be handled as quickly as possible. Situations occurring at the fair should be handled at the fair when possible.
  - E. Complaints regarding the conduct of an exhibitor should be addressed by ICJLA Representative & fair manager.
  - F. All sanctions or disciplinary actions to be carried out by ICJLA Representative or fair management (as appropriate to the situation).
- 2. Infractions that involve breaking the law will be turned over to law enforcement.

### **Sample Collection Procedures:**

Performed by the Veterinarian/authorized representative

- 1. Verify the animal with the owner. Identify any tattoos, ear tags, ear notches that are on the animal. Whenever possible use USDA official identification vs. farm identification. Be sure to include this information on the "Sample Tag".
- 2. Open the sample case by breaking the seal, and noting the seal number. Immediately record the seal # in the top right box of the Sample Transmittal Packing List (see attached form with kit). Verify that each individual sample container has an intact "Security Seal".
- 3. Present the container for examination to the representative (exhibitor) of the animal you are about to test. If the container is rejected for any reason, use another container and return the defective one to the laboratory.
- 4. Open the container by pressing upward on the tab marked open, breaking the seal.
- 5. Place the container in a catching stick; fold the lid back and anchor it under the metal finger welded to the handle.
- 6. After collecting the sample, close the lid and snap it completely shut. Loop the barbed plastic strip on the sample container through the two holes in the container tabs and pull snug. Apply a short piece of evidence tape across the lid and down sides of the container.
  - A. NOTE: An example of a properly sealed and labeled container is included with the provided supplies.
  - B. NOTE: If a urine sample cannot be obtained, a Michigan Licensed Veterinarian/Veterinarian Technician may collect five tubes of blood. Each tube of blood must be identified with the tag number/barcode provided on the "Sample Tag". Seal all the labeled blood tubes inside a plastic sample container as described below.
- 7. Complete the information on a "Sample Tag" substituting the name of the fair for "Track", the name of the animal (Grand Champion Steer, Reserve Champion Steer, etc.) for "Horse" and the ear tag number or other unique identification number or "Tattoo". Have the representative of the animal sign under "Witness" after they watch the sample sealing.
- 8. Place one large sticker tag on the top of the container and the other large sticker tag on the side of the container. The bottom part of the "Sample Tag" must be kept in a secure manner for cross-reference when test results are reported. DO NOT send the bottom part of the "Sample Tag" to the lab.

- 9. Lock the sealed and labeled sample container in a metal can. Once the can is locked it cannot be opened until it reaches the lab.
- 10. Samples must be held secure and cold until transferred to the laboratory.

A. Note: urine can be kept frozen, blood must be kept refrigerated and never frozen.

- 11. Any discarded needles ("sharps") should be placed in an approved "Sharps" container by the veterinarian/veterinarian technician.
- 12. When all samples collection has been completed fill out the "Sample Transmittal Packing List. The packing list must identify by tag number all samples included in the case in which it is enclosed. Enclosed the completed "Sample Transmittal Packing List", any unused supplies and regenerated/re-frozen freezer packs in the case and seal it with the provided intact case seal.

### **Maintaining Chain of Custody**

Policies for the Fair and/or Executive Director/Livestock Supervisor

- 1. Transport samples to the lab either in person or by overnight express. Arrange samples to arrive at the lab during normal business hours (7:30am-5:00 p.m., Monday through Friday). The lab is located on the campus of Michigan State University at: 1615 South Harrison Road, East Lansing, MI 48823.
- 2. Collect and retain signed Animal Certification Forms and the bottom half of the "Sample tag". Both of these documents should be kept in a secure place until negative results have been received. In the event of a positive result these documents must be kept as evidence.

# **Troy Nealey Memorial Award**



One of America's and Ingham County 4-H's finest!

Lance Corporal Troy D. Nealey, of the United States Marine Corps, age 24, a former Ingham County 4-H member, was killed in action on October 29, 2006, in the Al Anbar Province, Iraq.

This award was established at his request to recognize Ingham County 4-H members participating with large livestock showmanship, specifically beef, swine, and sheep. These are 4-H project areas that Troy participated in for 10 years as a 4-H member.

Judging: Wednesday, July 30th - 9 a.m. - Main Arena

Arrival: Sunday, July 27<sup>th</sup> by 12:00 noon Release: Saturday, August 2<sup>nd</sup> after 11:00 pm

Rules: Exhibitor should also review all General Rules & Animal Health Requirements.

- 1. Exhibitors are to fit, show, & take care of their own exhibits.
- 2. Exhibitors will furnish their own feed & bedding.
- 3. Eight & nine year old members are limited to one animal; ten to fourteen year old members are limited to 3 animals; 15 years old & over members are limited to 4 animals; but only one animal in any one Class, unless twins.
- 4. An animal may be exhibited in only one breed.
- 5. Judges discretion will be used if less than four in breed for Championship Ribbons.
- 6. Shirts or show coats with farm logo or name are not permitted.
- 7. DUMPING OF MILK/MILK REPLACER IN WASH RACK ONLY.
- 8. Exercising of animals, only on east end of Main Arena or Ash Street Arena, no other areas PLEASE.
- 9. RFID tags required for all bovine prior to arrival at fair.

### **Showmanship**

- 1. Fitting & Showing Contest for all members. The animal must be fitted & shown by the Club Member & be the Member's own project.
- 2. White shirt & pants are traditional for Dairy Showmanship but are not required.

- 5. No intact males may be exhibited in any goat classes.
- 6. All Dairy Goats in milk MUST be milked out completely between 6 pm and 9 pm, the night before show (This includes all goats with babies that are pulled. All goats must be checked by Superintendent or Assistant Superintendent. Any goats not milked out will not be eligible to show.
- 7. If you have shown Goats at another fair, you may not show goats at the Ingham County Fair in the same year.
- 8. Animals must be purchased and in the exhibitor's possession no later than May 1<sup>st</sup>. If kids are born after May 1<sup>st</sup> you must own the dam before May 1<sup>st</sup>.
- 9. 2025 tagging date for market goats is on April 26, 2025 10:30-12. If tagging date is an issue, please contact Jennifer Pung directly via email at <a href="mailto:goatrodeo212@gmail.com">goatrodeo212@gmail.com</a> or text or call 517-712-4080.

Michigan Department of Agriculture Health Exhibition Rules apply. Copies are available at the Fair Office.

- 1. Market hogs may be purchased, but must be owned by the exhibitor and be in the exhibitor's possession by May 1st
- 2. Entries may be submitted for up to five animals, but only 2 pigs may be brought to check in. Submission forms due to Superintendent by June 1st.
- 3. The use of feed and supplements containing Ractopamine is **strongly** discouraged. Exhibitors whose animals go for resale will be required to sign an affidavit that their hogs have never had ractopamine.
- 4. Official (NUES or 840) tags must be placed in animals ear prior to check in.
- 5. Pigs may be brought to the fairgrounds Sunday, July 27<sup>th</sup> between 5:30 am and 9:30 am. Please enter through Gate A and pull up between the wash rack and feeder barn. Trailers will be unloaded on a first come first served basis. <u>Do Not unload until instructed to do so.</u> Trucks should exit through the north camping gate.
- 6. No equipment may be unloaded during weigh in.
- 7. Hogs may be vet checked as they are unloaded. Superintendent and vets reserve the right to send an animal home if deemed unhealthy.
- 8. Animals will be weighed at the time of check in. Any animals weighing between and 220 and 290lbs will be eligible to show and sell. If over or under weight, they may be shown but cannot be sold in the auction. Exhibitor will be responsible for finding a private treaty buyer or animal can be taken home.
- 9. At check-in, exhibitor must indicate if they are entering their swine as Homegrown, Purebred, or Crossbred.
- 10. Eligibility for Purebred Class the exhibitor must have purebred certification in the exhibitor's name for the animal to show in purebred classes. Purebreds will be verified at check in.
- 11. This is a non-terminal show (subject to change based on MDA recommendations) Superintendent must be notified by Tuesday if the animal will not be auctioned.
- 12. Pens must be bedded daily with clean wood shavings. No sand, mulch, or straw allowed.
- 13. Pigs determined to have testicles or parts of testicles will be disqualified.

- 1. All animals must be in the exhibitor's care and possession by May 1, 2025. Market chickens, ducks and geese may be purchased after May 1st, but must be owned as day old chicks. Please review specific market requirements below.
- 2. No class changes or additions are allowed. Market birds must meet minimum weight to check in. Please review specific market requirements below.
- 3. There is a MANDATORY exhibitor meeting on Sunday, July 27th at 1:00pm in the Poultry Barn.
- 4. Any animal showing signs of parasites or illness will be refused. Any animal deemed unfit for exhibit will be refused. All birds except pigeons and waterfowl must be Pullorum tested at check-in. If tested in advance, birds must be kept segregated from untested birds until fair, per MDARD exhibition requirements, and proof of negative test results must be presented to superintendent at check-in.
- 5. Infectious Laryngotracheitis (ILT) vaccinated birds are not allowed.
- 6. Exhibitors may have up to two entries from classes 29.04 through 29.08 in any combination. This includes Market Chickens, Market Waterfowl, Market Turkeys and Production Chickens. No bird may be shown in more than one class. Please see each section for specifics regarding hatch dates and minimum weight requirements.
- 7. All breeding pairs must include one male and one female of the same breed and variety.
- 8. No sale signs, other than the Small Animal Auction sale signs, are allowed in the Poultry Barn.
- 9. Barn will be open from 8:00am 10:00pm daily. Barn will be locked when unsupervised.
- 10. Exhibitors are required to clean their cages AT LEAST ONCE PER DAY, or more often as needed. Exhibitors must provide animals with food and water throughout the day. Animals MUST have water at ALL times. If animals/cages are not properly cared for, the exhibitor will be disqualified and asked to remove their animals from the premises.
- 11. EACH exhibitor must sign up for a minimum of one shift of barn duty.
- 12. Feed and bedding are the responsibility of the exhibitor. Feed and water cups will be provided. Pine shavings are highly recommended. Cedar shavings are NOT allowed in the Poultry Barn. Medicated feed or water is NOT allowed in the Poultry Barn.
- 13. Exhibitors are responsible for showing their own birds.
- 14. Judges and/or superintendent reserve the right to separate or combine classes for judging.
- 15. Only exhibitors, judges and staff are allowed in the show area.
- 16. No birds will be released early unless approved by superintendent and fair management.
- 17. All poultry entered in breed classes must be of a breed and variety recognized by the American Poultry Association to be eligible for awards. Please see the APA website for a full list of currently recognized breeds; <a href="https://www.amerpoultryassn.com">www.amerpoultryassn.com</a>
- 18. If exhibitors have any questions regarding entries, please contact superintendent or assistant superintendent.

### Rules: (Exhibitors should review all General Rules and Animal Health Regulations)

- 1. The American Rabbit Breeders Association Standard (ARBA) will be used as the basis for judging. All recognized breeds will be accepted.
- Members may show in Showmanship, 5 breed classes, 1 meat pen, 1 single fryer or Roaster, 1 Costume contest (member and animal in costume or Rabbit in costume), and 1 Protégé class. NO changes in class during fair. Only one animal per class (Example: You could show 1 Mini Rex Sr Buck, 1 Jr Buck, and 1 Jr Doe and also show Satin 1 Sr. Buck and 1 Sr. Doe. 1 meat pen and 1 single fryer).
- 3. Four class rabbits are those whom have the following classes: Senior buck (over 6 months of age), Senior Doe (over 6 months of age), Junior buck (under 6 months of age), Junior Doe (under 6 months of age). Age is determined by the age of the rabbit on the day of the show. These breeds are listed in the standard with these classes.
- 4. Six class rabbits are those whom have the following classes: Senior buck (over 8 months of age), Senior Doe (over 8 months of age), Intermediate Buck (between 6-8 months of age), Intermediate Doe (between 6-8 months of age), Junior buck (under 6 months of age), Junior Doe (under 6 months of age). Age is determined by the age of the rabbit on the day of the show. These breeds are listed in the standard with these classes.
- 5. Grand/reserve of each meat pen, single fryer, roaster will be sold.
- 6. All animals must be in Member's possession and care by May 1st PARENT STOCK OF MEAT PENS MUST BE IN MEMBERS POSSESSION AND CARE BY MAY 1. ANY VIOLATION OF THESE STIPULATIONS WILL RESULT IN THE ANIMALS BEING SENT HOME. Breeding date for meat pens is no sooner than April 20, 2025.
- 7. All market rabbits (Meat Pen, Single Fryer, and Roasters) must receive official identification tattoo from the superintendent. **There will be a tattoo clinic offered on Monday, July 7**th from 6:00pm-7:00 p.m. at the Shirley Clark Pavilion on the fairgrounds. Otherwise members must make arrangements with the superintendent **before** this date to be eligible for Grand or Reserve award. Tattoos are done for a donation. Market Rabbit ID tattoo is no charge. All donations gathered during tattoo clinic will go towards covering the cost of awards.
- Rabbit Barn will be open 8:00 a.m. to 12:00 (Noon) Sunday, July 27<sup>th</sup> to accept animals / Rabbit Science Projects thru designated doors. ALL ANIMALS MUST BE CHECKED IN DURING THIS TIME including Pee Wee animals. (Barn will close at 6 pm Sunday, July 27<sup>th</sup>. Please make sure your chores are completed before this time).
- 9. NOTICE: Rabbits showing symptoms of disease will not be admitted. Early treatment will prevent disease. All cages must be <u>KEPT CLEAN</u>. Rabbits <u>MUST</u> be fed and watered each day.
- 10. ALL RABBITS MUST BE LEGIBLY TATTOOED. Rabbits must be tattooed at check in. No Exceptions, if not tattooed, they will be sent home. Members will be required to provide rabbit tattoo during entry online. This information is needed for show day and rabbit safety. See Rule 7.
- 11. Exhibitor must provide crocks and water bottles to feed & water animals. Rabbits must have water at all times; if proper care is not exhibited, member will be disqualified and asked to remove animals from premises.
- 12. Cages must be cleaned on daily basis (especially meat pens). If not done, you may be asked to leave by superintendent and forfeit any awards/placing you received.
- 13. No Rabbits are to leave the barn except for Small Animal Sale or permission by superintendent
- 14. Mandatory Exhibitor meeting Sunday, July 27th at 2 pm. All info related to show day, sale, and fair week expectations will be discussed. It is up to the member to send a representative or contact the superintendents in advance.
- 15. Rabbit/Cavy barn will be locked when not supervised. Each club is responsible for at least one shift of barn duty. Chore chart will be available for sign up at check in and during tattoo clinic.
- 16. Only show staff, judges and clerks are allowed in judging arena. No Adults.

- 17. Breed class order will be posted morning of judging. Each exhibitor is responsible to make sure their animal is shown.
- 18. If an Exhibitor is showing in another Livestock or Still Life project at the same time as the rabbit breeding class shows, let the Superintendent know if another Exhibitor will be showing your animal during breed class. Rabbit members must take rabbit out of pens and show them, in order to receive ribbons, except the doe and litter class.
- 19. Rabbits entered in costume contest or fur class must be entered in breed class.
- 20. Tear down of the rabbit barn will happen the morning of Sunday, August 3<sup>rd</sup> from 8 a.m. until all cages are removed and cleaned up. All members and parents are encouraged to help at this time.

### **Showmanship**


