WAIVER AND HOLD HARMLESS AGREEMENT

KANDIYOHI COUNTY SHERIFF'S DEPARTMENT TENNESSEN WARNING

In accordance with the Minnesota Government Data Practices Act, the County of Kandiyohi is required to inform you of your rights as they pertain to the private information collected from you. Private data is that information which is available to you, but not to the public. The personal information we collect about you is private.

Minnesota Statutes 13.01 to 13.87 on Government Data Practices require that you be informed that the following information which you are asked to provide on the Waiver of Liability form is considered private data: 1.Name, 2. Home address, 3. Home phone number, 4. Date of birth, 5. Age.

We ask this information for the following reasons: to distinguish you from all other applicants and identify you in our files; to enable us to verify that you are the individual who makes the application; to enable us to contact you when additional information is required; to check records to determine if you meet the criteria to ride with a peace officer.

The data supplied by you may be used for such other purposes as may be determined to be necessary resulting from your riding with a peace officer from the County of Kandiyohi.

REFUSAL TO SUPPLY REQUESTED INFORMATION WILL MEAN THAT YOUR APPLICATION TO RIDE WITH A COUNTY OFFICER MAY NOT BE CONSIDERED.

Private data is available only to you and to other persons in County Government who have a bona-fide need of all data furnished which is not designated in this notice as private data.
