

What is the source of my water?

Your water comes from Spring Creek Spring, Adams Spring (Ground Water under the Direct Influence of Surface Water) and the Barren River. (Surface Water).

Why are there contaminants in my water?

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency Safe Drinking Water Hotline (800-426-4791).

The sources of drinking water, both tap water and bottle water, include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water:

Microbial Contaminants	Such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
Inorganic Contaminants	Such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial, or domestic wastewater discharge, oil and gas production, mining, or farming.
Pesticides and Herbicides	Which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
Organic Chemical Contaminants	Including synthetic and volatile organic chemical, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.
Radioactive Contaminants	Which can be naturally-occurring or the results of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the EPA and the Tennessee Department of Environment and Conservation prescribe regulations, which limit the amount of certain contaminants in water, provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

Relevant to your Source of Water

We're working hard to protect our water from contaminants, and working with the State to determine the vulnerability of our water supply to potential contamination. The Tennessee Dept. of Environment has prepared a Source Water Assessment Program Report for the untreated water source. The Report assesses the susceptibility of untreated water sources to potential contamination. To ensure safe drinking water, all public water systems treat and routinely test their water, water sources have been rated as reasonably susceptible, moderately susceptible, or slightly susceptible based on geological factors and human activities in the vicinity of the water source. Our rating is moderately susceptible. We have a Well Head Protection Plan in place to lessen the changes of contamination of our water sources.

Do I Need to Take special Precautions?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immune-compromised persons such as persons with cancer undergoing chemotherapy, persons who have under-gone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about their personal sanitation, food preparation, handling infants and pets, and drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbiological contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

What About Lead in my water?

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing, The City of Lafayette is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about the lead in your water, you may wish to have your water tested. Terms & Abbreviations:

<u>MCLG</u>	Maximum Contaminant Level Goal, or the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
<u>MCL</u>	Maximum Contaminant Level, or the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.
<u>MRDL:</u>	Maximum Residual Disinfectant Level or MRDL: The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for the control of microbial contaminants.
<u>MRDLG</u>	Maximum residual disinfectant level goal. The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
<u>AL</u>	Action Level, or the concentration of a contaminant which, when exceeded, triggers treatment or other requirements which a water system must follow.
<u>Below Detection Level (BDL)</u>	Laboratory analysis indicates that the contaminant is not present at a level that can be detected.
<u>Parts per million (ppm) or Milligrams per liter (mg/l)</u>	Explained as a relation to time and money as one part per million corresponds to one minute in two years or a single penny in \$10,000.
<u>Parts per billion (ppb) or Micrograms per liter</u>	Explained as a relation to time and money as one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.
<u>Nephelometric Turbidity Unit (NTU)</u>	Nephelometric turbidity unit is a measure of the clarity of water. Turbidity in excess of 5 NTU is just noticeable to the average person.
<u>TT</u>	Treatment Technique, or a required process intended to reduce the level of a contaminant in drinking water
<u>Turbidity:</u>	Turbidity does not present any risk to your health. We monitor turbidity, which is a measure of the cloudiness of water, because it is a good indicator that our filtration system is functioning properly.

About the data:

Most of the data presented in this table is from testing done between Jan.1 through Dec. 31 2022. We monitor for some contaminants less than once per year, and for those contaminants, the date of the last sample is shown in the table.

Turbidity * We met the Treatment Technique for turbidity with 100% of our samples were below the turbidity limit of .3 NTU. Turbidity is a measure of the cloudiness of the water. We monitor it because it is a good indicator of the effectiveness of our filtration system.

During the most recent round of lead and copper testing, 0 of 30 households sampled contained concentrations exceeding the action level.
