Rider Requirements:

- ◆ Be ready at the designated time. The driver may not be able to wait due to time constraints.
- ◆ Pack drinks and/or snacks for long trips as indoor dining is unpredictable and may not be an option due to restrictions or time constraints.
- ◆ All COVID-19 protocols are observed.
- ◆ Bring a mask. Masks are required for everyone using public transit during the entire ride. Passenger distancing for everyone's safety is enforced.
- ◆ Let us know when scheduling the trip if additional persons are traveling as caregiver/support persons are allowed.
- ◆ **48 Hours notice Required for all rides.**
- ◆ Courteous, prompt cancelation of a ride is appreciated as we often have a wait list.
- ◆ Our drivers provide door to door service. Please be prepared to manage any packages or additional items upon pick-up and drop-off.
- ◆ Smoking is not allowed in any Lake County Public Transit vehicles.
- ◆ We provide scheduled transit. Any additional stops will need prior approval in order to be completed.

This is a transit day dedicated to serving the community and surrounding area. We take individuals to businesses in Lakeview FREE of charge.

Thursdays excluding holidays.

Time

Call early to schedule your preferred time of pickup.

Christmas Valley Service

We provide weekly service to La Pine from Christmas Valley for non-medical appointments.

Day

This trip is on Wednesdays and is rider defined with stops in La Pine for shopping, lunch and appointments.

Community Transit

Food Access

Call to request a ride to food box giveaways and holiday events.

Travel Coordination

We can provide access to alternate means of transportation.

County-wide

We provide service in Lake county via two points of operation 5 days per week.

Hospital Release

We provide transportation home from the local hospital for individuals.

Veterans

We provide transportation to medical appointments for veterans.. Appointments must be at a VA Health facility or authorized by the VA.
