The Lyons City Council met in regular session Monday May 18, 2020 at 6:00 PM opening with the invocation given by Caleb Barrow. Mayor Garlan Old presided over the meeting. Presentations:

Justin Holliday – Police Department: Justin reported the cases have increased by 12 for a yearly total of 166 and there were 18 citations for a total of 201 from May 5, 2020 until May 18, 2020.

Brandon Cantrell – City Inspector report: Brandon reported there was one violation, 32 weed notices with 25 complying. The City will mow 7 locations when time allows. There were 14 building permit applications with 11 approved and 2 pending for a value of \$86,744.00. There was no new information on the Bolton Building. With the office not open to the public due to the pandemic Brandon has been helping do applications on line.

Mayor, City Administrator Report and City Attorney Reports:

Mayor: Phase 1.5 of Rice County reopening from Marci Detmer, Rice County Health Department.

City Administrator: Chad Buckley.

- a. Currently the Courthouse is experiencing issues with the sanitary sewer service to the building. The sewer line is estimated to be very old as there was never a main sewer line built to serve any building around the square along East Avenue South, West Avenue South, Main or Commercial. Each of the downtown buildings is served by a sewer main behind each. Walton Plumbing has worked to clean the existing line but the age, condition and slope of the 4" sewer service is still backing up. In my experience the distance that a customer should maintain a sanitary sewer should be reasonable. As you can observe from the slide the courthouse maintains a line that is 637' long. While most building owners downtown at most cross a street or alley to connect to sewer. It appears that the right thing to do is for the City to extend a sanitary sewer main from the alley to West Avenue South. At the County Commission meeting this morning the Commissioners were planning to bury a new sewer to the courthouse if the City would build a main to the corner. A number of issues that will come up with

a sewer project that I need to review revolve around the difference in the requirements of the City of Lyons by KDHE. Municipal mains have a minimum size, this main will need to be a minimum of 8" in diameter. Mains can not make a turn of more than just a few degrees with out a manhole. This means we will make sure we will only need two, one at each end. We will also try to maintain as much brick as possible however the areas around the manholes will have a concrete pad poured around the project area.

- b. An interview was conducted for the position of Utility Supervisor last week. However, the individual declined our offer.
- c. Audree Aguilera has presented her resignation as the Community Development coordinator for the City of Lyons. Last week she graduated from Wichita State University with a Masters in Public Administration. Good luck in the future.

Committee reports:

- a. Airport Advisory Agenda: There is a grant application for \$20,000.00 for maintenance and upgrades to the airport. There are no definite plans for the funds but there are plenty of items for possible improvements.

- a. Appointment for Council Member Ward 3 Melody Adams. 
