Re: One-Way Streets

The City of Lyons, in an effort to improve the traffic flow around Park Elementary is in the process of making changes. The streets impacted by this change are the 100 and 200 blocks of South Workman and the 300 and 400 blocks of East Commercial. Both streets will be altered to allow for one-way traffic only.

Below is a copy of the amendment to the City Code.

**AN ORDINANCE AMENDING CHAPTER XIV, ARTICLE 2
OF THE CITY CODE OF THE CITY OF LYONS, KANSAS**

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF
LYONS CITY, KANSAS:**

SECTION 1: That Chapter XIV, Article 2, Section 14-202, is hereby amended to read as follows:

14-202. **ONE-WAY STREETS AND ALLEYS.** When signs are in place giving notice thereof, it shall be unlawful for any person to operate a motor vehicle on any such streets or alleys in a direction other than that designated:

- (a) The alley in the North one-half (1/2) of Block Two of White's Addition to the City of Lyons shall be a one-way alley for Southbound traffic.
- (b) The East-West alley in Block Two of White's Addition to the City of Lyons shall be one-way for westbound traffic only. (Ordinance 1602)
- (c) *The 300 and 400 blocks of East Commercial shall be one-way for westbound traffic only.*
- (d) *The 100 and 200 blocks of South Workman shall be one-way for southbound traffic only.*

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage and publication of the above ordinance in the official city

newspaper. The provisions hereof are severable, and in the event of invalidity, for any reason, of any portion of this ordinance, the remaining provisions of the ordinance shall remain in full force and effect, with the invalid provisions deemed excised.

The purpose of this letter is to inform the residence of this neighborhood to in order that they may prepare for the new signage, and to plan accordingly. This adjustment will be made once the publication requirements have been fulfilled and the one-way signs arrive.

The City of Lyons realizes that this change will be new at the beginning of the school year for everyone. Our goal is to provide a safe zone for students, parents, and facility as they travel to and from Park Elementary.
