MINUTES OF REGULAR MEETING

The Maiden Town Council met on Monday, March 19, 2018 at 7:00 p.m. for their regularly scheduled meeting, held in the Council Chambers at the Maiden Town Hall.

Present for the meeting were Mayor Bob Smyre, Mayor Pro-Tem Max Bumgarner Jr, Councilmembers Danny Hipps, Trina Michael, Marcus Midgett and Ronnie Williams.

Also present were Town Manager Todd Herms, Town Attorney Scott Conrad and Town Clerk Elizabeth Krige.

The meeting was called to order at 7:00 p.m. by Mayor Bob Smyre

The invocation was given by Mayor Bob Smyre.

The Pledge of Allegiance was led by Scout Troop 303.

4. Approval of Agenda

Mayor Smyre requested that Council amend their agenda to include a Closed Session for consultation with attorney and economic development.

5. Citizens Requests and Comments

Chief Ledford recognized Sergeant Joe Painter for the completion of the Department of Justice Intermediate Law Enforcement Certificate. Chief Ledford said this certificate required a lot of hard work and sacrifice. Chief Ledford thanked Sergeant Painter for this service to the Police Department. Chief Ledford also introduced Rhyan Causby, a new officer in the department. Chief Ledford said that Officer Causby has eight years of experience as a law enforcement officer.

At this time, Mayor Smyre thanked Boy Scout Troop 303 for attending the meeting and opened the floor for questions from the scouts. One of the scouts asked the Mayor how long he served as Mayor, Mayor Smyre answered thirty-three years. Another scout asked the Mayor about his responsibilities. Mayor Smyre said they were to lead the town, lead meetings and answer questions.

Another scout asked Mayor Smyre his favorite part of being mayor. Mayor Smyre said he loved talking to young people and helping satisfy the needs of the community. The last question posed by the scout troop was in regard to a food truck project members of his class presented to the Mayor, Town Manager and other staff in December.

Mr. Herms explained they had been compiled in an executive summary by Planning Director, Blake Wright. Mr. Herms said if there was ever interest in starting a food truck the ideas presented by the class would be given to potential business owners.
