

Summary of Ordinances and Resolutions
October 5, 2023

- **Ordinance No. 289 (22-23) AS AMENDED** An Ordinance to amend Section 1121.02 [Use Regulations] Permitted in a “C-3” [General Retail and Service District] Zoning District of the Codified Ordinances of the City of Marietta, Ohio.
- **Ordinance No. 290 (22-23) AS AMENDED** An Ordinance to amend Chapter 1103 [Special Provisions] of the Codified Ordinances of the City of Marietta, Ohio.
- **Ordinance No. 316 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to enter into a Revocable Land Use and License Agreement with Ohio Power Company, an Ohio Corporation and a Unit of American Electric Power, 700 Morrison Road, Gahanna, OH 43230 for real property located at 241 Front Street (The Marietta Area Community Center at the Armory), and at 243 Front Street (The Lock House), in the City of Marietta, Ohio, and declaring an EMERGENCY.
- **Ordinance No. 329 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to enter into a Contractual Agreement with Strand Associates of Columbus, Ohio, based upon the quality based selection process, for Planning Services in connection with the State Route 7 North Water Transmission Main Project in an amount not to exceed \$250,000.00 and declaring an EMERGENCY.
- **Ordinance No. 330 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to apply for a planning loan through the Ohio EPA Division of Environmental and Financial Assistance (DEFA) Office on behalf of the City of Marietta, Ohio for the State Route 7 North Water Transmission Main Project; for an amount not to exceed \$250,000.00, and declaring an EMERGENCY.
- **Ordinance No. 331 (22-23)** An Ordinance to amend Sections 949.01 (Park Names) and 949.03 (Hours of Operation) of the Codified Ordinances of the City of Marietta, Ohio, relating to Public Parks located in the City of Marietta, Ohio; and declaring an EMERGENCY.
- **Ordinance No. 333 (22-23)** An Ordinance to authorize and direct the Auditor of the City of Marietta, Ohio, to allocate and/or set aside a portion of monies from the American Rescue Plan Act Fund, (ARPA) to be used for the Ohio River Wall Repair Project, in the amount of \$120,000.00; and declaring an EMERGENCY.
- **Ordinance No. 334 (22-23)** An Ordinance to authorize and direct the Auditor of the City of Marietta, Ohio, to allocate and/or set aside a portion of monies from the American Rescue Plan Act Fund, (ARPA) to be used for the Fire Training Center Project, in an amount not to exceed \$209,601.00; and declaring an EMERGENCY.
- **Ordinance No. 335 (22-23)** An Ordinance to authorize and direct the President of Council and the Auditor of the City of Marietta, Ohio, to enter into a contract on behalf of the City of Marietta,

Ohio, with the Local Government Services Division of the Office of the Auditor of State for the compilation of general purpose financial statements for the City of Marietta, Ohio, for the year ending December 31, 2023; at a cost not to exceed \$48,000.00, and declaring an EMERGENCY.

- **Ordinance No. 336 (22-23)** An Ordinance to appropriate and/or transfer funds.
- **Resolution No. 127 (22-23)** A Resolution accepting the amounts and rates as determined by the budget commission and authorizing the necessary tax levies and certifying them to the county auditor, and declaring an EMERGENCY.

October 10, 2023

- **Resolution No. 128 (22-23)** A Resolution to adopt and approve the Public Housing Agency Plan for the City of Marietta, Ohio, and to authorize and direct the Mayor to certify said Plan to the U.S. Department of Housing and Urban Development, Office of Public and Indian Housing, on behalf of the City of Marietta, Ohio, and declaring an EMERGENCY.

October 30, 2023

- **Ordinance No. 346 (22-23)** An Ordinance to authorize and direct the Mayor of the City of Marietta, Ohio to enter into an Intergovernmental Contract with the Public Entities Pool of Ohio, pursuant to Ohio Revised Code §2744.081, and declaring an EMERGENCY.
