

ORDINANCE NO. 16 (24-25) AS AMENDED

An Ordinance to create three (3) seasonal laborer positions at the Marietta Harbor, in the City of Marietta, Ohio, under the auspices of the various Washington County Job and Family Services Employment Programs, and to designate the duties therefor, and to establish the salary thereof, and declaring an EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARIETTA, OHIO:

Section 1: That there shall be and are hereby created, three (3) seasonal laborer positions at the Marietta Harbor of the City of Marietta, Ohio, under the auspices of the various Washington County Job and Family Services Employment Programs, to be filled by appointment of the Director of Public Safety and Service pursuant to law. Said appointments are to be made beginning April 1, 2024, and said positions are to terminate when funding is no longer available through the various Washington County Job and Family Services Employment Programs, but in no event, later than December 31, 2024.

Section 2: That the duties of the seasonal position of laborer at the Marietta Harbor shall be those designated in the job description attached hereto as Exhibit "A" and any such other duties as the Director of Public Safety and Service may, from time to time, prescribe.

Section 3: That the salary of the seasonal position of laborer in the Service Department shall be and is hereby established at the minimum wage rate of \$10.45 per hour, provided that the Appointees to said positions, shall not receive fringe benefits from the City, other than Workers' Compensation, Medicare benefits, and premium pay at the rate of time and one-half per hour, for each hour worked on a holiday.


Section 4: That the salary schedule for each additional year of service shall be as follows:

YEARS OF SERVICE	HOURLY RATE
2nd Year	\$10.60
3rd Year	\$10.75
4th Year	\$10.90
5th Year and thereafter	\$11.05


Section 5: That this Ordinance shall be and is hereby declared to be an EMERGENCY measure necessary for the immediate preservation of the public peace, health and safety of the City of Marietta, Ohio, and for the further reason that immediate action is necessary in order to provide adequate manpower levels necessary to operate the Marietta Harbor; WHEREFORE, this Ordinance shall be in full force and effect from and immediately after its passage and approval by the Mayor.
