

ORDINANCE NO. 2 (24-25)

An Ordinance to abolish the position of Wastewater Operations Manager in the Wastewater Department of the City of Marietta, Ohio, and to amend the current Table of Organization to reflect said abolishment, and declaring an EMERGENCY.

WHEREAS, there currently exists the position of Wastewater Operations Manager in the Wastewater Department of the City of Marietta, Ohio; and

WHEREAS, the City of Marietta, Ohio desires to abolish the position of Wastewater Operations Manager in the Wastewater Department and in the alternative create a new position of Wastewater Collections Forman in the Wastewater Department, effective upon the retirement of Steve Elliott, Wastewater Superintendent; and

WHEREAS, the City now needs to amend the current Table of Organization to reflect the abolishment of the Wastewater Operations Manager in the Wastewater Department, effective upon the retirement of Steve Elliott, who currently serves as the Wastewater Superintendent.; now therefore


BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARIETTA, OHIO:

- Section 1: That the position of Wastewater Operations Manager in the Wastewater Department of the City of Marietta, Ohio is hereby abolished, effective upon the retirement of Steve Elliott, Wastewater Superintendent.
- Section 2: That the City's current Table of Organization shall be and is hereby amended in order to reflect the abolishment of the position of Wastewater Operations Manager in the Wastewater Department. Furthermore, the portion of the current Table of Organization that is in conflict herewith, shall be and is hereby repealed.



Section 3: That this Ordinance shall be and is hereby declared to be an EMERGENCY measure necessary for the immediate preservation of the public peace, health and safety of the City of Marietta, Ohio, and for the further reason that the Table of Organization for the City of Marietta, Ohio needs to correctly reflect the abolishment of the position of Wastewater Operations Manager in the Wastewater Department, effective upon the retirement of Steve Elliott, Wastewater Superintendent. 
