

ORDINANCE NO. 292 (22-23)

An Ordinance to repeal Section 137.02 of the Codified Ordinances of the City of Marietta, in its entirety, in order to abolish the position of Water Director and the position of Wastewater Director that was created by Ordinance 140 (86-87); and furthermore, to amend the City of Marietta, Ohio's current Table of Organization to reflect the abolishment of said positions; and additionally, to repeal Ordinance No. 140 (86-87) in its entirety, and declaring an EMERGENCY.

WHEREAS, on November 20, 1986, the Council of the City of Marietta, Ohio, passed Ordinance No. 140 (86-87) which created the position of Water Director, and the position of Wastewater Director, and which further created the duties of said positions and the licensing requirements for each position; and

WHEREAS, by the passage of Ordinance No. 140 (86-87) Codified Ordinance Section 137.02 was created, to reflect the establishment of the positions and the duties and licensing requirements of the position of Water Director, and the position of Wastewater Director; and

WHEREAS, from time to time, the City of Marietta has created new positions and modified the job descriptions of various positions, and combined positions and job duties; and

WHEREAS, over time, the duties of the Water Director and the duties of the Wastewater Director were combined with other existing positions, or newly created positions; and

WHEREAS, the position of Water Director and the position of Wastewater Director have become obsolete because the duties and requirements for those positions have evolved into other positions created over time; and


WHEREAS, the position of Water Director and the position of Wastewater Director are no longer used and no longer needed; and

WHEREAS, the position of Water Director and the position of Wastewater Director needs to be abolished and deleted from the City's Table of Organization; now therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARIETTA OHIO:

- Section 1: That Section 137.02 of the Codified Ordinances of the City of Marietta, Ohio is hereby repealed in its entirety.
- Section 2: That the position of Water Director and the position of Wastewater Director is hereby abolished.
- Section 3: That Ordinance No. 140 (86-87) is hereby repealed in its entirety.
- Section 4: That the City of Marietta's current Table of Organization is hereby amended to reflect the abolishment of the position of Water Director and the position of Wastewater Director.
- Section 6: That this Ordinance shall be and is hereby declared to be an EMERGENCY measure necessary for the immediate preservation of the public peace, health and safety of the City of Marietta, Ohio, and for the further reason that the Table of Organization needs to accurately reflect the current positions within the City of Marietta. WHEREFORE, this Ordinance shall be in full force and effect from and immediately after its passage and approval by the Mayor.




