

ORDINANCE NO. 296 (22-23)

An Ordinance to authorize and direct the Director of Public Safety and Service to enter into a purchase contract on behalf of the City of Marietta, Ohio, with Rush Truck Centers, of Cincinnati, Ohio for the purchase of a 2024 International HV607 4 x 2 dump truck for use by the Waste Water Department of the City of Marietta, Ohio, at a cost not to exceed \$117,016.39 and declaring an EMERGENCY.

WHEREAS, a need exists to purchase a dump truck for the Waste Water Department of the City of Marietta, Ohio; and,

WHEREAS, following an analysis of the City's needs in this respect, and the alternatives available for the provision of those needs, the Director of Public Safety and Service has recommended that the City enter into a purchase contract with Rush Truck Centers, of Cincinnati, Ohio, for the purchase of a 2024 International HV607 4 x 2 dump truck; and,

WHEREAS, the Director of Public Safety and Service has determined that pursuant to Ohio Revised Code that the City of Marietta, Ohio may purchase this dump truck through the Ohio Department of Transportation Cooperative Purchasing Contract; and, therefore is exempt from any competitive selection procedures otherwise required by law; and,

WHEREAS, the acquisition of the 2024 International HV607 4 x 2 dump truck from Rush Truck Centers, of Cincinnati, Ohio, for a total acquisition cost not to exceed \$117,016.39 appears to be the best proposal for the acquisition of the dump truck as determined by the Director of Public Safety and Service; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARIETTA, OHIO:

Section 1: That the Director of Public Safety and Service shall be and is hereby authorized and directed to enter into a purchase contract on behalf of the City of Marietta, Ohio, with Rush Truck Centers, of Cincinnati, Ohio, for the purchase of a 2024 International HV607 4 X 2

dump truck for use by the Waste Water Department of the City of Marietta, Ohio, at a cost not to exceed \$117,016.39, according to the terms and conditions of the proposal attached hereto as Exhibit "A", which terms and conditions are hereby adopted and approved.

Section 2: That this Ordinance is hereby declared to be an EMERGENCY measure necessary for the immediate preservation of the public peace, health, and safety of the City of Marietta, Ohio, and for the further reason that immediate action is required in order to guarantee the price of the dump truck; WHEREFORE, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.


