

ORDINANCE NO. 3 (24-25)

An Ordinance to create the position of Wastewater Collections Foreman in the Wastewater Department of the City of Marietta, Ohio, and to amend the current Table of Organization to reflect the creation of said position of Wastewater Collections Foreman and declaring an EMERGENCY.

WHEREAS, the position of Wastewater Operations Manager in the Wastewater Department was abolished effective upon the retirement of Steve Elliott, Wastewater Superintendent; and

WHEREAS, the City desires to create a new position to replace the position of the Wastewater Operations Manager in the Wastewater Department; and

WHEREAS, the newly created position will be that of Wastewater Collections Foreman in the Wastewater Department; and

WHEREAS, the newly created position of Wastewater Collections Foreman in the Wastewater Department shall become effective upon the retirement of Steve Elliott, Wastewater Superintendent; and

WHEREAS, the City now needs to amend the current Table of Organization to reflect the creation of the Wastewater Collections Foreman in the Wastewater Department, effective upon the retirement of Steve Elliott, who currently serves as the Wastewater Superintendent.; now therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARIETTA, OHIO:

Section 1: That the position of Wastewater Collections Foreman in the Wastewater Department of the City of Marietta, Ohio is hereby created, effective upon the retirement of Steve Elliott, Wastewater Superintendent.


Section 2: That the City's current Table of Organization shall be and is hereby amended in order to reflect the creation of the position of Wastewater Collections Foreman in the Wastewater


Department. Furthermore, the portion of the current Table of Organization that is in conflict herewith, shall be and is hereby repealed.

Section 3: That this Ordinance shall be and is hereby declared to be an EMERGENCY measure necessary for the immediate preservation of the public peace, health and safety of the City of Marietta, Ohio, and for the further reason that the Table of Organization for the City of Marietta, Ohio needs to correctly reflect the creation of the position of Wastewater Collections Foreman in the Wastewater Department, effective upon the retirement of Steve Elliott, Wastewater Superintendent. WHEREFORE, this Ordinance shall be in full force and effect from and immediately after its passage and approval by the Mayor.
