

ORDINANCE NO. 350 (22-23)

An Ordinance to amend Section 3 of Ordinance No. 220 (22-23), passed on March 16, 2023, concerning temporary seasonal laborer positions in the Public Works Department of the City of Marietta, Ohio, and declaring an EMERGENCY.

WHEREAS, on March 16, 2023, the Council for the City of Marietta, Ohio, passed Ordinance No. 220 (22-23) which created four (4) temporary seasonal labor positions in the Public Works Department for the City of Marietta, Ohio; and

WHEREAS, Ordinance No. 220 (22-23), also outlined the duties and the salary of the temporary seasonal laborer positions in the Public Works Department; and

WHEREAS, since the passage of Ordinance No. 220 (22-23), two (2) of the temporary seasonal laborer positions have become vacant leaving only two (2) temporary seasonal laborers positions still filled; and

WHEREAS, the City wishes to retain the two (2) remaining temporary seasonal laborers in the Public Works Department, pursuant to the dictates of Ordinance 220 (22-23), and further wishes to increase their salaries to \$15.00 per hour, retroactive to the date of October 30, 2023; now therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARIETTA, OHIO:


- Section 1: That Section 3 of Ordinance No. 220 (22-23), passed on March 16, 2023, shall be and is hereby amended in order to establish a new rate of pay for the two (2) remaining temporary seasonal laborers in the Public Works Department.
- Section 2: That the salary of the remaining two (2) temporary seasonal laborers in the Public Works Department shall be and is hereby established at the rate of \$15.00/hour, effective October 30, 2023, provided that the two (2) remaining temporary seasonal laborers shall not receive fringe benefits from the City, other than Workers' Compensation, Medicare benefits, and premium pay at the rate of time and one-half per hour for each hour worked on a holiday.
- Section 3: That all other provisions as previously outlined in Ordinance No. 220 (22-23) that were not modified herein, shall remain in full force and effect.


Section 4: That this Ordinance shall be and is hereby declared to be an EMERGENCY measure necessary for the immediate preservation of the public peace, health and safety of the City of Marietta, Ohio, and for the further reason that immediate action is necessary in order to retain the two (2) remaining temporary seasonal laborers, who have proven themselves to be excellent workers in the Public Works Department;

WHEREFORE, this Ordinance shall be in full force and effect from and immediately after its passage and approval by the Mayor.


