## ORDINANCE NO. 66 (24-25)

An Ordinance to authorize and direct the Director of Public Safety and Service to temporarily Accommodate the Permitting of the Operation of DORA (Designated Outdoor Refreshment Area) during the Great American Race, for the date of Sunday, June 23, 2024, and declaring an EMERGENCY.

WHEREAS, Pursuant to Resolution No. 91 (20-21) As Amended, Section 3, Subparagraph 3(c), passed on April 29, 2021; and thereafter amended by Resolution No. 24 (22-23), Section 1, passed May 19, 2022; it was Resolved that the days and hours of operation for Marietta's Designated Outdoor Refreshment Area (DORA) would be Monday, Tuesday, Wednesday, Thursday, Friday and Saturday from 12:00 p.m. (noon) until 12:00 a.m. (midnight); and

WHEREAS, Resolution No. 91 (20-21) As Amended, and Resolution No. 24 (22-23) further authorized City Council to reserve the right to temporarily suspend DORA operations, in order to accommodate the permitting of special events that may occur within the boundaries of the DORA; and

WHEREAS, Resolution No. 91 (20-21) As Amended, and Resolution No. 24 (22-23) further authorized City Council to reserve the right to temporarily accommodate the permitting of special events that may occur within the boundaries of the DORA; and

WHEREAS, the Great American Race is currently scheduled as a special event to occur in Marietta, Ohio, on Sunday, June 23, 2024, wherein about 130 teams in the race will be in Marietta and their cars will be parked on Front Street for everyone to see; and

WHEREAS, the Council of the City of Marietta, Ohio wishes to temporarily extend the days of operation within the boundaries of the DORA, in order to temporarily include Sunday, June 23, 2024 from 12:00 p.m.(noon), until 12:00 a.m. only, in order to accommodate the public attending the festivities associated with the Great American Race; and

WHEREAS, with the exception of Sunday, June 23, 2024, the normal days and hours of DORA will continue to be Monday, Tuesday, Wednesday, Thursday, Friday and Saturday from 12:00 p.m. (noon) until 12:00 a.m. (midnight), unless further authorized by the Council of the City of Marietta, Ohio; and

WHEREAS, the Council for the City of Marietta, Ohio, hereby authorizes and directs the Director of Public Safety and Service to temporarily accommodate the operation of DORA within its designated boundaries in the City of Marietta, Ohio, for Sunday, June 23, 2024, from 12:00 p.m. (noon), until 12:00 a.m. (midnight), and to provide all qualified permit holders within the boundaries with notice of the temporary accommodation, and to inform all qualified permit holders within the DORA boundaries that they shall be permitted to sell DORA cups for the specified date and times; and

WHEREAS, this temporary accommodation for the allowance of DORA on a Sunday, specifically on June 23, 2024, shall terminate at 12:01 a.m. on Monday, June 24, 2024; now therefore

## BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARIETTA, OHIO:

- Section 1: That the Director of Public Safety and Service shall be and is hereby authorized and directed to temporarily permit the operation of DORA within its designated boundaries in the City of Marietta, Ohio, for Sunday, June 23, 2024 from 12:00 p.m. (noon) until 12:00 a.m. (midnight), and to provide all qualified permit holders within the boundaries, with notice of the temporary allowance, and to inform all qualified permit holders within the DORA boundaries that they shall be permitted to sell DORA cups for the specified date and times.
- Section 2: That this temporary accommodation for the allowance of DORA on a Sunday, specifically on June 23, 2024, for the Great American Race, shall terminate at 12:01 a.m. on Monday, June 24, 2024.
- Section 3: DORA shall resume its normal days and hours of operation on Monday, June 24, 2024 pursuant to the days and hours established in Resolution No. 91 (20-21) As Amended, and as further amended by Resolution 24 (22-23).

Section 4: That this Ordinance is declared to be an EMERGENCY measure necessary for the immediate preservation of the public peace, health and safety of the City of Marietta, Ohio, and for the further reason that immediate action is needed because the Great American Race is scheduled for June 23, 2024, and in order to allow time for the passage of legislation and the effective date of the legislation, it must pass with an emergency clause on June 6, 2024. WHEREFORE, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
