ORDINANCE NO. 77 (22-23)

An Ordinance to authorize and direct the Director of Public Safety and Service to enter into a contract on behalf of the City of Marietta, Ohio, with Sutphen Corporation, of Dublin, Ohio for the lease/purchase of a Sutphen Heavy Duty Custom SPH 100 MID Mount Platform Ladder Fire Truck with equipment and apparatus, for use by the Fire Department of the City of Marietta, Ohio, at a cost not to exceed \$1,702,072.00, pursuant to Ohio Revised Code Sections 125.04(B)(3) and 5513.01(B).under the auspices of Ohio's Cooperative Purchasing Act as administered by the Ohio Department of Administrative Services, Office of State Purchasing through the Ohio Department of Transportation, and declaring an EMERGENCY.

WHEREAS, a need exists to lease/purchase a new ladder fire truck for the Fire Department of the City of Marietta, Ohio; and,

WHEREAS, following an analysis of the City's needs in this respect, and the alternatives available for the provision of those needs, the Director of Public Safety and Service has recommended that the City enter into a contract with Sutphen Corporation of Dublin, Ohio, for the lease/purchase of a new ladder fire truck with equipment and apparatus; and,

WHEREAS, on February 3, 2022, via passage of Resolution No. 3 (22-23) the Council of the City of Marietta approved the City's voluntary participation in the use of state contracts based upon state public bids, pursuant to Ohio Revised Code Section 5513.01(B), under the auspices of Ohio's Cooperative Purchasing Act, as administered by the Ohio Department of Administrative Services, Office of State Purchasing, through the Ohio Department of Transportation; and,

WHEREAS, Ohio Revised Code Section 125.04(B)(3) states in part that purchases made by a political subdivision under this division are exempt from any competitive selection procedures otherwise required by law and in conjunction with Ohio Revised Code Section 5513.01 (B); and,

WHEREAS, the acquisition of a Sutphen Heavy Duty Custom SPH 100 MID Mount Platform with Equipment Ladder Fire Truck from Sutphen Corporation of Dublin, Ohio, for a total lease/purchase cost not to exceed \$1,702.072.00 appears to be the best proposal for the acquisition of the custom ladder fire truck with equipment and apparatus, as determined by the Director of Public Safety and Service; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARIETTA, OHIO:

Section 1: That the Director of Public Safety and Service shall be and is hereby authorized and directed to lease/purchase, on behalf of the City of Marietta, Ohio, from Sutphen Corporation of Dublin, Ohio, a Sutphen Heavy Duty Custom SPH 100 MID Mount Platform Ladder Fire Truck with equipment and apparatus, for use by the Fire Department of the City of Marietta, Ohio, at a cost not to exceed \$1,702,072.00 under the auspices of Ohio's Cooperative Purchasing Act, as administered by the Ohio Department of Administrative Services, Office of State Purchasing, through the Ohio Department of Transportation, according to the terms and conditions of the proposal attached hereto as Exhibit A, which terms and conditions are hereby adopted and approved.

Section 2: That this Ordinance shall be and is hereby declared to be an EMERGENCY measure necessary for the immediate preservation of the public peace, health and safety of the City of Marietta, Ohio, and for the further reason that immediate action is necessary in order to secure the price and financing method quoted; WHEREFORE, this Ordinance shall be in full force and effect from and immediately after its passage and approval by the Mayor.
