

ORDINANCE NO. 8 (24-25)

An Ordinance to abolish the position of Assistant Water Superintendent in the Water Treatment Department of the City of Marietta, Ohio, effective February 1, 2024; and to amend the current Table of Organization of the City of Marietta, in order to reflect the abolishment of said position, and declaring an EMERGENCY.

WHEREAS, early in 2023, the Water Superintendent of the Water Treatment Department for the City of Marietta, Ohio, informed the City that he would be retiring effective January 31, 2024; and

WHEREAS, the City of Marietta, Ohio began to look for a candidate that could replace the Water Superintendent upon his retirement; and

WHEREAS, the City found an eligible candidate that could replace the Water Superintendent upon the Water Superintendent's retirement; and

WHEREAS, the City of Marietta believed it was necessary to hire the replacement candidate early in 2023 so that he could train under the current Water Superintendent of the Water Treatment Department; and

WHEREAS, the City of Marietta created the position of Assistant Water Superintendent in the Water Treatment Department for the new candidate who would train under the supervision of the Water Superintendent in the Water Treatment Department, until his retirement; and

WHEREAS, now that the Assistant Water Superintendent in the Water Treatment Department will be stepping into the position of Water Superintendent, effective February 1, 2024, there is no longer a need for the position of Assistant Water Superintendent; and

WHEREAS, the City wishes to abolish the position of Assistant Water Superintendent, effective February 1, 2024; now therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARIETTA, OHIO:

Section 1: That the position of Assistant Water Superintendent in the in the Water Treatment Department of the City of Marietta, Ohio is hereby abolished, effective February 1, 2024.


Section 2: That the City of Marietta, Ohio's current Table of Organization shall be amended in order to reflect the abolishment of the position of Assistant Water Superintendent in the Water Treatment Department; and that any portion of the current Table of Organization that is in conflict herewith, shall be and is hereby repealed.

Section 3: That this Ordinance shall be and is hereby declared to be an EMERGENCY measure necessary for the immediate preservation of the public peace, health and safety of the City of Marietta, Ohio, and for the further reason that the person that is currently serving in the position of Assistant Water Superintendent in the Water Treatment Department will be assuming the new position of Water Superintendent on February 1, 2024, and therefore, the Administration wishes to abolish the position of Assistant Water Superintendent in the Water Treatment Department effective February 1, 2024. WHEREFORE, this Ordinance shall be in full force and effect from and immediately after its passage and approval by the Mayor.
