The Council of the **City of Marietta** of Washington County, Ohio, met in Regular Session on the 5th day of October, 2023, at Room 10, Marietta Community Center at the Armory with the following members present: Mr. Harley Noland, Mr. William Farnsworth, Mr. William Gossett, Mr. Bret Allphin, Mr. Michael Scales, Mr. Geoff Schenkel and Mrs. Cassidi Shoaf.

WHEREAS, this Council in accordance with the provisions of law has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1, 2024, and,

WHEREAS, the Budget Commission of Washington County, Ohio, has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within the ten mill tax limitation; now therefore be it

RESOLVED, by the Council of the City of Marietta, Washington County, Ohio that the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted; and be it further

RESOLVED, that there be and is hereby levied on the tax duplicate of said City the rate of each tax necessary to be levied within and without the ten mill limitation as follows:
