

RESOLUTION NO. 89 (22-23) AS AMENDED

A Resolution to authorize the Eagle Scout Project of Cole Stine, member of Troop 207, to be completed on the grounds of Indian Acres Park.

WHEREAS, Cole Stine wishes to undertake an Eagle Scout Project on the grounds of Indian Acres Park. Specifically, Cole Stine wishes to construct a picnic shelter, per the design specifications marked as Exhibit "A", attached hereto, and incorporated herein; and,

WHEREAS, Cole Stine will be donating his time and labor, as well as materials toward the fulfillment of his project; and,

WHEREAS, this Council authorizes Cole Stine to complete his Eagle Scout Project on the grounds of Indian Acres Park, under the direct supervision of the Director of Public Safety and Service; and

WHEREAS, the picnic shelter shall be constructed according to the specs used in building the picnic shelter that was constructed in Gold Star Park in the City of Marietta, Ohio, using the exact same plans that were used for the Gold Star Park picnic shelter; and


WHEREAS, this Council wishes to express its appreciation to Cole Stine, for his exemplary service to the community; now, therefore,


BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MARIETTA, OHIO:


Section 1: That the Marietta City Council shall and does hereby authorize Cole Stine to complete his Eagle Scout Project on the grounds of Indian Acres Park, under the direct supervision of the Director of Public Safety and Service and, per the attached specifications.


- Section 2: That Cole Stine shall construct the picnic shelter on the grounds of Indian Acres Park using the same exact plans or specs that were used to construct the picnic shelter at Gold Star Park, a copy of which is attached hereto, approved, and incorporated herein.
- Section 3: That the Marietta City Council does hereby expresses its appreciation to Cole Stine for his donation of time, labor and materials and for his exemplary service to the community.
- Section 4: That the Clerk of Council shall be and is hereby directed to spread a copy of this Resolution on the minutes of this body and to forward copies thereof to Cole Stine with an appropriate expression of this Council's thanks.
- Section 5: That this Resolution shall take effect and be in full force from and after the earliest time allowed by law.
