

RESOLUTION NO. 90 (22-23)

A Resolution to authorize Marietta Moose Lodge No. 1823, to install, under the direct supervision of the Director of Public Safety and Service, a book box at the corner of Post Street and West Butler Street, near the Marietta Harbor.

WHEREAS, Marietta Moose Lodge No. 1823, located at 171 Front Street, Marietta, Ohio, wishes to install a book box for use by the public, at the corner of Post Street and West Butler Street, near the Marietta Harbor. Said public book box shall be 24" X 24" X 20"; and shall be installed under the direct supervision of the Director of Public Safety and Service, per the design specifications marked as Exhibit "A", attached hereto, and incorporated herein; and,

WHEREAS, Marietta Moose Lodge No. 1823 will be donating all labor and materials, toward the fulfillment of this project; and,

WHEREAS, this Council authorizes Marietta Moose Lodge No. 1823 to complete this project on property owned by the City of Marietta, Ohio, said property located at the corner of Post Street and West Butler Street, near the Marietta Harbor, under the direct supervision of the Director of Public Safety and Service; and

WHEREAS, this Council wishes to express its appreciation to Marietta Moose Lodge No. 1823 members, for their exemplary service to the community; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MARIETTA, OHIO:

Section 1: That the Marietta City Council shall and does hereby authorize Marietta Moose Lodge No. 1823 to install a book box at the corner of Post Street and West Butler Street, near the Marietta Harbor, under the direct supervision of the Director of Public Safety and

Service and, per the attached specifications which are hereby approved and incorporated herein.






