

RESOLUTION NO. 97 (22-23)

A Resolution to authorize Girl Scout Troop 10148 to undertake a landscaping project on the grounds of Gold Star Park under the direct supervision of the Director of Public Safety and Service, and declaring an EMERGENCY.

WHEREAS, Girl Scout Troop 10148 wishes to undertake a landscaping project using the existing flower beds on the grounds of Gold Star Park, and to also create a new flower bed surrounding the Silent Battle Monument pad-site per the design specifications marked as Exhibit "A", attached hereto, and incorporated herein; and,

WHEREAS, Girl Scout Troop 10148 has chosen this project as their Girl Scout Bronze Award Project, which allows the troop to learn the local governmental process, while providing a valuable Community Service Project to the community and the City of Marietta, Ohio; and

WHEREAS, this Council authorizes Girl Scout Troop 10148 to complete its landscaping project on the grounds of Gold Star Park, under the direct supervision of the Director of Public Safety and Service; and

- Section 2: That the Marietta City Council does hereby express its appreciation to Girl Scout Troop 10148 for their donation of time, labor, and materials and for their exemplary service to the community and the City of Marietta, Ohio.
- Section 3: That the Clerk of Council shall be and is hereby directed to spread a copy of this Resolution on the minutes of this body and to forward copies thereof to Girl Scout Troop 10148 and its participating members as an appropriate expression of this Council's thanks for a job well done.
- Section 4: That this Resolution shall be and is hereby declared to be an EMERGENCY measure necessary for the immediate preservation of the public peace, health, and safety of the City of Marietta, Ohio, and for the further reason that now is the prime time to plant flowers and this project has a deadline.

WHEREFORE, this Resolution shall be in full force and effect from and immediately after its passage and approval by the Mayor.
