Marietta City Council January 27, 2025 Special Meeting Minutes Armory Building, 241 Front Street Room 10

Roll Call. President Vessels called the meeting to order at 5:30 p.m. The following council members were present: Councilor Scales, Councilor Allphin, Councilor Gossett, Councilor O'Neill, and Councilor Grimm. Others present were Safety Service Director Wetz and Law Director Bertram. A sergeant-at-arms was not present.

Councilor Scales made a motion to excuse Councilor Noland and Councilor Rutherford. Councilor Grimm seconded the motion and it passed with a voice vote.

Pledge of Allegiance. President Vessels led in the Pledge of Allegiance.

The special council meeting notice was read by the clerk.

Call on Officials and Visitors:

- Mr. Bertram had nothing to say.
- Councilor Grimm expressed concerns about the legislation. He said we were proceeding down the same route as last year with the aquatic center and we realized a \$60,000 loss. He said it hasn't been further discussed in committee, and he can't support doing the same thing again. He said he would like to bring it back to committee.
- Mr. Wetz said the city is just going out for bids on the aquatic center. When the bids are received, the same person as in the past will not bid as he retired. He said they are trying to find someone else to operate it more efficiently, and it's up to council to accept their bids. He said they are working with deadlines to get it open and people in place.
