Sheriff's Report

Sheriff Boggs submitted the Monthly Tax Disbursements Report for October. Disbursements totaled \$2,508,374.27.

Sheriff Boggs explained to the fiscal court that he is requesting from the state, at 0% interest, an advancement totaling \$325,000.00 to assist with the operation of his department throughout 2017. This is the same amount Sheriff Boggs requested and received for 2016.

Motion made by Commissioner Day and seconded by Commissioner McKay to approve Sheriff Boggs' request of an advancement in the amount of \$325,000.00 from the state at 0% interest to be used for the operation of his office in 2017.

Sheriff Boggs requested members of fiscal court to approve salaries for deputies, assistants and other employees in his office for 2017, not to exceed \$733,835.60. This amount includes full time salaries and wages, overtime wages, part time salaries and wages, vacation and sick leave and KLEFPF.
