### **SUGGESTED DOCUMENTATION FOR DEFENDANT'S TRUE IDENTITY MOTION**

The following list includes some of the information, which may be helpful in the support of a defendant's True Identity Motion. To assist in your claim that you did not receive the citation in question, please provide the Court and the Prosecutor with as much information and documentation as possible, such as:

- 1) Valid Driver's License or Identification Card.
- 2) Address information on the date the citation was issued.
- 3) Current address, home telephone number and work telephone number.
- 4) Make, model, license plate number for vehicle operated on the offense date and today.
- 5) Proof of insurance for the vehicle operated on the offense date and today.
- 6) Identity of person you know, or have reason to believe has received and/or signed for the citation using your name including the following:
  - a) Name
  - b) Date of Birth
  - c) Driver's License number
  - d) Home address and home telephone number
  - e) Work address and telephone number
  - f) Make, model and license plate of vehicle
- 7) Proof of your location on the date and time citation was issued. (example: copy of work schedule, time slip)
- 8) Any other information or documentation you deem relevant to establish that you did not receive the citation in question.

**NOTE:** A person commits a third degree felony if they make a false statement during or in connection with an official proceeding.

A person commits an offense if they make, present or uses a record or document with knowledge that it is false.

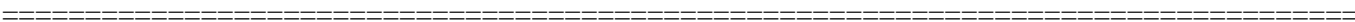
