**** A second or subsequent conviction of an offense under the Texas Motor Vehicle Safety Responsibility Act will result in the suspension of your Driver's License and denial of automobile registration unless you file and maintain proof of financial responsibility with the Texas Department of Public Safety (DPS) for two years from the date of conviction. DPS may waive the requirement to file proof of financial responsibility if you file satisfactory evidence with DPS reflecting that at the time the citation was issued, the vehicle was covered by a liability insurance policy of that you were otherwise exempt from the requirement to provide evidence of financial responsibility.**
