2. No skateboards, roller skates, roller blades, metal spiked shoes, or bicycles are allowed on playing surfaces.
3. No league or tournament play of any kind on City of Newton Tennis Courts, unless sponsored or authorized by the Newton Parks and Recreation Department.

IT SHALL BE UNLAWFULL FOR ANY PERSON TO:

4. Remove, destroy or damage any City of Newton equipment or property.
5. Climb or hang on any fence surrounding City of Newton property and/or the net on the Courts.
6. Have motorized vehicles on City of Newton property, except in designated areas.
7. Discharge or cause to be discharged any firearm on City of Newton property.
8. Consume, display publicly, or be under the influence of any alcoholic beverages and/or drugs.
9. Use profanity or abusive language or be guilty of disorderly conduct of any kind.
10. Make or kindle a fire except in designated areas.
11. Deposit garbage, debris of any kind on or upon City Property.
12. Dig, cut, bruise or mutilate plant materials.
13. Make or do any indecent or vulgar motions in view of any person on City of Newton property.
14. Engage in soliciting, peddling, begging, or selling of any kind without written permissions.
