## **PUBLIC HEARINGS:**

# **CITIZEN PARTICIPATION: (PUBLIC COMMENTS)**

**Laurie Gregory** of South Bend, IN who's mother is Jeannine Gregory of Misty Acres, is concerned with the noise from Indeck. She asked when the problem could be expected to be fixed and also would the cost of the repair be absorbed down the pipe to the consumer.

Phil Mazzotta stated that the noise is still there and asked what is the noise ordinance.

**Kathy Schiele** of 2297 Invicta Dr. asked if the noise level was the expectation of what the City thought. Her expectation was living in peace. Everything vibrates in her house.

**Judy Weeks** of 2249 Monterey Dr. explained that the loudness is affecting her health. She can't sleep and has headaches, resulting with her probably going to see a doctor.

**Ginger Brawley** of 1744 Holiday Dr. reported the noise level is 8. something, not 5. something. This is affecting hundreds of people.

**Diane Hill** of Sumnerville, her mother Grace Singer lives on Creek Rd., and her aunt Alice Curry lives on White St. They are in their 90's and have been complaining about the sound and the vibration. She asked that Mayor Shelton let them know something through Facebook.

Janet Frame of Red Bird, passed Misty Acres. She stated that she has lived there 9 years and also cannot sleep. She is also curious about the lake level being the highest it's been in 8 years and wonders if that has anything to do with Indeck although she has been told that it doesn't.

**Sue Jurgonski** of Misty Acres, reported that she has done some research on the noise ordinance in Niles compared to Howard Township, in which they are very similar. She thought that she would have

some sort of answer by now. She asked the Council if any of them have been out to Misty Acres. Her main question is regarding the noise ordinance and why can't it be enforced.

City Administrator Huff responded by stating that he has not been given a deadline as to when the issue will be resolved. Indeck has brought in engineers, sound consultants and different individuals trying to find the key source of this change that occurred around March 26. Since they have been unable to isolate the exact cause, they have started construction of sound barrier walls last week. This is only the interim solution. Shutting down the plant is problematic for a lot of people. The City is taking this very seriously. There is a development agreement with Indeck that the City is in the process of enforcing that addresses sound levels and nuisances.
