City Administrator Huff added that the City engaged with an independent 3rd party to review all investments and compliance with Michigan statutes on what could and could not be invested in. A report should be available in a couple of weeks and the company are willing to make a presentation to Council.

Councilmember Boggs said that she was sorry that Mrs. Woodson was having the problems that she has. She hopes that it can be cleared up. Boggs also reported pot holes on Vine to Ash and 5th to 8th Streets.

Councilmember Bertschy stated that the bounce house at Riverfest was a great idea and hoped to see it again next year. Bertschy added that she was also upset regarding the situation with Mrs. Woodson.
