RESOLUTION NO. 13-2025

A RESOLUTION DESIGNATING PUBLIC DEPOSITORYIES AND AUTHORIZING WITHDRAWAL OF CITY MONIES

WHEREAS, the Common Council of the City of Onalaska, Wisconsin, has designated the following banks/investment pools/credit unions/financial institutions as qualified public depositories under Chapter 34 of Wisconsin Statutes for all public monies ear-marked for the City General Fund, Checking and Savings Accounts, City Utility, coming into the hands of the current and/or any successor to the City Treasurer.

WHEREAS, the Common Council has granted the City Treasurer authority to use the depositories interchangeably as they deem most advantageous to the City.

NOW, THEREFORE BE IT RESOLVED by the Common Council of the City of Onalaska that funds shall be drawn by check or written transfer order only as provided in Wis. Stat. 66.042 and upon the signature of the Mayor and/or the President of the Common Council and the City Clerk countersigning, except that the City Treasurer be authorized to make draws for investment of funds not immediately needed; and

BE IT FURTHER RESOLVED, that the City Treasurer is designated as the "Local Official" authorized to transfer funds to the State Treasurer for deposit in the Local Government Investment Pool and that the State Treasurer is authorized to accept on-line and telephone requests, including facsimile transmissions, for withdrawal of funds from the Local Government Investment Pool.



BE IT FURTHER RESOLVED, that the City Clerk be and is hereby directed to certify such bank(s), State Investment Pool, credit union(s) and financial institutions the proper and authentic signatures of said Mayor, President of the Council, City Clerk and City Treasurer, under Seal of the City.

BE IT FURTHER RESOLVED, that a certified copy of this resolution may be delivered to each of the named depositories and that said depositories may rely on this resolution until changed by lawful resolution.

Please take Notice that a Petition for Incorporation of territory described below was filed, pursuant to sec. 66.0203 of the Wisconsin Statutes, with the Circuit Court for La Crosse County, Wisconsin on the 21st day of September 2024.

The territory which is the subject of the petition for incorporation is generally described as follows: Part of Sections 6, 7, 17, 18, 19, 20 and 30 of Township 16 North, Range 7 West; part of Sections 1 and 25, Township 16 North, Range 8 West; all of Sections 33, 34 and 35 of Township 17 North, Range 8 West and all of Sections 2, 3, 4, 10, 11, 12, 13, 14, 23 and 24 of Township 16 North, Range 8 West, Town of Campbell, La Crosse County Wisconsin.
