WHEREAS, the county has obtained a Final Judgment from Supreme Court, Oswego County in an in rem foreclosure proceeding; and

WHEREAS, the county has executed a deed or deeds pursuant to the Final Judgment(s) obtained vesting title in the name of the County of Oswego; and

WHEREAS, the tax district of the County of Oswego enjoys a right of sale under RPTL§1166 either at public auction to the highest bidder or by approval and confirmation of the sale by a majority vote of this body; and

WHEREAS, certain parcels are being sold have offered to pay the county tax district, in full, for all delinquent taxes penalties and interest as part of this purchase thereby making the county whole; and

WHEREAS, other parcels need to be conveyed back due to bankruptcy filings or other issues; and

WHEREAS, a resolution is necessary and desirable,

NOW, THEREFORE, upon the recommendation of the Government, Courts and Consumer Affairs Committee of this body, it is hereby

RESOLVED, the County Treasurer be, and is hereby, authorized to sell and transfer the following delinquent tax properties to the person(s) named for the consideration stated hereinbelow. The Consideration named in said deed shall be considered payment of all taxes held against the property, including the 2022 tax, unless otherwise stated:

RESOLUTION AUTHORIZING THE TRANSFER OF TAX-FORECLOSED PROPERTIES TO THE OSWEGO COUNTY LAND BANK CORPORATION

WHEREAS, the County of Oswego has formed one of fewer than 25 land banks within the State of New York; and

WHEREAS, the County as a foreclosing governmental unit has, heretofore, foreclosed upon various delinquent and blighted tax properties within the County of Oswego; and

Re: Budget Modification - Insurance Department - A1910

Attached please find a budget modification for the Insurance Department. Insurance policies cover all county departments and officers/employees. This request is necessary, in part, to pay the county's 2022 premiums due and payable semi-annually for all lines of coverage (auto, general liability, environmental tank liability, public officials, inland marine, healthcare professional, police professional, fire, boiler, etc.) The difference between the budget line and the renewal premiums due in July is approximately \$72,000. A substantial portion of this is due to increased coverage required by state programs.

The 2022 insurance line is estimated as part of the budget adoption process but actual premiums are not known or due until the following January. All major policies run with the county's fiscal year. Some lines of insurance have premiums tied to the adopted county budget amount as the carrier views the budget itself as an indicia of risk and county operations. In addition to experience, factors that affect premiums are the market, changing/replacement value of items covered and other factors. For example, replacing an older truck for a 2022 model or renting a crane or milling machine not scheduled on the policy on balance may trigger an increase in premium.

The balance of the request is to cover anticipated deductibles for claims through the end of the year. Thank you.

Subject: Request to enter an Intermunicipal Agreement for WebEOC Incident Management System.

Purpose: The COVID-19 public health emergency has shown the use of social distancing is one of the key elements in reducing the spread of the virus. The Emergency Management Office (EMO) would like to incorporate a web-based platform to manage incidents that can be utilized in-person and remotely. WebEOC is used by many State, Federal and local agencies, and non-governmental emergency management partners such as Corporations, Hospitals and Education Institutions to monitor and manage activities before, during and after an emergency or disaster.

WebEOC is the most widely used, battle-tested emergency management technology available. It helps organizations prepare and respond to incidents of any kind. It could be utilized to prepare for large scale events such as Harborfest and Super Dirt Week as well as manage incidents such as flooding, snow events or ice storms, public health emergencies and radiological incidents. Once implemented this platform can be used by all county departments for incident management therefore there is a benefit to the entire county to invest in this system.

WebEOC is a secure, internet-based emergency information management system that provides real-time information sharing or operation details from various government and public safety groups in response to an imminent threat, emergency, or disaster. It has the capability to establish situation and daily reports, request resources, and initiate requests for preliminary damage assessments in the aftermath of a disaster. The system can also capture financial data and intelligence reporting information, records activities, tasks, decisions, plans, media releases, briefings, and online meetings. There is also a file library included in the platform which is an important resource for accessing emergency management plans, (such as a CEMP, Hazard Mitigation or REP plans) and agency specific documentation and self-help guides.

Summary: By entering into this agreement EMO will partner with Onondaga County to bring this system to Oswego County at a significant price saving than if we were to invest on our own. By partnering with Onondaga County we will be entering into the highest “gold star” version of the application at a cost of \$13,435 1st year and \$6,124 2nd year and successive with a marginal increase each year. EMO has secured grant funding to pay for this for at least the first three years and will work to continue funding through eligible grant programs thereafter.

Recommended

Action: The Emergency Management would respectfully request the members of the Public Safety Committee and Oswego County Legislature authorize entering this Intermunicipal Agreement to bring this online incident management tool to Oswego County.

INTERMUNICIPAL AGREEMENT

THIS INTERMUNICIPAL AGREEMENT (“the Agreement), by and between the COUNTY OF ONONDAGA, a municipal corporation with principal offices at 421 Montgomery Street, Syracuse, NY 13202, by J. Ryan McMahon II, its County Executive (“Onondaga County”); and the COUNTY OF OSWEGO [specifically, the Office of Emergency Management], a municipal corporation with principal offices at located at 46 E. Bridge Street, Oswego, NY 13216, by James Weatherup as Chairman of the Oswego County Legislature (“Oswego County”).

WHEREAS, in preparation for and response to emergency incidents, enhancing partnerships and collaboration between local and regional public and private sector entities to establish a common operating picture, will allow each user to increase their situational awareness, to make informed, data-driven, and effective decisions in an effort to preserve the lives and property of their respective populations; and

WHEREAS, WebEOC is the industry leading emergency incident management software that provides shared workspace where various, customizable dashboards allow users to view real-time information to make data-driven decisions for day-to-day operations, to prepare for emergency situations, and to communicate and respond during emergency incidents; and

WHEREAS, utilizing WebEOC will allow Onondaga County and Oswego County to share data in order to collaborate and communicate effectively in preparation for and response to emergency incidents;

NOW, THEREFORE, the parties hereby agree as follows:

TERM

This Agreement shall be in effect from October 1, 2021, and shall continue until September 30, 2024, as to the emergency preparation and response support services provided for pursuant to this Agreement.

Notwithstanding the foregoing, any party may terminate this Agreement at any time upon ninety (90) days’ written notice, served upon the Office of the Onondaga County Attorney located at 421 Montgomery Street, 10th Floor, Syracuse, New York 13202.

If this Agreement is terminated by a party, written notice must be sent to the other party as set forth below:

- The Oswego County Attorney’s Office, with a copy sent to the Oswego County Emergency Management Office;
- Onondaga County Law Department, with a copy sent to the Department of Emergency Management for Onondaga County

In the event this Agreement is terminated by Onondaga County or Oswego County, or an equivalent agreement between Onondaga County and another Participating Agency is terminated by a party thereto (“WebEOC Agreement”), Onondaga County will provide written notice of said termination to all WebEOC Agreement Participating Agencies.

SCOPE OF SERVICES

Advice by Subject Matter Experts

Oswego County may request advice from Onondaga County personnel who have acquired knowledge and expertise as users of the WebEOC software. Onondaga County will ask those experts to provide the requested advice to Oswego

County in a timely manner, subject to Onondaga County workflow of the experts, but responding in good faith to the time sensitive needs of the parties.

Oversight Committee

All parties agree that there shall be a Program Oversight Committee to ensure effective communication and partnership between the parties. Onondaga County, Oswego County, and any other WebEOC Agreement Participating Agency will each have one voting representative, collectively comprising the WebEOC Oversight Committee. This Committee shall make recommendations, changes and amendments, as necessary and agreed upon, in collaboration with this Agreement and WebEOC Agreements.

COMPENSATION

Advice by Subject Matter Experts

Onondaga County shall not seek reimbursement for advice provided to Oswego County by Onondaga County experts.

Implementation and Continued Use

Note: The first year of costs total \$74,875, which is divided equally amongst 5 participating agencies.

Future years will accrue yearly service costs of \$6,124 for Oswego County. Annual recurring costs will be based on the current subscription level, and divided equally among the parties to WebEOC Agreements, inclusive of this Agreement. In the event that the WebEOC Oversight Committee seeks to make changes to such WebEOC Agreements by purchasing additional WebEOC software capabilities, the costs will be split equally, if said capabilities benefit all the parties thereto. If a single party seeks to purchase additional WebEOC software capabilities for their sole benefit, that single party will be required to pay the full costs of that purchase.

Oswego County, will pay its fees to Onondaga County annually and Onondaga County will thereafter pay all expenses on Oswego County’s behalf.

MODIFICATIONS

This Agreement represents the entire and integrated understanding between Onondaga County and Oswego County and supersedes all prior negotiations, representations, or understandings either written or oral. This Agreement may be amended only by written instruments signed by all involved parties. It is understood that amendments may be required from time to time due to the potential changes in the work that may be required.

SEVERABILITY

If any term or provision of this Agreement shall be held invalid or unenforceable, the remainder of this Agreement shall not be affected thereby and every other term and provision of this Agreement shall be valid and enforced to the fullest extent permitted by law.

CLAUSES REQUIRED BY LAW

The parties hereto understand and agree that each and every provision of law and clause required by law to be inserted in this Agreement shall be deemed to have been inserted herein, and if through mistake or inadvertence such provision is not inserted, said clause shall be deemed to have been inserted and shall have the full force and effect of law.

2022 has again been a difficult year with staffing for the E911 Department. E911 currently has 5 full time telecommunicator positions and 2 part time telecommunicator positions open. These vacancies have increased our overtime costs unexpectedly in the last couple months to maintain appropriate coverage of the department. We also installed a 911 phone system upgrade earlier this year that required staff to come in for an extra day which had to be scheduled on over time due to coverage requirements.

I am requesting a budget modification from salaries and wages to overtime to cover the required overtime that E911 is incurring. I am requesting to move \$15,000 to the overtime budget line A3020-512000 from salaries and wages line A3020-511000. This amount should cover overtime expenses for the remainder of 2022 barring any further major impacts to staffing.

WHEREAS, the CAP Court meets at the Public Safety Center, 39 Churchill Road, in Oswego, every evening from 5:30 pm to 10:00 pm, 365 days a year, as well as every weekend morning and holiday mornings at 8:00 am, and

WHEREAS, assigned counsel attorneys who are part of the 18-B Panel are compensated for all evening, weekend, and holiday appearances at CAP Court; and

WHEREAS, prosecutors from the Oswego County District Attorney's Office appear at all evening CAP Court arraignments, either virtually or in person, and facilitate every weekend / holiday morning arraignment; and

WHEREAS, the CAP Court appearances occur outside of standard business hours and are in addition to the normal duties performed by prosecutors in the District Attorney's Office, and

WHEREAS, adequately and compensating prosecutors who appear at and perform additional duties for CAP Court helps to promote the retention of experienced Assistant District Attorneys, which is in the County's best interest; and

WHEREAS, the Management Compensation Plan is expired

NOW, THEREFORE, upon the recommendation of the Public Safety and Finance and Personnel Committees of this body, it is hereby

RESOLVED, that the Oswego County Legislature authorizes a stipend to compensate prosecutors for the additional appearances and duties related to CAP Court, at a rate of \$200 per evening (\$300 if it's a holiday), and at a rate of \$75 per weekend morning (non-holiday), and at a rate of \$125 per holiday morning, and that the Human Resources Department will establish pay codes and develop ancillary documents or forms as may be necessary to effectuate same; and be it further

SUBJECT: Provide a Stipend for additional duties performed by prosecutors related to the Centralized Arraignment Part (CAP Court)

PURPOSE: To establish a stipend for additional duties regularly performed by prosecutors on evenings, weekends, and holidays, outside of standard business hours.

SUMMARY: In January of 2020, Oswego County had to implement a Centralized Arraignment Part (CAP Court) to make sure that a defense attorney is present for all criminal arraignments, as required by law. The CAP Court meets at the Public Safety Center, 39 Churchill Road in Oswego, every evening from 5:30 pm to 10:00 pm, 365 days a year. Additionally, CAP Court meets at 8:00 am on both weekend days and on holidays.

Defense attorneys under the County's 18-B Assigned Counsel Plan appear at CAP Court and are compensated at a rate of \$325 per night (\$475 on holidays), \$150 per weekend morning, and \$250 per morning on holidays.

Prosecutors from the District Attorney's Office have appeared at and facilitated all CAP Court appearances since the inception of the program but have received no additional compensation or renumeration for these additional duties that occur outside of normal business hours, as well as on weekends and holidays.

To fairly compensate the prosecutors for their work at CAP Court, which will help promote the retention of qualified and experienced Assistant District Attorneys, I would like to provide a stipend for this additional work at a rate of \$200 per evening (\$300 on holiday evenings), \$75 per weekend morning, and \$125 on holiday mornings.

This stipend would be funded by eliminating a full-time Assistant District Attorney position that was recently vacated (position 116501306) and transferring the salary and fringe benefits associated with that position to a new budget line within the District Attorney's Office, to be used to pay prosecutors the CAP Court stipend.

RECOMMENDED

ACTION: It is respectfully recommended that the Public Safety and Finance & Personnel Committees authorize a stipend to compensate prosecutors for the additional appearances and duties related to CAP Court, at a rate of \$200 per evening (\$300 if it's a holiday), and at a rate of \$75 per weekend morning (non-holiday), and at a rate of \$125 per holiday morning, and direct the Human Resources Department to establish pay codes and develop ancillary documents or forms as may be necessary to effectuate same; and further, that a separate line should be established within the District Attorney's Office budget from which the CAP Court stipend will be paid, to be funded in 2022 from salary and benefits associated with a full-time Assistant District Attorney position (116501306) that is now vacant; and further, that vacant Assistant District Attorney position (116501306) shall hereby be eliminated from the budget of the District Attorney's Office.

- Subject:** Request for authorization to reclassify the Typist position (COOP Grade 3) to Senior Typist (COOP Grade 5) within the District Attorney's Office.
- Purpose:** Due to the re-evaluation of departmental staffing, this proposed change will allow the department to function efficiently and effectively while maintaining and providing continued succession planning opportunities within the department.
- Summary:** With the continued progression of administrative duties, the opportunity exists to restructure operations. The individual in this position will continue to perform functions associated with the current Typist position while also taking on more complex duties that are associated with the position of Senior Typist. This promotion will help retain a valuable employee and is consistent with ensuring the continuation of the professional and efficient operations of the department.
- Recommended Action:** To authorize the proposed reclassification of the Typist position (COOP Grade 3) to Senior Typist (COOP Grade 5) within the District Attorney's Office.

- 1) **Fulton Police Department** – The applicant proposes to create two satellite offices, one each on the east and west sides of the river. The east side office will be within a qualified census tract and the west side office will be in the general proximity of the High School. The offices will not be manned 24/7 but will be open and available to on-duty law enforcement individuals (local and others) for access to Wi-Fi and other appropriate law enforcement amenities. This will, in effect, create a law enforcement presence in two neighborhoods that would benefit from that extra sense of security. The proposal was for \$40,000 of a \$60,000 project.

SUBJECT: Creation of one Social Welfare Examiner position for the Child Care program

SUMMARY: New York State has enacted emergency changes to the Child Care Assistance Program. These changes increase the provider market rates and expand income eligibility for the program to 300% of the Federal Poverty level. The new regulations also provide a 12-month guarantee of assistance under the program and remove some work requirements for parents attending school.

With the changes to the program, growing caseloads, and expanded eligibility and outreach requirements, DSS respectfully requests the addition of this one (1) Social Welfare Examiner position to focus on the Child Care program.

FISCAL IMPACT: This position is 100% funded through the department's childcare allocation.

SUBJECT: Reclassification of Seasonal HEAP CSW to Social Welfare Examiner

SUMMARY: Earlier this year, DSS Assistance Programs reclassified one of the part-time, seasonal Community Service Worker (CSW) positions to Social Welfare Examiner. (SWE) This was a successful upgrade as it removed 100% review of the employee's work as it was performed by the higher-grade Social Welfare Examiner. Eligibility determinations are in the SWE job description, but not in that of the CSW. Having two seasonal SWE's would relieve the HEAP supervisor of 100% review of every case. Spot reviews of work performed by the seasonal SWE's will continue to occur.

Also, the part-time, seasonal positions within the HEAP program have been difficult to recruit. DSS also currently has several full-time permanent CSW vacancies and when candidates become available, they choose the full-time position as opposed to the part-time seasonal HEAP title. The higher-grade seasonal SWE position makes it easier to recruit, and in one instance the department was able to bring back a retired, fully trained staff person to assist with the HEAP program.

FISCAL IMPACT: This position is 100% Federally funded. The additional salary cost will be covered by the department's HEAP allocation.

Subject: Salary adjustment of DSS Director of Services and Creation of One (1) Case Supervisor A and Three (3) Case Supervisor Bs

Summary: **DSS seeks additional upper-level positions necessary to assist with policy decisions and resulting procedures, as initially recommended by the Bonadio Study of 2017. These upper-level positions were also recommended in our most recent Program Improvement Plan (PIP) issued by NYS OCFS. The need for more upper-level management continues to grow as regulations change and new programming is implemented to meet State mandates, and some programming will position us for improved funding for services. These changes as described below, along with further changes and additions which will be presented at future meetings, are fully supported by the sitting Child Protection Advisory Council as a part of our Recruitment & Retention Strategy for the Services Unit.**

- Add a Case Supervisor A position in Oswego County Professionals Association (OCPA) SG40. This position will assist the Director of Services in policy and procedure planning, guidance and implementation, submission of required State plans for all service provision, and direct supervision of Case Supervisor B staff that oversee Preventive Service provision, QA & Audit. With the addition of requirements brought on by the Families First Preventive Services Act (FFPSA), the Department is working diligently at building supports for families that will aid in keeping children safe within their homes, rather than being removed & placed into foster care. This Case Supervisor A will be instrumental in the planning and implementation work required to make these changes possible.
- Add 3 additional Case Supervisor Bs to the Services Division – to be in CSEA, Grade 13, until further upgrade is negotiated with CSEA. The new Case Supervisor B positions are necessary for better monitoring of case actions, compliance with procedures & protocols and ensuring communication of changes to all staff. These Case Supervisor Bs will be assigned to do the following:

- 1 – Additional manager over CPS Unit – currently has 8 teams (each with 1 Sr CW and 5-6 CWs) and all managed by one Case Supervisor B. This position will allow for better monitoring of cases, coaching & support of Seniors and Caseworkers and better communication with partners in our Multi-Disciplinary Teams.
- 2 – Adds manager to focus on case review and internal audit of preventive services caseload, communication, and implementation of training plans to address deficiencies identified. This QA Grade B will be responsible for reviewing documentation that is tied to Federal IV-E reimbursement, ensuring the agency is meeting state mandates as well as the FFPSA initiatives- Blind removals, Kin Fire Wall, Foster Care Candidacy, FFPSA Candidacy, and QI Assessment referrals, assessments and required meetings. This person would further be responsible for ensuring Permanency Goals are being met.
- 3 – Adds manager to focus on preventive services provided by contracted partners, review of their case actions, and communication with staff. This manager will also be responsible for supervision of the Sobriety Treatment and Recovery Teams that the Department will be implementing later this year. START focuses on families with a child(ren) under six about whom we receive a new CPS report with allegations of substance use/abuse as a safety risk.
- Make salary adjustment to Director of Services title. This is a high-level management position that supervises more employees than many other directors in county departments and takes on a higher level of liability/consequence of error than others. The intended increases in staffing and the increased programming changes that are now in progress add significantly to her responsibilities. We recommend this increase to adequately compensate the Director for these responsibilities.

Subject: Request for Salary Set for DSS Director of Services

Summary: DSS has been working closely with staff from across the Department as well as with the members of CPAC to create a viable recruitment & retention strategy within the Services Division. As part of that strategy, we are seeking additional upper-level positions necessary to assist with policy decisions and resulting procedures, as initially recommended by the Bonadio Study of 2017. The need for more upper-level management continues to grow as regulations change and new programming is implemented to meet State mandates, and some programming will position us for improved funding for services. These upper-level positions were also recommended in our most recent Program Improvement Plan (PIP) issued by NYS OCFS.

As a part of our Recruitment & Retention Strategy, we will also be seeking additional staffing in Caseworker, line supervisor and support staff roles to allow for the possibility of reduced caseloads, improved staff morale, and improved outcomes and relationships with the families we work with. We will seek to reduce Sr. Caseworker workloads to allow for better support to the caseworkers and allow for closer attention to the details of their teams' cases. Our Caseworker turn-over rate in Child & Family Services continues to be a problem due to the high level of stress/anxiety experienced by the staff, and the resulting increased caseload that each remaining Caseworker needs to manage due to the vacancies and new cases coming in. Caseworkers often leave for higher paying jobs that carry a lot less stress.

The implementation of FFPSA and requirements to provide more & better Preventive Services will require the Department to implement new evidence-based programming and seek more Preventive Services contracts that will require intensive planning, management, and oversight.

With the anticipated growth in the staffing of the Services Unit and the increasing responsibilities of planning, collaboration, monitoring, and reporting, we are

recommending a salary adjustment for the Director of Services to set her salary at \$82,305.

The Department of Solid Waste is proposing an Intermunicipal Agreement by and between the County of Oswego and the City of Fulton for the treatment of leachate and the disposal of sludge.

The agreement will allow for the County to dispose of 1,000,000 gallons of leachate per year at no charge in exchange for allowing the City of Fulton to dispose of up to 500 tons of wastewater treatment sludge per year at no charge. Deliveries exceeding these agreed upon quantities are charged at \$0.025 per gallon and \$75.00 per ton respectively.

This arrangement will allow the County to dispose of leachate, particularly from the Silk Road Landfill, at the nearest available treatment facility minimizing transportation costs and equipment demands upon the Department of Solid Waste. Likewise, the agreement will allow the City of Fulton to dispose of its wastewater treatment sludge upon most advantageous terms.

Accordingly, the department is requesting the corresponding resolution be approved.

**INTERMUNICIPAL AGREEMENT BY AND BETWEEN
THE COUNTY OF OSWEGO AND
THE CITY OF FULTON
(Leachate Treatment & Sludge Disposal)**

THIS AGREEMENT entered into this ____ day of July, 2022 by and between the **COUNTY OF OSWEGO**, a municipal corporation by and of the State of New York, with its principal offices for business located at 46 East Bridge Street, Oswego, New York and the **CITY OF FULTON**, a municipal corporation by and of the State of New York with its principal offices for business located at City Hall, 141 South First Street, Fulton, New York,

WITNESSETH:

WHEREAS, the County of Oswego Department of Solid Waste presently has between 10,000,000 to 12,000,000 gallons of leachate treated from its landfill; and

WHEREAS, the City of Fulton generates sludge at its Wastewater Treatment Plant and needs to dispose of same; and

WHEREAS, the City of Fulton Wastewater Treatment Plant is willing to accept and treat a certain amount of leachate from the county on an annual basis and, the County of Oswego, in turn, is willing to accept and dispose of a certain amount of sludge from the city; and

WHEREAS, said arrangement promotes inter-municipal cooperation and efficiency; and

WHEREAS, a written agreement is both necessary and desirable,

NOW, THEREFORE, it is mutually agreed as follows:

1. The County of Oswego Department of Solid Waste will accept up to 500 tons of wastewater treatment WWTP sludge for disposal from the City of Fulton without fee on an annual basis for the duration of this agreement and above that amount, a fee of \$75 per ton will be charged.
2. In turn, the City of Fulton Wastewater Treatment Plant WWTP will accept up to 1,000,000 gallons of landfill leachate from the County of Oswego without fee for treatment and above that amount, a fee of \$0.025 will be charged per gallon.
3. **Governing Law.** This Agreement shall be governed by and construed in accordance with the laws of the State without giving effect to the conflict of laws principles thereof. All disputes arising out of or in connection with this Agreement shall be decided in the first instance by the New York State Supreme Court, Oswego County, to the exclusion of all other courts, except that the parties shall have all appeal rights allowed by State law. The Parties hereby submit to the jurisdiction of the New York State Supreme Court, Oswego County, for purposes

of all such suits.

4. Severability. In the event that any provision of this Agreement is held to be unenforceable or invalid by any court or regulatory authority of competent jurisdiction, the validity and enforceability of the remaining provisions shall not be affected so long as the Parties renegotiate the unenforceable or invalid provision(s) in order to accomplish the goal and intent of this Agreement.

5. Entire Agreement; Amendment. This Agreement constitutes the entire agreement and understanding of the Parties with respect to its subject matter and it supersedes all prior agreements and understandings, written or oral, between the Parties regarding the acceptance of landfill leachate by the City of Oswego and Wastewater Treatment Plant sludge by the County of Oswego. This Agreement may not be amended except by an instrument in writing signed by the Parties. This Agreement has been approved by the Common Council of the City of Fulton and the Oswego County Legislature prior to execution.

6. If either party should become unable to operate its facility and/or to accept ongoing deliveries of sludge or leachate, except for temporary restrictions due to transient conditions, deliveries shall be suspended for said time-frame without liability to any party.

6. Effective Date. This Agreement shall be effective as of the date first written above.

7. Term. The term of this agreement shall be for five (5) years from the effective date.

Subject: Budget Modification for the County Clerk's office

Purpose: Transfer \$2,000 from 1410.542400 to 1410.514300

Summary: Due to the recent Supreme Court ruling, my office has been experiencing a large increase in the number of walk-in customers and paperwork associated with pistol permit restrictions. We are doing our best to provide efficient customer service but that leaves less time for data entry and paperwork. Increasing our additional hours line will provide the office with the flexibility to deal with this fluid situation.

This transfer is intended to cover the amount that we anticipate needed for the interim. We are already seeing an increase in revenue associated with pistol permits and believe this cost will be more than covered.
