**RECITALS**

WHEREAS, the City and the Public Defender entered into a Contract for Services (Contract) for the provision of preliminary legal representation at the South Correctional Entity (SCORE) for defendants charged with criminal offenses by the City and in custody at SCORE, as described in the scope of services in Section 1 of the Contract; and

WHEREAS, pursuant to Section 4 of the Contract, the Contract expires on December 31, 2018; and

WHEREAS, the Pacific City Council will not have an opportunity to consider a possible extension of the Contract until after it expires on December 31, 2018; and

WHEREAS, the City needs to maintain public defense services for defendants charged with criminal offenses by the City and in custody at SCORE, including after the expiration of the Contract on December 31, 2018, and

WHEREAS, the Public Defender agrees to continue providing public defense services as outlined in the Contract’s scope of services beyond the Contract’s expiration date,

THEREFORE, IN CONSIDERATION OF THE ABOVE, THE PARTIES HEREBY AGREE AS FOLLOWS:

**AGREEMENT**

1. Section 4 of the Contract is hereby amended to read as follows:



2. All other provisions of the Contract shall remain unaffected.


