

AMENDMENT # 23 TO ORIGINAL AGREEMENT FOR INMATE HOUSING

THIS AMENDMENT TO INTERLOCAL AGREEMENT FOR INMATE HOUSING dated as of MARCH 28, 2018 (hereinafter "Amendment to Original Agreement") is made and entered into by and between the **South Correctional Entity**, a governmental administrative agency formed pursuant to RCW 39.34.030(3) ("SCORE") and CITY OF PACIFIC (hereinafter the "City" and together with SCORE, the "Parties" or individually a "Party"). This Amendment to Original Agreement is intended to supplement and amend that certain Agreement for Inmate Housing between the Parties dated 3/20/18, as it may have been previously amended (the "Original Agreement"). The Parties hereto mutually agree as follows:

- 2018 Bed Rates.** Section 27 (Bed Rate) of the Original Agreement is hereby amended to include the following guaranteed and non-guaranteed bed rates for inmate housing:
Guaranteed Bed Rate: \$120.00 2 No. of Guaranteed Beds
Non-Guaranteed Bed Rate: \$175.00 _____
- Effective Date; Execution.** The bed rates provided for in Section 1 of this Amendment to Original Agreement shall become effective **January 1, 2018**. This Amendment to Original Agreement may be executed in any number of counterparts.
- Ratification and Confirmation.** All other terms and conditions of the Original Agreement are hereby ratified and confirmed.
