#### **Minutes**

#### CITY COUNCIL

June 6, 2022

A regular meeting of the City of Petoskey City Council was held in the City Hall Council Chambers, Petoskey, Michigan, on Monday, June 6, 2022. This meeting was called to order at 7:00 P.M.; then, after a recitation of the Pledge of Allegiance to the Flag of the United States of America, a roll call then determined that the following were

Present: John Murphy, Mayor

Also in attendance were Interim City Manager/Clerk-Treasurer Alan Terry, Parks and Recreation Director Kendall Klingelsmith, City Planner Zachary Sompels, Downtown Director Becky Goodman, Finance Supervisor Audrey Plath and Executive Assistant Sarah Bek.

#### **Hear Arbor Day Proclamation**

Mayor Murphy thanked the Parks and Recreation Director for his efforts in designating Petoskey as a Tree City USA and read the following proclamation:

WHEREAS, in 1872, J. Sterling Morton proposed to the Nebraska Board of Agriculture that a special day be set aside for the planting of trees; and

WHEREAS, the holiday, called Arbor Day, was first observed with the planting of more than a million trees in Nebraska; and

WHEREAS, Arbor Day is now observed throughout the nation and the world; and

WHEREAS, trees can reduce the erosion of our precious topsoil by wind and water, lower our heating and cooling costs, moderate the temperature, clean the air, produce oxygen and provide habitat for wildlife; and

WHEREAS, trees are a renewable resource giving us paper, wood for our homes, fuel for our fires and countless other wood products; and

WHEREAS, trees in our city increase property values, enhance the economic vitality of business areas, and beautify our community; and

WHEREAS, trees, wherever they are planted, are a source of joy and spiritual renewal:

NOW, THEREFORE, I, John Murphy, Mayor of the City of Petoskey, do hereby proclaim June 6, 2022 as Arbor Day in the City of Petoskey. I urge all citizens to celebrate Arbor Day and to support efforts to protect our trees and woodlands; and

FURTHER, I urge all citizens to plant and care for trees to gladden the heart and promote the well-being of this and future generations.

#### Hear Little Traverse Wheelway Westside Connector Schematic Design Presentation

The Parks and Recreation Director reviewed that in the fall of 2019, several significant fissures were identified along the Little Traverse Wheelway (LTW) between Magnus Park and Arrowhead Shores; that these areas were evaluated by engineers who recommended a larger study be completed to address the issues; that in April 2020, a slope failure caused several hundred feet of the LTW to be destroyed; that the City of Petoskey, Emmet County and Resort Township contracted with Beckett and Raeder to assist with direction to rebuild, re-route or abandon the trail and developed a schematic design with probable costs for a route on the south side of US-31.

Tim Knutsen, Landscape Architect with Beckett and Raeder, gave a presentation on the schematic design study; reviewed that the trail failure in 2020 closed the trail from East Park to Magnus Park; that concerns were raised regarding trail connectivity on the US-31 shoulder to bypass the trail closure; that preliminary trail routes were investigated on the north and south sides of the US-31 right-of-way and identified challenges with each proposed route; that the project team selected the south US-31 rightof-way option due to shoreline bluff stability, clearance from roadway, preliminary cost and establishment of trail connectivity between south side of US-31/Resort Township and LTW; reviewed feasibility of the south trail route option due to design and engineering including topographic survey, location of existing utilities within road right-of-way and utility replacement costs and accommodation of stormwater from proposed improvements; reviewed design and engineering influences; reviewed tunnel crossing and proposed location along with proposed retaining walls and clearance to roadway, to protect existing 72" storm sewer from impact and re-route utilities over/under tunnel and ramp structures; reviewed challenges of existing utilities and stormwater management; reviewed physical obstacles including required easements and surface features relocation; reviewed preliminary construction costs of south segment with an estimated \$6.49M for project with an additional cost of \$635,375 for alternate East Park connector; and concluded that the south segment is conceptually feasible from a design and engineering standpoint, that a separate study to identify preliminary design, engineering and construction costs to replace the failed section of the LTW would need to be completed.

City Councilmembers inquired if MDOT plans to share monitoring study; inquired if bollards were in place on Eppler curve; inquired if the Baird slope failure study covers same design; commented on deforesting from Greenwood Road area project and water movement from this area; inquired if a sidewalk with trail was considered on the south side which could be more immediate and cheaper; inquired on easement costs; heard concerns on road crossings and traffic speeds and that the current plan does not address safety; expressed that the bigger issue is the bluff failure and the community would like it repaired, but that comes at a cost; and commented that a sidewalk at Parkview in Resort Township would be favorable for walkability.

Mr. Knutsen responded that the project team received pushback from MDOT who cannot guarantee the trail will last at the bluff location; that MDOT placed a monitor at Eppler curve and monitoring bluff movement; that some concepts are comparable between the Baird slope failure study and schematic design, but that a more in-depth study would need to be completed for bluff location; that the tunnel and utilities are the biggest challenge in the south segment; and that he would be presenting to Emmet County and Resort Township next week.

Mayor Murphy asked for public comments and heard from the Executive Director of the Trails Council and that the City has been the quarterback of this project the past few years; that joint jurisdictions were looking for a cheap and fast solution, but it has been two years and cost is not cheap; that now elected officials should ask how should the trail be rebuilt; that consultants answered most questions, but more information is still needed; commented that switchbacks could be used to work with topography similar to M-119 section of LTW; and that 116,000 users, both tourists and locals, used trail in 2021 and trail does enhance economic impact.

Other public comments included from those in favor of rebuilding the bluff since it is a one-of-a-kind section of trail; heard a suggestion to charge users a permit fee to use trail to offset costs similar to use of State parks; and heard an inquiry on what is being done with existing trail since there is a lot of activity going on within the segment and concerned with current state and liability issues.

#### Consent Agenda - Resolution No. 19662

Following introduction of the consent agenda for this meeting of June 6, 2022, City Councilmember Wagner moved that, seconded by City Councilmember DeMoore adoption of the following resolution:

BE IT RESOLVED that the City Council does and hereby confirms that the draft minutes of the May 16, 2022 regular session and May 17, 2022 special joint session City Council meetings be and are hereby approved; and

BE IT RESOLVED that receipt by the City Council of a report concerning all checks that had been issued since May 16, 2022 for contract and vendor claims at \$760,208.88, intergovernmental claims at \$0 and the May 26 payroll at \$222,853.78, for a total of \$983,062.66 be and is hereby acknowledged.

#### **Hear Public Comment**

Mayor Murphy asked for public comments and heard a comment inquiring if a fine or fee could be assessed on commercial properties vacant for long periods of time; and heard from a neighbor of a short-term rental on Grove Street concerning ongoing issues including noise and parking.

#### **Hear City Manager Updates**

The City Manager reviewed that the City's \$72,500 Waterways grant request was approved for additional funding of the marina fuel farm; that Lofts at Lumber Square met with the Brownfield Redevelopment Authority and is proceeding with a Brownfield TIF request; that staff met with Krimson LLC who is proposing to include workforce housing at Michigan Maple Block site and will be requesting a Brownfield TIF, but no site plan has been submitted yet; that State Street reconstruction begins next week from Howard Street to Kalamazoo Avenue with an estimated completion of early August; that First Presbyterian Church will be installing a new steeple on Thursday requiring a portion of Division Street to be closed to traffic; and that the Public Safety Open House is scheduled for 11:00 A.M. to 2:00 P.M. next Saturday, June 18.

City Councilmembers requested a Brownfield presentation for City Council and the DMB; inquired on the current zoning for Michigan Maple Block property; heard an inquiry regarding converting all I-2 zoning districts to mixed use to help housing; and heard concerns with Lofts at Lumber Square since there isn't any requirement in MEDC grant for affordable housing and it's important if City financially contributes and possible need for a provision requiring workforce housing for a period of time.

City staff responded that there is a County-wide training on TIFs and staff would email date to City Councilmembers; that Michigan Maple Block is zoned I-2 and if proposed project is heavily residential then will require a zoning change with a possible PUD.

#### Discuss Proposed Zoning Ordinance Amendments to Remove Housing Barriers

The City Planner reviewed proposed zoning ordinance amendments to remove housing barriers including allowing accessory dwelling units; reviewed current and proposed language for R-1 and R-2 Single Family Residential Districts amending Section 400 Intent to maintain character of neighborhoods; reviewed language amending Section 401 – Principal Uses permitted and that a dwelling unit shall have a minimum footprint of 600 square feet, not including an attached garage; reviewed adding Subsection 8 to Section 401 principal uses permitted; and reviewed the addition of Subsection 9 to Section 401 Principal Uses permitted.

City Councilmembers discussed proposed changes; inquired if duplexes were historically not included, what is the goal of proposed amendments and if Emmet County just lowered their square footage requirement; inquired on the number of people who could occupy a 600 sq. foot dwelling and if two-unit dwellings were permitted now in R-1 and R-2 districts; heard concerns with 3-month rental period and that it will not help with short-term rental crisis; inquired on why an ADU would not have separate utility laterals and if a modular would be considered a type of ADU that would be permitted; and why an ADU could not be the same height as the principal residence.

City staff responded that duplexes were not historically included because there was more restriction due to large lots and open space; that the goal of the proposed amendment is to allow for regulation of ADU's to help densify area with restrictions and allow different housing options; that the County allows mobile homes to be ADU's, but there was resistance from the Planning Commission allowing mobile homes; that the County will issue occupancy permit; that there is no limitations in R-1 and R-2 districts if all conditions are met; that separate laterals are costly; and that the amendments are to encourage more development rather than being too restrictive and discourage growth.

Mayor Murphy asked for public comments and heard an inquiry if a home with an ADU for a family member would be allowed and if it would count as one of the 10 permitted; heard concerns that ADU deed restrictions seem more red tape and excessive; heard from those concerned with the 600 minimum square footage; heard from those in favor of hiring a compliance person prior to enacting ordinance; and that adding supply is most important thing since it is such a problem hiring in the community.

The proposed zoning ordinance will be further discussed at the next regular City Council meeting.

# <u>Discuss and Recommend Darling Lot Design Guidelines to Walker Parking – Resolution No.</u> 19663

The City Manager reviewed that a joint meeting of the City Council and Downtown Management Board was held on May 17 to hear a presentation by Walker Parking Consultants on a conceptual plan for a parking deck at the Darling Lot and that the consultant is looking for direction on how to proceed with the next step of the design phase.

City Councilmembers inquired if the plan would be reviewed by the Planning Commission; heard concerns on the decision to complete the study by the Parking Committee; heard concerns that there was no mention that it is an RRC property and owned by the City; heard from those in favor of seeing a mixed-use development on the property in addition to a parking structure; heard concerns on cost for not too much of an increase in parking; that it will be difficult to find funding and a developer; inquired on how the project would be funded; that covered parking is a priority in the City's Action Plan and that a single parking structure without another revenue stream is challenging; and concurred on a covered deck, medium architecture, no green roof or solar and perpendicular parking spots.

City staff responded that the plan will go before the Planning Commission, but not design elements; that the Parking fund has approximately \$1M saved to go toward a deck; that a smaller deck at Lake and Division Streets would be more feasible; that the more spent will cause more bonding; and that the feasibility study was included in this year's budget which was approved by City Council.

City Councilmember Wagner moved that, seconded by City Councilmember Walker to provide Walker Parking Consultants direction for continuing parking structure design with covered deck, medium architectural design, no solar panels or green roof and perpendicular parking spots.

Said motion was adopted by the following vote:

Mayor Murphy asked for public comments and heard a comment on self-driving cars and if Walker Parking is preparing for future technology; heard from those in favor of covered parking and the need for more in downtown; and heard concerns that the infrastructure is unaffordable.

#### <u>Approve Separation of Clerk – Treasurer Position – Resolution No. 19664</u>

The City Manager reviewed that the position of Clerk-Treasurer was combined approximately 40 years ago along with the Director of Finance; that due to increase in duties and heightened political awareness, less appeal to Finance applicants; that election duties involves several employees in the Department of Finance and involves the entire year with presidential election process; that Clerk duties are currently managed by Department of Finance staff and the City Manager's Administrative Assistant; that business licenses and permits have always been issued through the City Manager's Office while the elections handled through the efforts of everyone; that he recommended restructuring the position and separate the positions of Clerk-Treasurer and appoint Finance Supervisor as City Clerk with the Treasurer position to remain with the Director of Finance; and that by separating the positions it would allow to begin the recruiting process with Michigan Municipal League for the Director of Finance position due to his retirement scheduled for September 30, 2022.

City Councilmembers inquired if the separation would require a Charter change; heard from those in favor of waiting for the new City Manager to begin in two weeks to decide on the position; and inquired on the status of previous contract with HRGov.

The City Manager responded that a Charter change is not necessary as it allows City Council to separate or combine positions through resolution; and the City ended the previous contract with HRGov; and it will take some time to facilitate the transition process.

City Councilmember Shiels moved that, seconded by City Councilmember Walker to separate the Clerk-Treasurer position.

The City Manager then asked that the position not be split until September 1, 2022.

City Councilmember Shiels amended previous motion and moved that, supported by City Councilmember Walker to separate the Clerk-Treasurer position effective September 1, 2022.

Said motion was adopted by the following vote:

AYES: Shiels, Walker, Murphy (3) NAYS: DeMoore, Wagner (2)

#### **Council Comments**

Mayor Murphy asked for council comments and Councilmember DeMoore received resident complaints of speeding on Michigan Street and asked if additional traffic study data was available for Michigan Street. City Councilmember Shiels thanked the Planning Commission for their time and effort on removing housing barriers and mentioned there is a rare opportunity for available State and Federal grant funding. City Councilmember Wagner inquired if there were resources for citizens to remove dead trees if they have funding issues. City Councilmember Walker gave kudos to the Downtown Director and downtown businesses on lively summer activities over the weekend and thanked the Planning Commission and City Planner for their efforts in zoning amendments to remove housing barriers. Mayor Murphy reported he met with Black Coalition bike riders at the Carnegie Building and discussed diversity for entrepreneurs, thanked community members that helped him and the Parks and Recreation staff to plant flowers in Pennsylvania Park and also hosted second and third graders from Ottawa Elementary last Tuesday explaining the importance of government.

There being no further business to come before the City Council, this June 6, 2022, meeting of the City Council adjourned at 10:37 P.M.





**AGENDA SUBJECT**: Zoning Ordinance Amendments to Remove Housing Barriers

**RECOMMENDATION**: That the City Council discuss and possible adoption of proposed ordinance

amendments

**Background** At a public hearing on May 19, 2022, the Planning Commission discussed and approved the following ordinance amendment recommendations to the R-1 and R-2 Single Family Districts (Sections 400 and 401) to remove some of the housing barriers.

The proposed language outlines guidelines for new structures. Existing structures may be converted to accessory dwelling units pending building code. If the existing structure is to expand, it would have to fall into compliance with the new proposed ordinance language.

Currently, two family dwellings are allowed in the R-1 and R-2 Districts as a special condition use with approval by the Planning Commission. With the proposed language, two family dwellings would be allowed, as a permitted use, on an administrative level, as long as the project meets the requirements of proposed 401(8).

The 10 ADU's being proposed would be for the whole City where R-1 and R-2 uses are permitted. (R-1, R-2, R-3, RM-1, RM-2, B-1, B-3, B-3b, O-S, I-1, I-2)

<u>Discussion</u> The intent of these amendments is to focus on the careful allowance of accessory dwelling units in limited areas to help alleviate the pressure of the current nationwide housing crisis while diversifying the City's housing stock. In black are the proposed amendments from the Planning Commission with the red italics text being the current language.

#### 1. Amend Section 400 – Intent:

#### Current Language:

The R-1 and R-2 Single-Family Residential Districts are designed to be the most restrictive of the residential districts. The intent is to provide for an environment of predominantly low-density, one-family detached dwellings along with other residentially related facilities which serve the residents in the district.

#### Proposed language:

The R-1 and R-2 Single-Family Residential Districts are intended to continue the historic development pattern of primarily single family detached dwellings, with two-unit dwellings and limited detached accessory dwellings along with other residentially related facilities which serve the residents in the district.

#### 2. Amend Section 401 - Principal uses permitted (1)(c):

#### Current Language:

c. The dwelling unit shall have a minimum exterior width of 24 feet and a minimum depth of 24 feet. Attached garages shall not be included in width or depth measurements.

#### Proposed language:

c. The dwelling unit shall have a minimum footprint of 600 square feet, not including an attached garage.

#### 3. Add the following to Section 401 – Principal uses permitted:

- 8. Two-family attached dwellings subject to the following standards:
  - a. All regulations as contained in article XVI, Section 1600, Schedule limiting height, bulk, density and area by zoning district, in accordance with the district in which the parcel is located.
  - b. A two-family dwelling shall meet parking requirements of section 1704.
  - c. Two-family attached dwellings shall be architecturally compatible in size and character with the surrounding neighborhood.
  - d. A two-family dwelling shall not allow a garage to protrude beyond the front building plane.
  - e. For conversion of an existing building, the second dwelling entrance shall only be located on a non-street fronting building façade.
  - f. An exterior stairway to an upper level dwelling shall only be located on the side or rear of the structure and within the required building setbacks.
- 9. One (1) detached accessory dwelling unit (ADU) is allowed per residential lot subject to staff review and approval that the following standards are met:
  - a. An ADU is permitted on a parcel that has (1) single-family dwelling as the permitted principal use.
  - b. The property owner shall occupy either the ADU or the single-family dwelling on the property, except for temporary absences not to exceed a combined total of six (6) months in a calendar year, and be the primary residence of the property owner.
  - c. An ADU shall not exceed 600 square feet.
  - d. The property cannot exceed the lot coverage allowances of Section 1600 of the Zoning Ordinance.
  - e. At least one (1) off-street parking space shall be provided for the ADU. Tandem or stacked parking in a driveway may count toward the off-street parking requirement.
  - f. An ADU is not allowed on a property with a shared driveway.
  - g. Leasing or rental of the ADU for less than three (3) months is prohibited.

- h. The accessory dwelling unit shall NOT have separate utility laterals.
- i. A deed restriction that runs with the land, on a form to be provided by the City, shall be filed with the Register of Deeds prior to issuance of a zoning permit, and it shall incorporate the following restrictions:
  - 1) The ADU shall not be sold separately from the single-family dwelling.
  - 2) Shall specify the owner occupancy requirement and rental time limit.
  - 3) The deed restriction shall be in effect until the ADU is removed.
- j. No more than 10 new accessory dwelling units shall be permitted in a calendar year.
- k. The ADU cannot exceed 1 ½ stories and 16 feet, or the height of the principal structure, whichever is less.
- I. ADUs are only allowed in a rear yard and must have a minimum side-yard setback of five (5) feet, and a rear-yard setback of 5 feet. If located on an alley, accessory building setbacks shall apply.
- m. ADUs shall be compatible in appearance with the neighborhood.

<u>Recommendation</u> That the City Council conduct a second discussion and possible adoption of the proposed ordinance amendments to remove some of the housing barriers in the R-1 and R-2 Single Family Districts.

# AN ORDINANCE TO AMEND SECTIONS 400 AND 401 OF APPENDIX A, ZONING ORDINANCE OF THE PETOSKEY CODE OF ORDINANCES

WHEREAS, the Livable Petoskey Master Plan was adopted on July 19, 2021 and has a goal to provide a range of housing types, densities, and price levels to address the needs of all age groups, household types, and income levels; and

WHEREAS, the current lack of new housing construction is impacting the ability of current and new residents to find needed housing; and

WHEREAS, local regulations are one barrier to the construction of new housing that is under the control of the City of Petoskey; and

WHEREAS, the Planning Commission has been reviewing the zoning ordinances for several months to identify possible changes to remove such barriers and other needed changes and clarifications; and

WHEREAS, a public hearing was held May 19, 2022 by the Planning Commission on several changes where no opposition was received; and

WHEREAS, the Planning Commission recommends that the changes to Sections 400 and 401 of the Zoning Ordinance be approved to remove barriers to residential accessory units in residential districts.

NOW THEREFORE, the City of Petoskey ordains:

1. Section 400 of Appendix A to the Petoskey Code of Ordinances are hereby repealed and replaced with the following:

Section 400 – Intent:

The R-1 and R-2 Single-Family Residential Districts are intended to continue the historic development pattern of primarily single family detached dwellings, with two-unit dwellings and limited detached accessory dwellings along with other residentially related facilities which serve the residents in the district.

- 2. Section 401 of Appendix A to the Petoskey Code of Ordinances are hereby repealed and replaced with the following:
  - c. The dwelling unit shall have a minimum footprint of 600 square feet, not including an attached garage.
- 3. Section 401(8) and (9) of Appendix A to the Petoskey Code of Ordinances hereby added:
  - 8. Two-family attached dwellings subject to the following standards:

- a. All regulations as contained in article XVI, Section 1600, Schedule limiting height, bulk, density and area by zoning district, in accordance with the district in which the parcel is located.
- b. A two-family dwelling shall meet parking requirements of section 1704.

- d. A two-family dwelling shall not allow a garage to protrude beyond the front building plane.
- e. For conversion of an existing building, the second dwelling entrance shall only be located on a non-street fronting building façade.

- m. ADUs shall be compatible in appearance with the neighborhood.
- Conflicting Standards.

If any of the standards set forth in this amendment conflict with any other standards of previous or further ordinances or amendments, the stricter standards shall apply.

- Repeal; Savings Clause.
   All ordinances, resolutions, or orders, or parts thereof, in conflict with the provisions of this ordinance are, to the extent of such conflict, repealed.
- 6. Severability.

The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the Ordinance shall not be affected thereby.

7. Effect.

This ordinance shall take effect fifteen (15) days following its enactment and shall be published once within seven (7) days after its enactment as provided by Charter.

**Background** At its August 17, 2020 meeting, Council approved a resolution that would establish a Social District in Downtown Petoskey according to a specified map and maintenance and operation plan. As a part of that resolution, five local licensees were approved to apply to the State of Michigan for a Social District Permit that would allow them to sell alcohol that could be consumed in the Commons Area of the Social District. In September of 2020, one more local licensee was approved, bringing the total number of local licensees allowed to sell alcohol into the Commons Area of the Social District to six. All local licensees need to be approved by Council before they apply to the State for their permit.

<u>Action</u> Crooked Tree Arts Center, 461 East Mitchell Street, and owners of a class C liquor license, is now seeking approval to apply for a Social District Permit so that they may move ahead and fill out their application for approval to serve alcohol that may be taken into and consumed in the approved Commons Area. A local unit of government form from the State of Michigan is enclosed. It is the request of staff that this recommendation be granted.

Under Article IV, Section 40, of the Constitution of Michigan (1963), the Commission shall exercise complete control of the alcoholic beverage traffic within this state, including the retail sales thereof, subject to statutory limitations. Further, the Commission shall have the sole right, power, and duty to control the alcoholic beverage traffic and traffic in other alcoholic liquor within this state, including the licensure of businesses and individuals.

**RECOMMENDATION**: That City Council consider awarding construction bid to Tri-

County Excavating in the amount of \$301,755 for construction of

the Solanus Mission Beach Project

**Background** This project began in 2019 with a grant submittal to the Michigan Coastal Management Program for a feasibility study for Solanus Mission Beach. In December 2020, the City, along with assistance from Beckett and Raeder, submitted a grant with a project cost of \$225,000 to the Coastal Healthy Habitat, Waters and Communities Initiative to assist with costs related to developing access to the Solanus Mission Beach area. In December 2021, the \$225,000 project was recommended for 50% (\$112,500) funding through the program and approved by City Council. The Coastal Healthy Habitat, Waters and Communities is an opportunity through the Michigan Coastal Management Program that focuses on protecting coastal native vegetation, wildlife, water quality, erosion control while improving connections to the coast for public use and enjoyment.


In December, City Council approved the project agreement for development of Solanus Mission Beach. The grant will cover \$112,500 of the project cost. This is budgeted at \$250,000 in the Capital Improvement Plan and will be covered through the TIFA fund which currently has approximately \$987,000 in the fund.

**<u>Bid Results</u>** Availability of detailed plans and specifications were advertised on the City's website and construction plan rooms on April 18, 2022. There was also a pre-bid meeting on May 3 attended by one contractor. One bid was received on May 17:

Recommendation That City Council consider award of this project to Tri-County Excavating, Harbor Springs, for the bid amount of \$301,755. Tri-County has worked with the City on other projects and is familiar with city staff and local contractors. Staff and Beckett and Raeder Inc., are confident the contractor is capable of completing the project. Beckett and Raeder will continue to work with the contractor to value engineer unit costs and is confident cost savings through landscaping modifications, site amenities and decking material. Staff, Beckett and Raeder and the contractor would recommend the contract be awarded so material can be ordered and sub-contractors can be secured.

<u>Action</u> That City Council consider a motion to award the contract for the construction of the Solanus Mission Beach Project and authorize Alan Terry, City Manager, or his designee to serve as the City's representative for this project.

**Background** In 2021, the City approved an agreement with the Little Traverse Bay Ferry Company which allowed them the use of Pier A for passenger pick up and drop off for the ferry service.

In March 2022, the City approved an agreement with the Little Traverse Bay Ferry Company to lease the Historical Room in the Resource Center for their ticket and merchandise sales.

As part of the expansion plan for the LTBFC, they would like to add a Special Event Vessel, a 65-foot passenger boat. The vessel would be moored broadside on Pier A throughout the summer months and used for special events that could include; weddings, sunset cruises, educational purposes and a variety of other opportunities. All marina rules, which include quiet hours, will be expected from passengers and crew. A brochure is enclosed to this memo.

**Review** The enclosed agreement has been reviewed for completeness by City staff, legal counsel and the Little Traverse Bay Ferry Company. The LTBFC is acceptable to the terms of the agreement and has expressed appreciation for the use of Pier A.

<u>Action</u> That City Council consider the agreement for Little Traverse Bay Ferry Company for operation of a Special Event Vessel.

# LICENSE AGREEMENT FOR FERRY SERVICES

**THIS LICENSE AGREEMENT** ("Agreement") made this\_\_\_day of June, 2022 by and between the City of Petoskey, a Michigan municipal corporation, of 101 East Lake Street, Petoskey, Michigan 49770 (hereinafter the "City") and Little Traverse Bay Foundation, a Michigan nonprofit corporation, whose registered address is 115 E. Third Street, Harbor Springs, Michigan 49740 (hereinafter "Licensee") pursuant to the following terms and conditions:

NOW THEREFORE, the parties agree as follows:

#### 1. License and Location.

- A. The City hereby grants to Licensee a revocable non-exclusive license to use, in part, the City's marina to operate a seasonal Special Event Vessel, comprising of educational boat tours, nonprofit activities, sunset cruises, group cruises and other activities on the Vessel consistent with the nonprofit charitable purposes of Licensee (such as water research activities with educational institutions, Scouts merit badge activities, activities with Tip of the Mitt and fundraising events for Licensee) (collectively, the "Uses") from June 25 to September 25 (the "Season") in order to provide the Uses, including the Special Event Vessel, on Little Traverse Bay for the 2022 summer season (the "License"). Licensee has the option to renew this license for an additional One (1) year if mutually agreed upon by the City and Licensee. Licensee's operation shall include the operation of Special Event Vessel that includes all required safety gear, including life jackets and other flotation and safety devices required by the United States Coast Guard and other applicable governmental and regulatory agencies.
- B. The City grants the Licensee the right to moor broadside on the east side of Pier "A" at the City of Petoskey Marina as designated in writing by the Parks and Recreation Department for the City from which to carry out the Uses (the "Ferry Services Area").
- C. Licensee accepts the Ferry Services Area in its present "as is" condition. No alterations may be made by Licensee to the City's pier in the Ferry Services Area without the written consent of the City. Licensee shall be responsible for the cost to repair any damages caused by Licensee to the City's pier. In no event shall the City be liable for any damages to Licensee's vessel or loss of personal property, or to any person, sustained by Licensee or their guests or invitees.
- D. Nothing in this License gives Licensee or their employees the right to park vehicles in the designated marina parking area. Licensee and all of its staff shall only park vehicles in areas designated by the City. In addition, all patrons of Licensee's Ferry Taxi Service shall only park in areas designated by the City.
- E. The City is not providing any services to the Licensee's Special Event Service. All operations of the Special Event Service shall be assumed by Licensee, except the City will provide gasoline services as customary to all visitors of the City Marina.

F. There shall be no signs on public property for Licensee's Special Event Service, except as approved by the City.

#### 2. License Fee.

Licensee shall pay the City the sum of \$104/per day for the duration of the season. Payment will be every 30 days beginning when the vessel is moored.

#### 3. Termination.

This Agreement, including the License granted by the City, may be terminated by either the City or Licensee upon ten (10) days written notice to the other party. The termination or expiration of this Agreement shall not relieve Licensee of its obligations to the City. The Licensee shall, within this ten (10) day period, remove all trade fixtures and all other personal property of Licensee. In addition, the City shall have the right to terminate this Agreement at any time immediately upon written notice to Licensee for Licensee's failure to fulfill any of its obligations under this License Agreement or upon any violation of rule or law applicable to the providing of Special Event service or upon the insolvency or bankruptcy of Licensee. In this case, Licensee shall vacate the Services Area and remove its property upon reasonable request of the City.

#### 4. <u>Seasonal Dates of Operation</u>.

Licensee shall be required to operate the Special Event Service with 75 moored days and hours of operation as approved by the City. All events shall be held outside the marina area in Little Traverse Bay.

#### 5. <u>Maintenance</u>:

Licensee is responsible for cleaning the Services Area and surrounding area. The City shall be notified of the end of the season so as to make a final inspection of the area.

#### 6. <u>Security Background Check</u>:

All employees of the Licensee assigned to work at the Services Area shall undergo and must pass a security clearance check performed by the Petoskey Department of Public Safety prior to beginning actual work. This background check is necessary because employees will be working in a public park setting. In the event that an employee is deemed to be a security or safety risk, the Licensee shall immediately restrict the employee from working at the Ferry Services Area.

#### 7. Work Inspection; ADA Standards:

City staff and local or State Health Officials or their certified representatives shall, at all times, be allowed to inspect the Services Area for compliance with this Agreement, sanitary issues, etc. Licensee shall be responsible for obtaining all necessary permits and licenses from the health department and any other state or federal agency. The presence or absence of a City inspector will not relieve the Licensee of its responsibility to comply with

the terms of this Agreement. Licensee shall comply with all applicable state and federal standards, including by way of illustration, assure the vessel and Ferry Service Area comply with the American's with Disabilities Act ("ADA").

#### 8. <u>Liability Insurance</u>; <u>Indemnification</u>:

- A. Licensee shall purchase and maintain such insurance as will protect the City and Licensee from claims set forth below which may arise out of, or result from, the Licensee's operations under this Agreement, whether such operations are by the Licensee or by any subcontractor or by anyone directly or indirectly employed by Licensee, including:
  - 1. Under worker's compensation, disability benefits, and/or other similar employee benefit acts;
  - 2. For damages because of bodily injury, occupational sickness or disease, or death of his employees;
  - 3. For damages because of bodily injury, sickness or disease, or death of any person other than his employees;
  - 4. For damages insured by usual personal injury liability coverage which are sustained:
    - a. By any person as a result of an offense directly or indirectly related to the employment of such person by the Licensee; or
    - b. By any other person.
  - 5. Claims for damages because of injury to or destruction of tangible property, including loss of use resulting therefrom.
- B. The insurance required under this Agreement shall be written for not less than any limits of liability specified herein, or required by law, whichever is greater, and shall include contractual liability insurance as applicable to the Licensee's obligations.

- C. Certificates of Insurance and the policy itself, in form and content, acceptable to the City, shall be filed with the City prior to the commencement of any activity under this Agreement. These certificates and policies shall contain a provision that coverage afforded under the policies will not be cancelled until at least thirty (30) days prior notice has been given to the City.
- D. All insurance required by Licensee shall name the City as an additional named insured.
- E. Licensee hereby agrees to indemnify and hold the City, its agents, employees, contractors, successors, and assigns harmless for any and all liability, loss or damage the City, its agents, employees, contractors, successors, and assigns may suffer as a result of claims, demands, costs, or judgments arising out of Licensee's operations hereunder. Such indemnification shall include the reimbursement to the City, its agents, employees, contractors, successors, and assigns of reasonable attorney fees incurred by the City, its agents, employees, contractors, successors, and assigns in connection with the defense of any action related to Licensee's operations hereunder.

#### 9. <u>Codes, Laws and Ordinances</u>:

The Licensee shall comply with all laws, ordinances, rules, and regulations bearing on the conduct of the work to be performed under this Agreement, including all federal, state and local COVID regulations. Should any change in specifications be required to comply with laws, ordinances, rules, or regulations, the Licensee shall notify the City in writing. The Licensee shall be held to complete all work necessary to meet requirements of said laws.

#### 10. Verifications:

Prior to beginning to operate under this Agreement, City Staff and the Licensee shall visit the Services Area and review the day-to-day operation as outlined herein. Operations cannot commence until approval by the City.

#### 11. <u>Inspection</u>:

The Services Area shall be subject at all times to inspection by the City or its authorized representatives. The presence or absence of a City inspector will not relieve the Licensee of its responsibility to complete work in accordance with all applicable laws and the terms of this Agreement.

#### 12. <u>Changes</u>:

The Licensee may not make any changes to the Services Area, nor shall it operate contrary to this Agreement, without the written consent of the City Manager.

#### 13. <u>Assignment</u>:

This Agreement shall not be assigned by either party and any such assignment shall immediately terminate this Agreement.

#### 14. <u>Governing Law</u>:

This Agreement shall be governed by and construed in accordance with the laws of the State of Michigan, with venue in the County of Emmet.

#### 15. <u>Entire Agreement</u>:

The provisions herein contained constitute the entire agreement between the parties. Any oral representations or modifications shall be of no effect. No term or condition of this Agreement may be modified, amended or waived except by a written amendment signed by all parties.

**AGENDA SUBJECT**: Bayfront Park Clock Tower Canister Modifications

**RECOMMENDATION**: That City Council approve the enclosed proposed resolution

**Background** In March, City Council approved the clock tower improvement agreement with Verdin for \$49,154. The agreement included work that required the clock to be dissembled, transported to Cincinnati and evaluated. Upon inspection at the factory, Verdin came across unrepairable canisters, which hold the lights and motors. The fiberglass was fragile and brittle beyond repair. They have been exposed to the elements for 25+ years and will need to be replaced. After evaluating the situation, Verdin recommends replacing the canisters with rolled aluminum. This product will be a much better long-term solution to protect the upgraded LED lights and new motors. This result could not have been predicted without going through the process of disassembling the clocks. (See enclosed letter from Verdin Company)

The clock tower has been a long-standing fixture and tourist attraction in Bayfront Park since its installation. It's used as a feature in magazines, brochures and social media as a representation of Petoskey.

The cost of the repairs is covered through the TIFA fund which has \$987,000 balance. TIFA is a dedicated fund for projects in the TIFA district. Funds from the TIFA account are only available for capital improvements within the TIFA district.

Additionally, there are concerns of waiting another year due to increasing product cost and availability of material. The cost of the canister replacement will be \$56,130. The City has worked with Verdin for a number of years and provides resources (bucket truck and staff) to assist with the needs of the company to keep costs down.

<u>Action</u> That City Council consider approving the enclosed proposed resolution approving the proposal from Verdin Company to provide necessary canister replacements to the Bayfront Park Clock Tower for a cost of \$56,130.

Thank you so much for your time on the phone last week. I'm glad we were able to discuss the situation prior to sending this information along.

We needed to remove the canisters and bring them back to Cincinnati for preparation of the new equipment and structural testing, during the evaluation it was determined the fiberglass clock canisters were unusable due to the long-term wear of the fiberglass. The canisters have major cracks, and the fiberglass has become brittle with age. From the outside it appears in decent condition due to the paint coating, we did not discover the poor condition until the canisters were removed from the tower.

We have included marked photographs drawing attention to the troublesome areas with yellow arrows, we will need to replace these canisters moving forward, as the current fiberglass canisters are not in the condition where we can justify putting them back into the tower. As this separation continues the structural integrity of the canisters will continue to worsen and, in the future, there could be catastrophic failure of the canisters themselves.

The new replacement canisters will be made of rolled aluminum. This is the best option in terms of upkeep as well as material. As with the LED's being a much better option than fluorescent tubes, the rolled aluminum would not wear and separate as the fiberglass has, giving it more reliability and better structural integrity going forward. The additional cost, as outlined in the attached order form, will be \$56,130.00.

There is an alternative option available as a potential phase for the clocks. This would involve continuing with installing the new timepieces for the clocks along with a NEMA enclosure that would allow the timepieces to remain unaffected by the weather. The drawback here however, would be that LED backlighting (or any backlighting for that matter) would not be included and the potential of doing the canisters later with LED's would be subject to future pricing fluctuations. This option will cost an additional \$2,375.00.
