New Business

Directors Report

Director Klingelsmith gave an update on the Solanus Mission Beach project, which is on task and is scheduled to be completed by mid-November. Festival Place Shelter has been a challenge to coordinate with the contractor. Still planning on having the roof completed this fall. The marina fuel tank project is scheduled to begin as soon as the marina closes on October 1. Fuel tank should be in holding in early November but removal and preparation will begin as soon as possible. The Winter Sports Park Project Agreement has been submitted to the State and the City is awaiting a signature from the State. Director Klingelsmith talked about the fundraising efforts by the "Friends of the Winter Sports Park" and shared the link (www.friendsofthewintersportspark.com) and discussed the goal and how to get involved. The Trust Fund Grant Project Agreement for 58 acres of additional Skyline Property has been approved by City Council and is awaiting a signature from the State for final execution.

Klingelsmith went through the timeline for the Parks and Recreation Master Plan Update and asked the Commission to serve as the committee to establish goals and objectives. The Master Plan is due for updating and there some hard deadlines to be met. The goal setting will begin during the October meeting and additional meetings may be needed to make sure proper reviewing will occur. Committee members volunteered for room monitors during the public workshops.

Commissioner Comments

Commissioner Bush indicated Bear Creek Township is going forward with a kayak launch on the Click Road property.

Commissioner Walker expressed how much the pickleball courts were used this summer.

Commissioner Buchanan complimented the City on identifying "no mow zones" this summer.

Adjournment


