NEW BUSINESS:

New Member Orientation and Introductions

Introductions were made and the board welcomed newly appointed members Nan Casey and Carla Crockett to the board. Director Klingelsmith went through the history of TIFA and purpose, and highlighted some of the projects associated with the tenure of the program.

Election of Officers

The last few years, the board has turned over with members. Last year the chairperson resigned so it was imperative to elect a new Chairperson and Vice-Chairperson. Gary Hunter was nominated as Chairperson and Clark Smith as Vice Chairperson. Motion was made by George Robson with support from Carla Crockett with all members' present voting aye.

Budget Overview

Director Klingelsmith went through the FY 2022 proposed revenue and expenditures for the TIFA fund. Board was satisfied with the direction of the budget and related projects.

Capital Needs Assessment Presentation

Director Klingelsmith provided the approved Capital Improvement Plan (CIP) and reviewed years 2022 and 2023. The full plan, including the long term lacking funding items, was provided. Director Klingelsmith indicated the house at 620 Ingalls, which is identified in the CIP for demolition by the City, will likely be advertised for bid. This will benefit the City in saving costs of demolition and also put the property back on the tax rolls. Many of the projects would be grant funded so the schedule of these projects are contingent upon the process. The Director also noted most of the projects in the CIP don't rely on the TIFA funds but felt it important to share the direction with the group.

Livable Shoreline Demonstration Project Presentation

Director Klingelsmith presented about the newly planted livable shoreline demonstration project located in the promenade playground and marina launch ramp areas. The project was funded by a grant from the Petoskey-Harbor Springs Area Community Foundation through their Little Traverse Bay Restoration Fund, with support from the Tip of the Mitt Watershed Council. The project features native plant species, compost from Emmet County and services of local contractors. This is a project to address shoreline resiliency and landscaping best practices. This project is within the TIFA district and may be similar to other shoreline areas to develop. Board member Crockett was supportive of the project and indicated this approach in other areas would be supported.
