December 18, 2017

A regular meeting of the City of Petoskey City Council was held in the City Hall Council Chambers, Petoskey, Michigan, on Monday, December 18, 2017. This meeting was called to order at 7:00 P.M.; then, after a recitation of the Pledge of Allegiance to the Flag of the United States of America, a roll call then determined that the following were

Also in attendance were City Manager Robert Straebel, Clerk-Treasurer Alan Terry, City Planner Amy Tweeten, Downtown Director Becky Goodman and City Attorney James Murray.

Resolution No. 19133 Approve Consent Agenda Items Following introduction of the consent agenda for this meeting of December 18, 2017, City Councilmember Marshall moved that, seconded by City Councilmember Wills adoption of the following resolution:

BE IT RESOLVED that the City Council does and hereby confirms that the draft minutes of the December 4, 2017 regular session City Council meeting be and are hereby approved; and

BE IT RESOLVED that receipt by the City Council of a report concerning all checks that had been issued since December 4 for contract and vendor claims at \$1,628,332.93, intergovernmental claims at \$15,552.82, and the December 14 payroll at \$314,346.30, for a total of \$1,958,232.05 be and is hereby acknowledged.

Hear Public Comment

Mayor Murphy asked for public comments and there were no comments.

Hear City Manager Updates

The City Manager reported that staff will meet with FOPLC representatives tomorrow for the second round of negotiations and potentially could be discussed in closed

session at the January 15 meeting; that the Winter Sports Park opens for the season on December 22; that City Hall will be closed December 22, December 25 and January 1 in observance of the Christmas and New Year's Day holidays; and that he would be on vacation beginning December 20 through January 1, but available by phone.

Resolution No. 19134-35 Confirm Appointments Mayor Murphy reviewed that City Council consider possible appointments to the Downtown Management Board and Parks and Recreation Commission.

City Councilmember Marshall moved that, seconded by City Councilmember Wills adoption of the following resolution:

BE IT RESOLVED that the City Council does and hereby approves the appointment of Benjamin Slocum, 112 <sup>1</sup>/<sub>2</sub> Howard Street, to the Downtown Management Board for a fouryear term ending December 2021.

Said resolution was adopted by the following vote:

City Councilmember Dittmar then moved that, seconded by City Councilmember Wills adoption of the following resolution:

BE IT RESOLVED that the City Council does and hereby approves the reappointment of Amy McMullen, 901 Sunset Court, for a two-year term ending January 2020.

Discuss Potential Ordinance Amending Appendix A to the Zoning Ordinance The City Attorney reviewed that he had received a legal opinion from the attorney representing the Harbor Hall Foundation at the November 20 meeting. In the correspondence, Mr. VanTreese claimed that Harbor Hall's Recovery Residence is a "residential use" of "dwelling"

under case law interpreting application of the federal Fair Housing Act, 42 USC § 3601 *et seq*. (the "FHA") and the Americans with Disabilities Act, 42 USC § 12132 *et seq* (the "ADA"). The City Attorney further reviewed that Mr. VanTreese's correspondence further claimed that Harbor Hall, Inc. is licensed by the State of Michigan as a substance-abuse integrated treatment health system facility; that Harbor Hall houses a total of 50 beds 38 in the main building and 12 in two recovery residences; and that even if Harbor Hall's uses are not allowed within the RM-2 District, Harbor Hall's right to use the property for substance abuse housing is "grandfathered" given its continued operation for both office and residential use for over 40 years.

The City Attorney also reviewed Harbor Hall variances received over the last 40 years that all referred to boarding houses; reviewed Fair Housing Act and Americans with Disabilities Act; and that the current amendment predates any Harbor Hall proposal. The City Attorney recommended City Council give direction to staff to further amend the proposed Zoning Ordinance in the RM-2, B-2A and B-2B Districts in the following two ways:

## For the RM-2 District

(1) either allow residential substance abuse service facilities, by requiring the issuance of a conditional use permit, in the same manner as other materially similar uses such as boarding houses, emergency shelters, sheltered housing, and similar assisted living facilities or, alternatively, to (2) exclude entirely all materially similar uses so that no one use is singled out.

# For the B-2A District

(1) either allow residential substance abuse service facilities, by requiring the issuance of a conditional use permit, in the same manner as other materially similar uses such as boarding houses, emergency shelters, sheltered housing, and similar assisted living facilities or, alternatively, to (2) exclude entirely all materially similar uses so that no one use is singled out.

# For the B-2B District

(1) either allow residential substance abuse service facilities, by requiring the issuance of a conditional use permit, in the same manner as other materially similar uses such as boarding houses, emergency shelters, sheltered housing, and similar assisted living facilities or, alternatively, to (2) exclude entirely all materially similar uses so that no one use is singled out.

City Councilmembers discussed that Harbor Hall began as a boarding house and evolved into more; discussed exclusions to various districts; and to further define nursing/convalescent homes.

City Councilmembers concurred and directed staff to make the following changes to the proposed zoning ordinance amendment:

<u>RM-2 District</u> – permitted residential uses include Multifamily Housing, Single Family Residence, Two Family Residence, Assisted Living Facilities, Boarding House, Sheltered Housing, Convalescent/Nursing Facility and Residential Care and Treatment Facilities; that there are only 8 occupants per structure; and that there is a 400-foot buffer between facilities.

<u>B-2A & B-2B</u> – permitted residential uses include Multifamily Housing, Single Family Residence, Two Family Residence, and lodging uses Bed and Breakfast and Hotel; remove Assisted Living Facilities, Boarding House, Dormitory, Convalescent/Nursing Facilities, Residential Care and Treatment Facilities and Sheltered Housing.

Jeff VanTreese, Harbor Hall Attorney, commented that Harbor Hall is not a boarding house; that spacing requirements could be different; and that the facility is used for clinical use and residential use according to the Fair Housing Act.

Larry Rochon, Harbor Hall President, commented that it has been a 20-year vision to have a program for women; that Harbor Hall brought a plan to Council and possible road vacation; that there was an open house on Thursday, December 14 and 450 invitations were mailed, with only 6-7 neighbors who attended; and that Harbor Hall has scaled back plans from the initial presentation.

Mayor Murphy asked for public comments and heard from those that did not receive invitations and live in the neighborhood; that the open house was sparsely attended and didn't learn anything new; heard from those that benefited from Harbor Hall; that Harbor Hall changes lives and affects many individuals in the community; that there is no treatment programs in the area for females and Harbor Hall should be considered; that location is a concern and a facility in a more rural area would be preferred; that moving to a rural area does not integrate people back into society; that Council needs to be very clear on what is permitted and excluded from each district; inquiries if there is opposition to alcohol treatment facility in RM-2; that there needs to be open communication with Harbor Hall and the City; that Harbor Hall is trying to revitalize a dilapidated building and make it a transitional treatment facility; inquiries on what is the primary goal of the City and zoning can only cause wealth in a city; heard from those that would like to see it work and didn't realize amending the zoning code would have been such an issue 16 months ago when first brought to Council; and that a special condition use was recently granted for boarding houses in Charlevoix.

City Councilmembers further commented that they are the policy makers and not trying to disparage Harbor Hall; that Harbor Hall provides beneficial work to its residents and the community; and that there is no question that there is a need for a facility, but that it is the City's responsibility that it is compatible with the rest of the community.

The City Attorney reviewed that he would be communicating with Mr. VanTreese on an accommodation policy.

Based on City Council's direction, city staff will draft ordinance language and have a first reading of the proposed ordinance at the January 15, 2018 meeting.

Resolution No. 19136 - Approve						
Redevelopment Liquor License for						
425 Michigan Street, LLC						

The City Manager next reviewed that David Meikle, owner of 425 Michigan Street, LLC, submitted a Redevelopment Liquor License application for a bar/restaurant/garage building at 425 Michigan Street, behind the "Bistro" building on Michigan Street. The City Manager reviewed that

construction is currently ongoing for the new building adjacent to the alley and behind his two businesses, Tap 30 and Pour; that the first, second and third floors of the Tap 30 and Pour buildings have been renovated with the new garage serving as indoor parking spaces for 3<sup>rd</sup> floor residents; and that on November 21 the DMB unanimously recommended City Council approve the Redevelopment Liquor License.

The City Manager also commented that if approved, the license would be number 4 of the maximum 6 Redevelopment Liquor Licenses that are currently available; that the Public Safety Director had no concerns regarding the site or building plans from a public safety response perspective; and reviewed temporary escrows of licenses due to an issue that recently surfaced and that according to the City Attorney, the decision to escrow a liquor license is within the authority of the Michigan Liquor Control Commission.

City Councilmembers discussed how much licenses cost; purpose of redevelopment liquor licenses; and that DMB needs to be clear on intent of approving these licenses for downtown.

Mayor Murphy asked for public comments and heard from those encouraging the approval; that this business opportunity is creative; and these types of licenses help provide affordable new restaurants downtown.

City Councilmember Wills moved that, seconded by City Councilmember Marshall adoption of the following resolution:

WHEREAS, in 2011 the City of Petoskey established a Redevelopment Area under P.A. 501 of 2006 for purposes of fostering existing and new restaurants, entertainment or recreation establishments within Petoskey's Downtown Development Authority district; and

WHEREAS, 425 Michigan Street, LLC, 425 Michigan Street, has applied with the City of Petoskey for a Redevelopment Liquor License; and

WHEREAS, the Downtown Management Board reviewed and recommended the granting of a Redevelopment Liquor License for 425 Michigan Street, LLC because it will encourage economic growth and activity within downtown, particularly in the evening hours, and is in keeping with the downtown Master Plan; and

WHEREAS, the City's Department of Public Safety staff has completed investigations that are required to be performed by local governmental units under provisions of the Michigan Liquor Control Act; and

WHEREAS, the Department of Public Safety staff has reported to the City Manager that, based upon findings of the Department's investigations, the City Manager could recommend that the City Council confirm the City's approval of the application by 425 Michigan Street, LLC for a new Redevelopment Liquor License:

NOW, THEREFORE, BE IT RESOLVED that the City Manager be and is hereby directed to report to the Michigan Department of Labor and Economic Growth's Liquor Control Commission, upon forms that have been provided by the Liquor Control Commission, confirmation of the City Council's approval of the application by 425 Michigan Street, LLC, 425 Michigan Street, for a new Redevelopment Liquor License.

Resolution No. 19137- Approve Marketing Strategy for RRC Program The City Manager reviewed that as part of the Redevelopment Ready Communities Program, the City is required to adopt a Marketing Strategy to promote and market Petoskey creating a positive image that sets the

community apart from other communities. The City Manager further reviewed that the Marketing Strategy identifies opportunities and outlines steps to attract businesses, consumers and real estate development to Petoskey; highlights four development sites; focuses on common goals and strategies with implementation carried out by various community entities including, but not limited to, Petoskey Regional Chamber of Commerce, Petoskey Area Visitor's Bureau, the DMB and Northern Lakes Economic Alliance; and that some tools the City will use to market the community and redevelopment ready sites is through the City's new website and recently launched Facebook page.

City Councilmembers inquired if volunteers could help market the community; what the City's efforts were with developers; and discussed parking needs in the Michigan Lot.

Mayor Murphy asked for public comments and heard a comment that this type of strategy is needed for tax cuts and thanked Council for approving the Marketing Strategy.

City Councilmember Wills moved that, seconded by City Councilmember Lyman to approve the Marketing Strategy as part of the Redevelopment Ready Communities Program.

Said motion was adopted by the following vote:

Resolution No. 19138 Adopt 2017 Budget Amendments At the end of each fiscal year, the City Council is routinely asked to formally adopt amendments to the Annual Budget. These amendments are necessitated by a variety of circumstances, and in many cases are administrative

changes to formally reflect previously approved actions and priorities.

The Library Fund revenue and expenditure adjustments are due to two Townships approving a millage request for library services at the November General Election, after the Library budget was submitted. The approved budget did not include these additional revenues or the additional services that were provided due to the millage approvals in both Springvale and Little Traverse Townships. Additional services included an expansion of library hours, building maintenance and capital outlays, were a large part of the increase in expenditures.

City Councilmember Marshall moved that, seconded by City Councilmember Lyman adoption of the following resolution:

WHEREAS, at the close of the City's 2017 fiscal year, the City staff has determined that expenditures within one City fund is anticipated to differ from amounts that had been budgeted for:

<u>Background</u> At its December 18, 2017 meeting, City Council provided direction on further changes to the pending Zoning Ordinance amendment. City Council directed that regulations for assisted living, residential care and treatment facilities, and sheltered housing in the RM-2 District should have restrictions similar to boarding houses. There was also concern that the definition for assisted living facility was overly broad, so a definition for "convalescent/ nursing care facility" has been added that was previously in the Zoning Ordinance. Convalescent/ nursing care facilities would then have the same restrictions as other group living facilities.

Council further directed that these same uses should be removed from the B-2A Transitional Business and B-2B Mixed Use Corridor districts.

Enclosed is a summary use table of the four Zoning Districts.

## Summary of Ordinance Changes

## Article II Definitions

The following definitions are either added or modified:

Assisted Living Facility. A special combination of housing, supportive services, personalized assistance, and health care designed to respond to the individual needs of residents who need help with activities of daily living; which may or may not include a central or private kitchen, dining, recreational, and other facilities; with separate bedrooms or living quarters; and where the emphasis of the facility remains residential.

*Boarding House*. A dwelling unit with a single kitchen facility where lodging is provided and meals may be provided to occupants for compensation either directly or indirectly for no less than a 30-day period.

*Block face*. That portion of a block or tract of land facing the same side of a single street and lying between the closest intersecting streets.

*Convalescent/Nursing Care Facility.* A structure with sleeping rooms, where persons are housed and are furnished with meals, nursing and/or medical care.

## Article VI RM-1 Multiple Family District

The proposed changes remove "general hospitals" as a special condition use as there is now a hospital zoning district, and establish the same regulations for the assisted living facilities and convalescent/nursing care facilities at a maximum of 8 occupants per structure and a minimum distance of 400 feet between like facilities.

# Article VII RM-2 Multiple Family District

The RM-2 District language removes "medical offices or clinics" adjacent to a general hospital as a use as there is now a hospital zoning district. Added to the special condition uses are Boarding Houses, Residential Care and Treatment Facilities, and Sheltered Housing with conditions. All uses in the RM-1 Zoning District are allowed in the RM-2 Zoning District. The special conditions include:

Boarding Houses. Located on a parcel of land not less than 7,200 square feet in area with no less than one full bathroom for up to 5 (five) occupants and an additional halfbathroom provided for each additional 2 (two) occupants or full bathroom for each additional 4(four) occupants. Occupancy shall not exceed 8 persons per structure subject further to City licensing application for inspection and compliance with the International Property Maintenance Code (IPMC). No license shall be issued for a boarding house within 400 feet of an existing boarding house.

Residential Care and Treatment Facilities not to exceed 8 occupants per structure and a minimum distance between facilities of 400 feet.

Sheltered Housing not to exceed 8 occupants per structure and a minimum distance between facilities of 400 feet.

## Article XXIX B-2A Transitional Business

All group living facilities, including dormitories, have been removed as uses from these districts.

# Article XXX B-2B Mixed Use Corridor

All group living facilities, including dormitories, have been removed as uses from these districts.

## Article XVI Schedule of Regulations

Section 1600(1)(b) The minimum front-yard setback is the average of the front-yard setbacks of any three (3) adjacent houses on the same block face, or 25 feet, whichever is less.

Section 1600(1)(c) The minimum corner front-yard setback is the average of the front-yard setbacks of any three (3) adjacent houses on the same block face, or 25 feet, whichever is less.

## Article XVII Section 1704(6) Required Number of Parking Spaces

The category of "Residential Care and Treatment Facility" and "Sheltered Housing" will be added to the table with the requirement of 1 space per 3 beds.

The requirement for Boarding Houses is being recommended to be reduced from "1 space per rental room" to "2 spaces per dwelling" to make it consistent with single family requirements.

<u>Action</u> City Council is being asked to hold a first reading of the revised ordinance. The enclosed ordinance highlights the latest changes, with yellow highlights as new text and strikeouts as removed text.

# AN ORDINANCE TO AMEND APPENDIX A OF THE PETOSKEY CODE OF ORDINANCES, ZONING ORDINANCE ARTICLE II, ARTICLE VI, ARTICLE VII, ARTICLE XVI, ARTICLE XVII, ARTICLE XXIX, AND ARTICLE XXX

# THE PETOSKEY CITY COUNCIL ORDAINS:

1. Appendix A, Article II, Section 201 of the Petoskey Code of Ordinances is amended, in part, to amend the definition of Assisted Living Facility and Boarding House and to create a new definition of Block Face and Convalescent/ Nursing Care Facility. The remaining definitions remain in full force and effect. The revised and new definitions are as follows:

Assisted Living Facility. A special combination of housing, supportive services, personalized assistance, and health care designed to respond to the individual needs of residents who need help with activities of daily living; which may or may not include a central or private kitchen, dining, recreational, and other facilities; with separate bedrooms or living quarters; and where the emphasis of the facility remains residential. An assisted living facility shall not include a residential care and treatment facility.

*Block face.* That portion of a block or tract of land facing the same side of a single street and lying between the closest intersecting streets.

*Boarding House*. A dwelling unit with a single kitchen facility where lodging is provided and meals may be provided to occupants for compensation either directly or indirectly for no less than a 30-day period. A Boarding House shall not include any residential structure used for the treatment of alcohol or substance abuse, mental illness, or developmental disabilities.

Convalescent/Nursing Care Facility. A structure with sleeping rooms, where persons are housed and are furnished with meals, nursing and medical care.

# 2. Appendix A, Article VI of the Petoskey Code of Ordinances is hereby repealed and replaced by the following:

Sec. 600. - Intent.

The RM-1 Multiple-Family Residential District is designed to provide sites for lowdensity multiple-family dwelling structures which will generally serve as zones of transition between less intensive nonresidential districts and lower density singlefamily development. This district will also accommodate the large planned multiplefamily residential development.

Sec. 601. - Principal uses permitted.

In the RM-1 Multiple-Family Residential District, no building or land shall be used and no building shall be erected except for one or more of the following specified uses unless otherwise provided in this Ordinance:

- 1. All uses permitted and as regulated in the R-1 through R-3 Single-Family Residential Districts with the lot area and yards equal to at least the requirements of the immediately abutting Single-Family Residential District.
- 2. Multiple-family dwellings.
- 3. Accessory buildings and uses customarily incident to any of the above permitted uses.

Sec. 602. - Required conditions.

In the case of multiple dwelling developments, all site plans shall be submitted to the planning commission for its review and approval prior to issuance of a building permit.

Approval shall be contingent upon a finding that:

- 1. The site plan shows that a proper relationship exists between local streets and any proposed service roads, driveways, and parking areas to encourage pedestrian and vehicular traffic safety, and
- 2. All the development features including the principal building or buildings and any accessory buildings, or uses, open spaces, and any service roads, driveways and parking areas are so located and related to minimize the possibility of any adverse effects upon adjacent property, such as, but not limited to: channeling excessive traffic onto local residential streets, lack of adequate screening or buffering of parking or service areas, or building groupings and circulation routes located as to interfere with police or fire equipment access.

Sec. 603. - Principal uses permitted subject to special conditions.

The following uses shall be permitted, subject to conditions hereinafter imposed for each use, and subject further to the review and approval of the planning commission pursuant to section 1717 of the zoning ordinance:

- 1. Nursery schools, day nurseries, child-care centers (not including dormitories or family day-care homes), and group day-care homes (seven or more minor children), provided that for each child so cared for, there is provided and maintained a minimum of 150 square feet of outdoor play area. Such play space shall have a minimum area of at least 1,200 square feet, and shall be fenced or screened from any adjoining residential land with planting.
- 2. Assisted Living and Convalescent/Nursing Care Facilities not to exceed 8 occupants per structure. No such facility shall be less than 400 feet from any like facility. Assisted Living Facility only as a planned development consisting of either a single multiple unit structure and/or cottage-type dwellings.

3. Accessory buildings and uses customarily incident to any of the abovepermitted uses.

Sec. 604. - Area and bulk requirements.

See article XVI Schedule of Regulations limiting the height and bulk of buildings, the minimum size of lot permitted by land use, maximum density permitted and providing minimum yard setback requirements.

# 3. Appendix A, Article VII of the Petoskey Code of Ordinances is hereby repealed and replaced by the following:

Sec. 700. - Intent.

The RM-2 Multiple-Family Residential District is designed to provide sites for intermediate density multiple-family dwelling structures primarily in close proximity to high traffic and pedestrian generators such as the downtown area. This zone is designed to provide a zone of transition between such generators and other residential zoning districts.

Sec. 701. - Principal uses permitted.

In an RM-2 Multiple-Family Residential District, no building or land shall be used and no building shall be erected except for one or more of the following specified uses unless otherwise provided in this ordinance:

- 1. All uses permitted and as regulated in the RM-1 Multiple-Family Residential District.
- 2. Boarding houses without shared driveways, when located on a parcel of land not less than 7,200 square feet in area with no less than one full bathroom for up to 5 (five) occupants and an additional half-bathroom provided for each additional 2 (two) occupants or full bathroom for each additional 4(four) occupants. Occupancy shall not exceed 8 persons per structure subject further to City licensing application for inspection and compliance with the International Property Maintenance Code (IPMC). No license shall be issued for a boarding house within 400 feet of an existing boarding house.
- 2. Accessory buildings and uses customarily incident to any of the above permitted uses.

Sec. 702. - Principal uses permitted subject to special conditions.

The following uses shall be permitted, subject to the conditions hereinafter imposed for each use, and subject further to the review and approval of the planning commission pursuant to section 1717 of the zoning ordinance:

- 1. Offices for executive or administrative occupations including legal, accounting, insurance, finance or similar professions in existing residential structures with the following conditions:
  - a. The property is immediately adjacent to, or directly across the street from, a business-zoned parcel (B1, B2 or B3);
  - b. The property is within one block of the parking-exempt district as defined in section 1704(11) of the zoning ordinance;
  - c. No on-site parking shall be constructed in excess of that required for residential use;
  - d. Architecture of additions or alterations shall be consistent with residential character of the neighborhood;
  - e. No interior display shall be visible from the exterior of the building;
  - f. The outdoor storage of goods or material shall be prohibited;
  - g. Exterior lighting shall be residential in character with fixtures restricted to no more than ten feet in height, 75 watts maximum with shielded or frosted fixtures and illumination levels limited to five foot-candles or less;
  - h. Customer hours shall be limited to 8:00 a.m. in the morning to 6:00 p.m. in the evening;
  - i. Trash and waste disposal shall only be curbside residential without use of on-site dumpsters; and
  - j. All provisions of the sign ordinance are met.
- 2. Assisted Living, Convalescent/Nursing Care, Residential Care and Treatment, and Sheltered Housing Facilities not to exceed 8 occupants per structure. No such facility shall be less than 400 feet from any like facility. Sheltered Housing not to exceed 10 occupants per structure
- 3. Boarding houses with shared driveways, when located on a parcel of land not less than 7,200 square feet in area with no less than one full bathroom for up to 5 (five) occupants and an additional half-bathroom provided for each additional 2 (two) occupants or full bathroom for each additional 4(four) occupants. Occupancy shall not exceed 8 persons per structure subject further to City licensing application for inspection and compliance with the International Property Maintenance Code (IPMC). No license shall be issued for a boarding house within 400 feet of an existing boarding house.
- 4. Accessory buildings and uses customarily incident to any of the above permitted uses.

Sec. 703. - Area and bulk requirements.

See article XVI Schedule of Regulations limiting the height and bulk of buildings, the minimum size of lot permitted by land use, maximum density permitted and minimum yard setback requirements.

# 4. Appendix A, Article XVI Section 1600 (1) (b) and (c) of the Petoskey Code of Ordinances is hereby repealed and replaced by the following:

(b) The minimum front-yard setback is the average of the front-yard setbacks of any three (3) adjacent houses on the same block face, or 25 feet, whichever is less.

(c) The minimum corner front-yard setback is the average of the front-yard setbacks of any three (3) adjacent houses on the same block face, or 25 feet, whichever is less.

The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the Ordinance shall not be affected thereby.

#### 12. Effect.

This ordinance shall take effect fifteen (15) days following its enactment and shall be published once within seven (7) days after its enactment as provided by Charter.

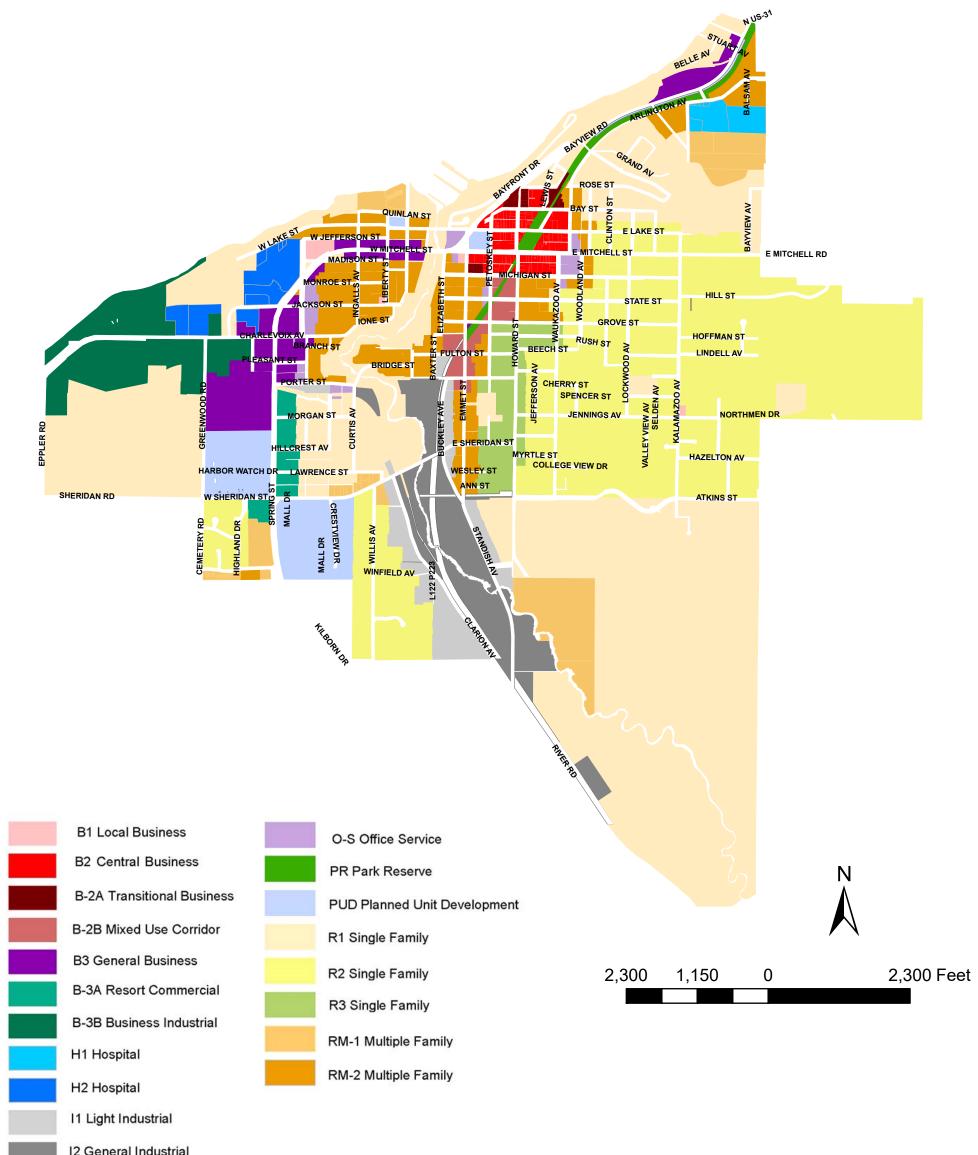

Background Magnus Park Campground is a very popular and unique destination for visitors who want to experience the City of Petoskey and surrounding areas from May through October. Currently, guests who wish to stay at Magnus Park have to go through the reservation process via the mail, which is extremely inefficient and results in an excessive amount of staff time to process the reservations.

Converting the current reservation system to an on-line process will free staff time while still providing the same quality result and exceptional customer service. Visitors will have the convenience of reserving their site on their mobile device, a computer, calling or stopping into City Hall. All staff will be trained to take a reservation over the phone and in person.

The cost of the reservation system will be incorporated in the current \$8 convenience fee. Visitors who reserve a site will pay the City upon completion of reservation process. The City will then transfer \$3 per reservation via direct deposit to MySites daily. There is no annual or monthly fee, nor long-term contract. MySites is an on-line platform that will not require any additional hardware for the City to purchase. The City will be able to use the point of sale system currently used at the Winter Sports Park. The point of sale system will be moved to Magnus Park and configured to accommodate taking reservations at the campground.

The City has a long-standing relationship with the parent company, Southeast Publishing Incorporated, as they have created site maps for the campground and marina for many years. The relationship has been positive and the communication through this process has been very transparent. City staff went through an extensive demonstration from the vendor once it was decided to pursue the product and were very pleased with the ease of the process and information provided. Not only will this tool improve the visitors experience with the reservation process, it will provide important data to staff to evaluate where improvements can be made at the campground.

Recommendation City staff, upon review, recommends to City Council to allow the City Manager to execute the agreement with MySites to provide an on-line reservation system for Magnus Park Campground.

#### Parties

- SEPI Marketing Corp. DBA MySites of 7676 B Peters Road a company incorporated in Broward County, Florida (Document number: P13000056760) having its registered office at 7676 B Peters Road, Plantation, FL 33324; (the "Provider") and;
- 2. *City of Petoskey Magnus Park of 101 E Lake Street, Petoskey, MI 49770* a company incorporated in Petoskey, MI (the "**Customer**").

#### Agreement

#### 1. Definitions

1.1 Except to the extent expressly provided otherwise, in this Agreement:

"**Account**" means an account enabling a person to access and use the MYSites Reservation Platform;

"**Agreement**" means this agreement including any Schedules, and any amendments to this Agreement from time to time;

**"Billing Provider"** – Any payment gateway chosen by the customer to collect their reservation fees from guests.

"Business Day" means any weekday other than a bank or public holiday.

"Business Hours" means the hours of 9:00am to 5:00pm EST on a Business Day;

"Charges" means the following amounts:

- (a) the amounts specified in Part 2 of Schedule 1 MYSites Reservation Management Platform;
- (b) Such amounts as may be agreed in writing by the parties from time to time; and

#### "Customer Confidential Information" means:

- (a) Any information disclosed by or on behalf of the Customer to the Provider during the Term OR at any time before the termination of this Agreement whether disclosed in writing, orally or otherwise that at the time of disclosure:
  - (i) was marked or described as "confidential"; or



- (ii) should have been reasonably understood by the Provider to be confidential; and
- (b) The Customer Data;

"**Customer Data**" means all data, works and materials: uploaded to or stored on the Platform by the Customer; transmitted by the Platform at the instigation of the Customer; supplied by the Customer to the Provider for uploading to, transmission by or storage on the Platform; or generated by the Platform because of the use of the MYSites Reservation Management Platform by the Customer;

"**Documentation**" means the documentation for the MYSites Reservation Management Platform produced by the Provider and delivered or made available by the Provider to the Customer;

"Effective Date" means the date of execution of this Agreement;

"Force Majeure Event" means an event, or a series of related events, that is outside the reasonable control of the party affected including failures of the internet or any public telecommunications network, hacker attacks, denial of service attacks, virus or other malicious software attacks or infections, power failures, industrial disputes affecting any third party, changes to the law, disasters, explosions, fires, floods, riots, terrorist attacks and wars;

"Guest" means a user of Magnus Park

"Intellectual Property Rights" means all intellectual property rights wherever in the world, whether registrable or un-registrable, registered or unregistered, including any application or right of application for such rights and these "intellectual property rights" include copyright and related rights, database rights, confidential information, trade secrets, know-how, business names, trade names, trademarks, service marks, passing off rights, unfair competition rights, patents, petty patents, utility models, semi-conductor topography rights and rights in designs;

"**Maintenance Platform**" means the general maintenance of the Platform and Reservation Management Platform, and the application of Updates and Upgrades;

"**Mobile App**" means the mobile application known as *MobileRVing 2.0* that is made available by the Provider through the *Google Play Store* and the *Apple App Store*;

"MySites" means the reservation management platform

"**Permitted Purpose**" means reservations management through the My Sites Reservation System;



"**Personal Data**" has the meaning given to it in the Data Protection Act 1998;

"**Platform**" means the platform managed by the Provider and used by the Provider to provide the Reservation Management Platform including the application and database software for the Reservation Management Platform, and server software used to provide the Reservation Management Platform, and the computer hardware on which that application, database, and server software is installed;

"**Schedule**" means any schedule attached to the main body of this Agreement;

"**Reservation Management Platform**" means *the MYSites Reservation System as* specified [Reservation Management Platform Specification], which will be made available by the Provider to the Customer as a service via the internet in accordance with this Agreement;

"**Reservation Management Platform Defect**" means a defect, error or bug in the Platform having an adverse effect OR a material adverse effect on the appearance, operation, functionality or performance of the Reservation Management Platform, but excluding any defect, error or bug caused by or arising because of:

- (a) Any act or omission of the Customer or any person authorized by the Customer to use the Platform or Reservation Management Platform;
- (b) Any use of the Platform or Reservation Management Platform contrary to the Documentation, whether by the Customer or by any person authorized by the Customer;
- (c) A failure of the Customer to perform or observe any of its obligations in this Agreement; and/or
- (d) An incompatibility between the Reservation Management Platform and any other services, network, application, program, hardware or software not specified as compatible in the Reservation Management Platform Specification;

"**Support Platform**" means support in relation to the use of, and the identification and resolution of errors in, the MySites Reservation System, but shall not include the provision of training Platform;

"**Supported Web Browser**" means the current release from time to time of Microsoft Internet Explorer, Mozilla Firefox, Google Chrome or Apple Safari, or any other web browser that the Provider agrees in writing shall be supported;

"**Term**" means the term of this Agreement, commencing in accordance with Clause 3.1 and ending in accordance with Clause 3.2;



"**Update**" means a hotfix, patch or minor version update to any Platform software; and

"**Upgrade**" means a major version upgrade of any Platform software.

**"Users"** – means employees or other stakeholders given access to the reservations management platform by the customer directly.

#### 2. Credit

2.1 This document was created by SEPI Marketing Incorporated

#### 3. Term

- 3.1 This Agreement shall come into force upon the Effective Date.
- 3.2 This Agreement shall continue in force indefinitely OR will be subject to termination in accordance with Clause 18.

#### 4. Reservation Management Platform

- 4.1 The Provider shall ensure that the Platform will, on the Effective Date, automatically generate an Account for the Customer and provide to the Customer login details for that Account.
- 4.2 The Provider hereby grants to the Customer a non-exclusive license to use the Reservation Management Platform by means of a Supported Web Browser for the internal business purposes of the Customer in accordance with the Documentation during the Term.
- 4.3 The license granted by the Provider to the Customer under Clause 4.2 is subject to the following limitations:
  - (a) Reservation Management Platform may only be used by the officers, employees, agents and subcontractors of the Customer;
  - (b) Reservation Management Platform may only be used by the named users identified in Schedule 1 Reservation Management Platform providing that the Customer may change, add or remove a designated named user in accordance with the procedure set out therein; and
  - (c) The Reservation Management Platform must not be used at any point in time by more than the number of concurrent users specified in Schedule 1 Reservation Management Platform, if the Customer may add or remove concurrent user licenses in accordance with the procedure set out therein.
- 4.4 Except to the extent expressly permitted in this Agreement or required by law on a non-excludable basis, the license granted by the Provider to the Customer under Clause 4.2 is subject to the following prohibitions:



- (a) The Customer must not sub-license its right to access and use the Reservation Management Platform;
- (b) The Customer must not permit any unauthorized person to access or use the Reservation Management Platform;
- (c) The Customer must not use the Reservation Management Platform to provide Platform to third parties;
- (d) The Customer must not republish or redistribute any content or material from the Reservation Management Platform; and
- (e) The Customer must not make any alteration to the Platform except as permitted by the Documentation.
- 4.5 The Customer shall use reasonable endeavors, including reasonable security measures relating to administrator Account access details, to ensure that no unauthorized person may gain access to the Reservation Management Service Platform using an administrator Account.
- 4.6 The Provider shall use all reasonable endeavors to maintain the availability of the Reservation Management Platform to the Customer at the gateway between the public internet and the network of the hosting Platform provider for the Reservation Management Platform, but does not guarantee 100% availability.
- 4.7 For the avoidance of doubt, downtime caused directly or indirectly by any of the following shall not be considered a breach of this Agreement:
  - (a) a Force Majeure Event;
  - (b) a fault or failure of the internet or any public telecommunications network;
  - (c) a fault or failure of the Customer's computer s or networks;
  - (d) any breach by the Customer of this Agreement; or
  - (e) scheduled maintenance carried out in accordance with this Agreement.
- 4.8 The Customer must comply with Schedule 2 Acceptable Use Policy, and must ensure that all persons using the Reservation Management Platform with the authority of the Customer or by means of an administrator account comply with Schedule 2 (Acceptable Use Policy).
- 4.9 The Customer must not use the Reservation Management Platform in any way that causes, or may cause, damage to the Reservation Management Platform or Service or impairment of the availability or accessibility of the Reservation Management Platform.



- 4.10 The Customer must not use the Reservation Management Platform:
  - (a) in any way that is unlawful, illegal, fraudulent or harmful; or
  - (b) in connection with any unlawful, illegal, fraudulent or harmful purpose or activity.
- 4.11 For the avoidance of doubt, the Customer has no right to access the software code (including object code, intermediate code and source code) of the Platform, either during or after the Term.
- 4.12 The Provider may suspend the provision of the Reservation Management Platform if any amount due to be paid by the Customer to the Provider under this Agreement is overdue, and the Provider has given to the Customer at least 30 days' written notice, following the amount becoming overdue, of its intention to suspend the Reservation Management Platform on this basis.

#### 5. Maintenance Services

- 5.1 The Provider shall provide the Maintenance Services to the Customer during the Term.
- 5.2 The Provider shall where practicable give to the Customer at least 5 Business Days' prior written notice of scheduled Maintenance services that are likely to affect the availability of the Reservation Management Platform or are likely to have a material negative impact upon the Reservation Management Platform, without prejudice to the Provider's other notice obligations under this main body of this Agreement.
- 5.3 The Provider shall give to the Customer at least 5 Business Days' prior written notice of the application of an Upgrade to the Platform.
- 5.4 The Provider shall give to the Customer written notice of the application of any security Update to the Platform and at least 5 Business Days prior written notice of the application of any non-security Update to the Platform.
- 5.5 The Provider shall provide the Maintenance services with reasonable skill and care.
- 5.6 The Provider may suspend the provision of the Maintenance Services if any amount due to be paid by the Customer to the Provider under this Agreement is overdue, and the Provider has given to the Customer at least 30 days' written notice, following the amount becoming overdue, of its intention to suspend the Maintenance Services on this basis.

#### 6. Support Services

6.1 The Provider shall provide the Support Services to the Customer during the Term. Services to include, training, custom programming support for the customer and other technical support as needed



- 6.2 The Provider shall make available to the Customer a helpdesk in accordance with the provisions of this main body of this Agreement.
- 6.3 The Provider shall provide the Support Service with reasonable skill and care; properly explaining all aspects of the system to the customer's satisfaction.
- 6.4 The Customer may use the helpdesk for the purposes of requesting and, where applicable, receiving the Support Services; and the Customer must not use the helpdesk for any other purpose.
- 6.5 The Provider shall respond promptly to all requests through Support Services that are made by the Customer through the helpdesk. Leaving no longer than a 24 hour lapse in communication.
- 6.6 The Provider may suspend the provision of the Support Platform if any amount due to be paid by the Customer to the Provider under this Agreement is overdue, and the Provider has given to the Customer at least 30 days' written notice, following the amount becoming overdue, of its intention to suspend the Support Platform on this basis.

#### 7. Customer Data

- 7.1 The Customer hereby grants to the Provider a non-exclusive license to copy, reproduce, store, distribute, publish, export, adapt, edit and translate the Customer Data to the extent reasonably required for the performance of the Provider's obligations and the exercise of the Provider's rights under this
- 7.2 The Customer warrants to the Provider that the Customer Data will not infringe the Intellectual Property Rights or other legal rights of any person and will not breach the provisions of any law, statute or regulation, in any jurisdiction and under any applicable law.
- 7.3 The Provider shall create a back-up copy of the Customer Data at least weekly, shall ensure that each such copy is sufficient to enable the Provider to restore the Reservation Management Platform to the state they were in at the time the back-up was taken, and shall retain and securely store each such copy for a minimum period of 30 day.
- 7.4 Within the period of 1 Business Day following receipt of a written request from the Customer, the Provider shall use all reasonable endeavors to restore to the Platform the Customer Data stored in any back-up copy created and stored by the Provider in accordance with Clause 7. The Customer acknowledges that this process will overwrite the Customer Data stored on the Platform prior to the restoration.

#### 8. Mobile App

8.1 The parties acknowledge and agree that the use of the Mobile App, the parties' respective rights and obligations in relation to the Mobile App and any



liabilities of either party arising out of the use of the Mobile App shall be subject to separate terms and conditions, and accordingly this Agreement shall not govern any such use, rights, obligations or liabilities.

#### 9. No assignment of Intellectual Property Rights

9.1 Nothing in this Agreement shall operate to assign or transfer any Intellectual Property Rights from the Provider to the Customer, or from the Customer to the Provider.

#### 10. Charges

- 10.1 The Customer is free to select a Billing Provider of their choice to process Guest accommodation payments and convenience fee payments that are charged by the Provider.
- 10.2 Convenience Fees are paid by the Guest and collected by the Customer through the Customer's Billing Provider.
- 10.3 Guest Reservations taken online, over the phone or in person will be subject to a \$3.00 (USD) Convenience Fee charged by the Provider to the Guest. The Convenience Fee is a one-time fee the Guest will pay after their initial balance has been satisified.
- 10.4 The Customer will be responsible for collection of the Provider's Convenience fee that will be clearly marked within the Guest's bill.
- 10.5 The Convenience Fee is a fee charged by the Provider and has no association with any fees that are charged to the Customer by the Customer's Billing Provider.
- 10.6 The Provider will not charge the Customer for reservations that end as a cancellation or refund.
- 10.7 The Provider may elect to vary any element of the Charges by giving to the Customer not less than 30 days written notice of the variation expiring on any anniversary of the date of execution of this Agreement.

#### 11. Payments

- 11.1 Convenience Fee Payments will be paid for by the Guest in addition to the balance that is owed to the Customer.
- 11.2 Convenience Fee Payments will be collected by the Customer as Guests close their balances which will include the Provider's Convenience fee.
- 11.3 Convenience Fee Payments from charges calculated by the Provider have no association with payments that are owed to the Customer's Billing Provider.



- 11.4 Collected Convenience Fee payments from the Customer to the Provider will be calculated and auto-debited daily through the MySites Reservations System which will utilize the preferred payment method of the Customer.
- 11.5 The Customer will have access to daily debit amounts through the Billing Dashboard of MySites for real time auditing purposes.
- 11.6 If the Customer does not pay any amount properly due to the Provider under this Agreement, the Provider may:
  - (a) Charge the Customer interest on the overdue amount at the rate of 8% per annum. Interest will accrue daily until the date of actual payment and be compounded at the end of each named calendar month; or

#### **12.** Provider's confidentiality obligations

- 12.1 The Provider must:
  - (a) Keep the Customer Confidential Information strictly confidential;
  - (b) Not disclose the Customer Confidential Information to any person without the Customer's prior written consent and then only under conditions of confidentiality;
  - (c) Use the same degree of care to protect the confidentiality of the Customer Confidential Information as the Provider uses to protect the Provider's own confidential information of a similar nature, being at least a reasonable degree of care;
  - (d) Act in good faith always in relation to the Customer Confidential Information; and
  - (e) Not use any of the Customer Confidential Information for any purpose other than the Permitted Purpose.
- 12.2 Notwithstanding Clause 12.1, the Provider may disclose the Customer Confidential Information to the Provider's officers, employees, professional advisers, insurers, agents and subcontractors who have a need to access the Customer Confidential Information for the performance of their work with respect to the Permitted Purpose and who are bound by a written agreement or professional obligation to protect the confidentiality of the Customer Confidential Information.
- 12.3 This Clause 12 imposes no obligations upon the Provider with respect to Customer Confidential Information that:
  - (a) is known to the Provider before disclosure under this Agreement and is not subject to any other obligation of confidentiality;



- (b) is or becomes publicly known through no act or default of the Provider; or
- (c) Has been obtained by the Provider from a third party in circumstances where the Provider has no reason to believe that there has been a breach of an obligation of confidentiality.
- 12.4 The restrictions in this Clause 12 do not apply to the extent that any Customer Confidential Information is required to be disclosed by any law or regulation, by any judicial or governmental order or request, or pursuant to disclosure requirements relating to the listing of the stock of the Provider on any recognized stock exchange.
- 12.5 The provisions of this Clause 12 shall continue in force indefinitely following the termination of this Agreement OR for a period of 5 years following the termination of this Agreement, at the end of which period they will cease to have effect.

#### 13. Data protection

- 13.1 The Customer warrants to the Provider that it has the legal right to disclose all Personal Data that it does in fact disclose to the Provider under or about this Agreement, and that the processing of that Personal Data by the Provider for the Permitted Purpose in accordance with this Agreement will not breach any applicable data protection or data privacy laws.
- 13.2 To the extent that the Provider Processes Personal Data disclosed by the Customer, the Provider warrants that:
  - (a) it will act only on instructions from the Customer in relation to the processing of that Personal Data;
  - (b) it has in place appropriate security measures (both technical and organizational) against unlawful or unauthorized processing of that Personal Data and against loss or corruption of that Personal Data

#### 14. Warranties

- 14.1 The Provider warrants to the Customer that:
  - (a) The Provider has the legal right and authority to enter into this Agreement and to perform its obligations under this Agreement;
  - (b) The Provider will comply with all applicable legal and regulatory requirements applying to the exercise of the Provider's rights and the fulfilment of the Provider's obligations under this Agreement; and
  - (c) The Provider has access to all necessary know-how, expertise and experience to perform its obligations under this Agreement.



- 14.2 The Provider warrants to the Customer that:
  - (a) The Reservation Management Platform will conform in all respects with the Reservation Management Platform Specification;
  - (b) The Reservation Management Platform will be free from defects;
  - (c) The application of Updates and Upgrades to the Platform by the Provider will not introduce any Reservation Management Platform Defects into the system;
  - (d) The Platform will be free from viruses, worms, Trojan horses, ransomware, spyware, adware and other malicious software programs; and
  - (e) The Platform will incorporate security features reflecting the requirements of good industry practice.
- 14.3 The Provider warrants to the Customer that the Reservation Management Platform, when used by the Customer in accordance with this Agreement, will not breach any laws, statutes or regulations applicable under law.
- 14.4 The Provider warrants to the Customer that the Reservation Management Platform, when used by the Customer in accordance with this Agreement, will not infringe the Intellectual Property Rights of any person in any jurisdiction and under any applicable law.
- 14.5 If the Provider reasonably determines, or any third party alleges, that the use of the Reservation Management Platform by the Customer in accordance with this Agreement infringes any person's Intellectual Property Rights, the Provider may at its own cost and expense:
  - (a) modify the Reservation Management Platform in such a way that they no longer infringe the relevant Intellectual Property Rights; or
  - (b) procure for the Customer the right to use the Reservation Management Platform in accordance with this Agreement.
- 14.6 The Customer warrants to the Provider that it has the legal right and authority to enter into this Agreement and to perform its obligations under this Agreement.
- 14.7 All of the parties' warranties and representations in respect of the subject matter of this Agreement are expressly set out in this Agreement. To the maximum extent permitted by applicable law, no other warranties or representations concerning the subject matter of this Agreement will be implied into this Agreement or any related contract.

#### **15.** Acknowledgements and warranty limitations



- 15.1 The Customer acknowledges that complex software is never wholly free from defects, errors and bugs; and subject to the other provisions of this Agreement, the Provider gives no warranty or representation that the Reservation Management Platform will be wholly free from defects, errors and bugs.
- 15.2 The Customer acknowledges that complex software is never entirely free from security vulnerabilities; and subject to the other provisions of this Agreement, the Provider gives no warranty or representation that the Reservation Management Platform will be entirely secure.
- 15.3 The Customer acknowledges that the Reservation Management Platform is designed to be compatible only with that software and those specified as compatible in the Reservation Management Platform Specification; and the Provider does not warrant or represent that the Reservation Management Platform will be compatible with any other software.
- 15.4 The Customer acknowledges that the Provider will not provide any legal, financial, accountancy or taxation advice under this Agreement or in relation to the Reservation Management Platform; and, except to the extent expressly provided otherwise in this Agreement, the Provider does not warrant or represent that the Reservation Management Platform or the use of the Reservation Management Platform by the Customer will not give rise to any legal liability on the part of the Customer or any other person.

#### 16. Limitations and exclusions of liability

- 16.1 The limitations and exclusions of liability set out in this Clause 16 and elsewhere in this Agreement:
  - (a) are subject to Clause 16.1; and
  - (b) govern all liabilities arising under this Agreement or relating to the subject matter of this Agreement, including liabilities arising in contract, in tort (including negligence) and for breach of statutory duty, except to the extent expressly provided otherwise in this Agreement.
- 16.2 Neither party shall be liable to the other party in respect of any losses arising out of a Force Majeure Event.
- 16.3 The Provider shall not be liable to the Customer in respect of any loss of profits or anticipated savings.
- 16.4 The Provider shall not be liable to the Customer in respect of any loss of revenue or income.
- 16.5 The Provider shall not be liable to the Customer in respect of any loss of use or production.



- 16.6 The Provider shall not be liable to the Customer in respect of any loss of business, contracts or opportunities.
- 16.7 The Provider shall not be liable to the Customer in respect of any loss or corruption of any data, database or software providing that this Clause 16.8 shall not protect the Provider unless the Provider has fully complied with its obligations under Clause 7.3 and Clause 7.4.
- 16.8 The Provider shall not be liable to the Customer in respect of any special, indirect or consequential loss or damage.
- 16.9 The liability of the Customer to the Provider under this Agreement in respect of any event or series of related events shall not exceed the greater of:
  - (a) *\$5,000.00* and
  - (b) The total amount paid and payable by the Customer to the Provider under this Agreement in the 12-month period preceding the commencement of the event or events.

#### **17.** Force Majeure Event

- 17.1 If a Force Majeure Event gives rise to a failure or delay in either party performing any obligation under this Agreement, that obligation will be suspended for the duration of the Force Majeure Event.
- 17.2 A party that becomes aware of a Force Majeure Event which gives rise to, or which is likely to give rise to, any failure or delay in that party performing any obligation under this Agreement, must:
  - (a) promptly notify the other; and
  - (b) inform the other of the period for which it is estimated that such failure or delay will continue.
- 17.3 A party whose performance of its obligations under this Agreement is affected by a Force Majeure Event must take reasonable steps to mitigate the effects of the Force Majeure Event.

#### 18. Termination

- 18.1 Either party may terminate this Agreement by giving to the other party at least 30 days' written notice of termination.
- 18.2 Either party may terminate this Agreement immediately by giving written notice of termination to the other party if the other party commits a material breach of this Agreement.
- 18.3 Either party may terminate this Agreement immediately by giving written notice of termination to the other party if:



- (a) the other party:
  - (i) is dissolved;
  - (ii) ceases to conduct all or substantially all of its business;
  - (iii) is or becomes unable to pay its debts as they fall due;
  - (iv) is or becomes insolvent or is declared insolvent; or
  - (v) convenes a meeting or makes or proposes to make any arrangement or composition with its creditors;
- (b) an administrator, administrative receiver, liquidator, receiver, trustee, manager or similar is appointed over any of the assets of the other party;
- (c) an order is made for the winding up of the other party, or the other party passes a resolution for its winding up; or
- (d) if that other party is an individual:
  - (i) that other party dies;
  - (ii) as a result of illness or incapacity, that other party becomes incapable of managing his or her own affairs; or
  - (iii) that other party is the subject of a bankruptcy petition or order.

#### **19.** Effects of termination

- 19.1 Upon the termination of this Agreement, all the provisions of this Agreement shall cease to have effect, save that the following provisions of this Agreement shall survive and continue to have effect (in accordance with their express terms or otherwise indefinitely): [Clauses 1, 4.11, 8, 11.2, 11.4, 12, 16, 19, 22 and 23].
- 19.2 Except to the extent that this Agreement expressly provides otherwise, the termination of this Agreement shall not affect the accrued rights of either party.
- 19.3 Within 30 days following the termination of this Agreement for any reason:
  - (a) the Customer must pay to the Provider any Charges in respect of Platform provided to the Customer before the termination of this Agreement; and without prejudice to the parties' other legal rights.

#### 20. Notices

20.1 Any notice from one party to the other party under this Agreement must be given by one of the following methods using the relevant contact details set



out in Clause 20.2 and Part 3 of Schedule 1 (Reservation Management Platform particulars):

- (a) Delivered personally or sent by courier, in which case the notice shall be deemed to be received upon delivery; or
- (b) Sent by recorded signed-for post, in which case the notice shall be deemed to be received 2 Business Days following posting,

providing that, if the stated time of deemed receipt is not within Business Hours, then the time of deemed receipt shall be when Business Hours next begin after the stated time.

20.2 The Provider's contact details for notices under this Clause 20 are as follows:

20.3 The addressee and contact details set out in Clause 20.2 and Part 3 of Schedule 1 (Reservation Management Platform) may be updated from time to time by a party giving written notice of the update to the other party in accordance with this Clause 20.

#### 21. Subcontracting

- 21.1 The Provider must not subcontract any of its obligations under this Agreement without the prior written consent of the Customer.
- 21.2 The Provider shall remain responsible to the Customer for the performance of any subcontracted obligations.
- 21.3 Notwithstanding any other provision of this Agreement, the Customer acknowledges and agrees that the Provider may subcontract to any reputable third party hosting business the hosting of the Platform and the provision of Platform in relation to the support and maintenance of elements of the Platform.

#### 22. General

- 22.1 No breach of any provision of this Agreement shall be waived except with the express written consent of the party not in breach.
- 22.2 If any provision of this Agreement is determined by any court or other competent authority to be unlawful and/or unenforceable, the other



provisions of this Agreement will continue in effect. If any unlawful and/or unenforceable provision would be lawful or enforceable if part of it were deleted, that part will be deemed to be deleted, and the rest of the provision will continue in effect (unless that would contradict the clear intention of the parties, in which case the entirety of the relevant provision will be deemed to be deleted).

- 22.3 This Agreement may not be varied except by a written document signed by or on behalf of each of the parties.
- 22.4 Neither party may without the prior written consent of the other party assign, transfer, charge, license or otherwise deal in or dispose of any contractual rights or obligations under this Agreement.
- 22.5 This Agreement is made for the benefit of the parties, and is not intended to benefit any third party or be enforceable by any third party. The rights of the parties to terminate, rescind, or agree any amendment, waiver, variation or settlement under or relating to this Agreement are not subject to the consent of any third party.
- 22.6 Subject to Clause 16.1, this Agreement shall constitute the entire agreement between the parties in relation to the subject matter of this Agreement, and shall supersede all previous agreements, arrangements and understandings between the parties in respect of that subject matter.
- 22.7 This Agreement shall be governed by and construed in accordance with the laws of the United States of America.
- 22.8 The courts of the United States of America shall have exclusive jurisdiction to adjudicate any dispute arising under or in connection with this Agreement.

#### 23. Interpretation

- 23.1 In this Agreement, a reference to a statute or statutory provision includes a reference to:
  - (a) that statute or statutory provision as modified, consolidated and/or reenacted from time to time; and
  - (b) any subordinate legislation made under that statute or statutory provision.
- 23.2 The Clause headings do not affect the interpretation of this Agreement.
- 23.3 In this Agreement, general words shall not be given a restrictive interpretation by reason of being preceded or followed by words indicating a particular class of acts, matters or things.

The Customer can install multiple properties within their Resort User Dashboard.

Reports, CRM and Email Marketing modules are included with the system at no additional cost.

The Reservation Management Platform does generate printable PDF invoices for guests and invoice e-mail capabilities are included as well.

The Reservation Management Platform does contain a site grid, interactive map, and customized programming if needed.

Reservations are for Outdoor recreation accommodations include but are not limited to: RV Sites, Primitive Camping Sites, Cabins, Yurts, Teepees, Tree Houses, Lots, Tiny Houses, Casitas, Lodges, Wagons or Caves.

The system can be accessed by the consumer one of three ways, a MobileRVing Reservation widget installed within customer's website, manual entry through the Walk-in Module, or from free marketing forms located throughout MobileRving.com & MobileRVing 2.0.

#### 2. Financial provisions



The reservation system does not retain consumer credit card information. All credit card and bank account data is submitted through the billing provider selected by the property. The Customer can choose their billing provider within the "Billing Dashboard", located in the administrative section of the system.

*Each reservation logged into the Reservation Management Platform is considered a billable reservation with the exception of cancellations and refunds.* 

Reservations that comply with the above standards are billed, only one time, for \$3.00 USD. This expense is passed on to the guest but paid for by the customer.

All reservations will be batch paid daily. Itemized reports for billing are available within the billing dashboard.

#### Schedule 2 (Acceptable Use Policy)

#### 1. Introduction

<u>Background</u> The City's 2018 Annual Budget and Capital Improvements Plan included \$480,000 within the Major, Local and General Street Funds for various street and sidewalk improvements within the Central Business District and miscellaneous sidewalk repairs city-wide. Areas scheduled for reconstruction include Petoskey Street and East Lake Street intersection, Petoskey Street and Bay Street intersection including the Bay Street dead-end near Beards Brewery. Street segments scheduled for asphalt resurfacing and concrete spot-repairs include Petoskey Street from East Lake Street to East Mitchell and East Lake Street from Howard Street to US-31. Miscellaneous sidewalk repairs and replacements are also part of this project and include segments along Michigan and State Streets between Waukazoo Avenue and Howard Street. The proposed project limits are shown in yellow on the enclosed map.

<u>Scope</u> Upgrades and improvements within the project limits include; installation of brick paver type crosswalks with concrete headers at the Petoskey and Lake intersection; ADA accessible ramps at all crosswalks; reconfigured curb-lines that provide street bump-outs near Bayfront tunnel for better defined cross walks that will improve pedestrian and vehicular safety; brick paver installations near Bayfront Tunnel; installation of rolled or mountable curb for loading/unloading near Petoskey Plastics; modifications to landscaping and tree plantings; added signage and paint striping; utility repairs and adjustments; and segments of asphalt street resurfacing.

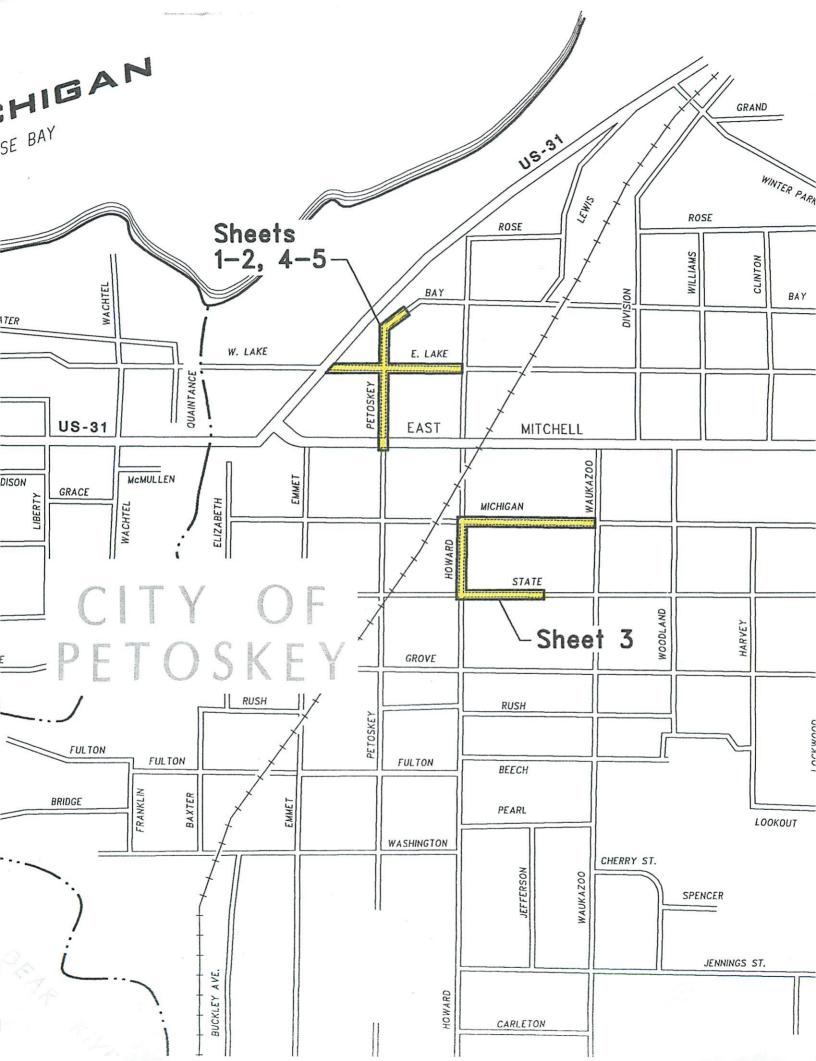
<u>Specifications and Bids</u> Design review for the project was performed by Beckett and Raeder, Inc., Ann Arbor and Petoskey; street layout along with bid documents and specifications were prepared by Benchmark Engineering, Inc., Harbor Springs. Bid packets were made available on December 13, 2017; three bids were received on January 9, 2018.

<u>Note</u>: Although low bid is nearly \$99,000 under budgeted amounts, certain elements for this project will be supplied by the City, such items include intersection and sidewalk brick pavers, safety railing near Bayfront Park Tunnel, tree plantings, landscapings and restorations.

<u>Review</u> Following review of the bids that were received January 9, City staff recommends that the City Council authorize contracting with Tri-County Excavating Group, LLC, Harbor Springs, for this proposed project for \$381,469.28.

<u>Budget</u> The City's 2018 Annual Budget and Capital Improvements Plan included \$625,000 within the Water and Sewer Fund and General Street Fund to replace an aging water transmission main located along West Lake Street between Ingalls Avenue and Magnus Park along with sidewalk improvements and upgrades along the same segment of West Lake Street.

<u>History</u> The water main proposed to be replaced was constructed in the mid 1960's and is a 10inch-high pressure cast iron transmission main that runs from Ingalls Pump Station, located at Bayfront Park West, to the Elevated Tank located adjacent to the 911 Call Center. This is a critical main to the City's water system and is designated a transmission type main because of its ability to transport large volumes of water from Bay Harbor water sources to the Upper Pressure District. This main has a significant break history and in recent years has caused the City to issue "Water Boil Alerts" due to the loss of pressure and draining of the Elevated Tank. Although the segment of main being replaced with this project encompasses areas of past failures and will mitigate disruptions, portions of this water main south of US-31 will remain on the radar screen for future replacement.

<u>Improvements</u> Due to the magnitude of construction activities involving the replacement of the water main, street and sidewalk improvements will also be a part of this project. Sidewalk improvements include widening the existing 6-foot sidewalk on the north side of West Lake Street to a 10-foot non-motorized path width from the Solanus Mission to Magnus Park. Street improvements include realigned curb-lines that narrow West Lake Street from its current 30-foot width to a 25-foot width that ultimately provides space for the proposed non-motorized path and maintain a 5 foot green-lawn for tree planting. Other improvements include upsizing the current water main from 10 inch to 12 inch, tree planting, LED street lighting upgrades, street paving and storm sewer adjustments.

<u>Specifications and Bids</u> Design review for the project was performed by Beckett and Raeder, Inc., Ann Arbor and Petoskey; street layout along with water utility installations were designed by Benchmark Engineering, Inc., Harbor Springs. Bid packets were made available on December 14, 2017; three bids were received on January 10, 2018.

<u>Note</u>: Although this project came in just over 2% of proposed estimates, City staff is confident this project can be completed within budgeted amounts of the Water and Sewer Fund and General Street Fund based on savings realized on other projects and potential gains through value engineering.

<u>Review</u> Following review of the bids that were received January 10, City staff recommends that the City Council authorize contracting with Elmer's Crane and Dozer, Inc., Petoskey, for this proposed project for \$638,577.90.

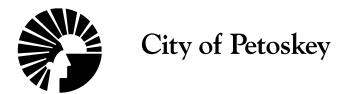
<u>Background</u> The 2018 Annual Budget and Capital Improvements Plan included \$471,400 within the Major Street Fund for rehabilitation work to the Bridge Street Bridge through a grant as provided by the Michigan Department of Transportation (MDOT) Local Bridge Program. The Bridge Street Bridge, located between Franklin and Porter Streets, was constructed over the Bear River in 1976. MDOT requires bridges within the City's jurisdiction to be inspected at a minimum of every two years. Since year 2013, the Bridge Street Bridge has been on an annual inspection cycle due to the deteriorating conditions of certain components of the bridge.

<u>Grant Application</u> In 2015, City staff along with consultant Northwest Design Group, who performs the City's bridge inspections, successfully submitted a grant application to MDOT's Local Bridge Program for funding that would be available for fiscal year 2018. As a condition to the 2015 grant application, City Council passed a resolution May 4, 2015 supporting the application along with committing to funding the required Local Share.

<u>Summary</u> The enclosed resolution would authorize the Mayor and City Clerk to execute a contract with MDOT for the rehabilitation of the Bridge Street Bridge. Under MDOT's Local Bridge Program, MDOT would provide 95% of eligible construction cost which is estimated at \$416,400 with the City or Local Share being responsible for the remaining 5% of construction cost along with design and construction engineering that is estimated at \$55,000.

<u>Recommendation</u> City staff recommends that the City Council approve the enclosed resolution that would authorize the Mayor and City Clerk to execute a contract with the Michigan Department of Transportation for the rehabilitation of the Bridge Street Bridge.

<u>Background</u> The City's 2018 Annual Budget and Capital Improvements Plan allocated \$509,000 within the Motor Pool Fund to purchase certain vehicles and equipment. Capital Expenditures as proposed for year 2018 would replace existing vehicles and equipment within the Motor Pool.

For many years the City has routinely made purchases from the State of Michigan Mi-Deal Purchasing Contract. Mi-Deal is an extended purchasing program which allows Michigan local units of government to use state contracts to buy goods and services. City purchases are normally limited to road salt, vehicles and equipment.

All proposed purchases as listed below will be through the Mi-Deal State Purchasing Contract except for a large commercial mower unit. This equipment unit will be purchased through another type of extended purchasing program called the National Intergovernmental Purchasing Alliance (National IPA), which the City has been a member since 2012. Similar to the Mi-Deal program, membership is for public entities only and pricing is based on actual contracts as procured by other public agencies throughout the country.

The following list of proposed vehicles and equipment make up the majority of Motor Pool Fund purchases for 2018 except for one large 45,000 GVW Heavy-Duty Plow Truck that is estimated at \$260,000. City staff is currently working on specifications which will establish final pricing in the near future.

<u>Recommendation</u> City staff recommends that the City Council authorize purchases for the following vehicles and equipment under the Mi-Deal State of Michigan purchasing contract and the National IPA.

- Mi-Deal purchase of a latest production four-wheel-drive, <sup>3</sup>/<sub>4</sub> ton, GMC Pick-up from Todd Wenzel Fleet and Commercial Truck Sales, Westland, at a cost not to exceed \$29,139.70 (Budget Allocated \$33,000). This vehicle will replace Parks and Recreation Plow Unit #46, a 2006 Ford Pick-up with approximately 62,000 miles, that will be retired.
- Mi-Deal purchase of a latest production four-wheel-drive, <sup>3</sup>/<sub>4</sub> ton, GMC Pick-up from Todd Wenzel Fleet and Commercial Truck Sales, Westland, at a cost not to exceed \$29,139.70 (Budget Allocated \$29,000). This vehicle will replace Public Works Water Division Unit #73, a 2008 Dodge Pick-up with approximately 92,000 miles, that will be retired.

- Mi-Deal purchase of a latest production four-wheel-drive Tahoe Police Pursuit from Berger Chevrolet Fleet Sales, Grand Rapids, at a cost not to exceed \$36,689.00 (Budget Allocated \$39,000). This vehicle would replace Public Safety Director's Unit #450, a 2010 Ford Expedition, with approximately 80,000 miles, that will be retired.
- Mi-Deal purchase of a latest production four-wheel-drive Tahoe Police Pursuit from Berger Chevrolet Fleet Sales, Grand Rapids, at a cost not to exceed \$36,865.00 (Budget Allocated \$45,000). This vehicle would replace Public Safety Patrol Unit #446, a 2014 Tahoe Pursuit, with approximately 85,000 miles, that will be retired.
- Mi-Deal purchase of a latest production four-wheel-drive, ½ ton, Chevrolet Crew-Cab Pick-up from Berger Chevrolet Fleet Sales, Grand Rapids, at a cost not to exceed \$32,694.00 (Budget Allocated \$35,000). This vehicle would replace Public Safety Unit #531, a 2002 Crew-Cab Pick-up, with approximately 47,000 miles, that will be retired.
- National IPA purchase of a latest production commercial mower, type Toro Groundsmaster with out-front and side-wing deck assemblies from Spartan Distributors, Sparta, at a cost not to exceed \$64,260.70 (Budget Allocated \$68,000). This unit would replace Parks and Recreation mower Unit #150, a similar type commercial mower, with approximately 3800 hours of operation, that will be retired.
