

Ordinance No. 5-20

AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO ADVERTISE AND ACCEPT BIDS FOR THE UPTOWN PUBLIC PARKING LOT IMPROVEMENT PROJECT.

WHEREAS, Village Council has adopted the 2020 Village of Plain City operating budget and capital improvement plan; and

WHEREAS, the improvement of the public parking lot leased by the Village in the Uptown district is a public works project included in the 2020 budget; and

WHEREAS, Ohio Revised Code Section 735.05 requires Village Council to adopt an ordinance authorizing the village administrator to advertise and accept bids for said project; and

WHEREAS, Village Council wishes to commence the public bidding process as soon as is permissible by law in the hope of obtaining more favorable project pricing than may be attainable by advertising at a later date.

NOW THEREFORE BE IT ORDAINED by the Council of the Village of Plain City, Ohio, a majority of the members elected or appointed thereto concurring, as follows:

- Section 1.** The Village Administrator is hereby authorized and directed to advertise and accept bids for the Uptown Public Parking Lot Improvement Project pursuant to Ohio Revised Code Section 735.05.
- Section 2.** Upon receiving and opening bids for said project, the Village Administrator shall present a recommendation as to whether to award a contract in connection with the public bidding process. Award of a contract for the project shall be authorized by action of Village Council in accordance with the Ohio Revised Code.
- Section 3. Effective Date.** This ordinance shall be in full force and effect from and after the earliest period provided by law.
