

Ordinance No. 13-22 b

**AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO AWARD THE CONTRACT FOR THE VILLAGE OF PLAIN CITY PASTIME PARK SPORTS COURT RECONSTRUCTION TO BUCKEYE FENCE BUILDERS**

**WHEREAS**, Village Council has adopted the 2022 Village of Plain City operating budget and capital improvement plan; and

**WHEREAS**, the basketball court reconstruction project is included in the 2022 budget; and

**WHEREAS**, in accordance with R.C. 735.05, the Village advertised for not less than two nor more than four consecutive weeks in a newspaper of general circulation within the Village; and

**WHEREAS**, having reviewed each bid, the Village's engineer has identified the bid from Buckeye Fence Builders as the best, lowest and responsible bid and recommends it be accepted; and

**WHEREAS**, the Village Administrator concurs with the Village Engineer's assessment and now seeks authority of the Village Council to award the bid to Buckeye Fence Builders in the amount of \$186,219; and,

**WHEREAS**, the Village Administrator requests authority, consistent with industry standards, of Village Council to approve, without the necessity of further Council action, change orders on the project not to exceed 10% of the bid.

**NOW THEREFORE BE IT ORDAINED** by the Council of the Village of Plain City, Ohio, a majority of the members elected or appointed thereto concurring, as follows:

**Section 1.** The Village Administrator is hereby authorized and directed to accept the bid of and execute an agreement with Buckeye Fence Builders for the Pastime Park Sports Court Reconstruction Project in the amount of \$186,219.

**Section 2.** The Village Administrator is hereby authorized to approve requested change orders on this project not to exceed 10% of the total bid without the need of further approval of Council.

**Section 3.** The Village Finance Director is authorized and directed to take all action necessary to appropriate and disburse funds in accordance with the contract.
