

Ordinance No. 28-2022

**AN ORDINANCE FOR FINAL APPROPRIATIONS FOR CURRENT EXPENSES
AND OTHER EXPENDITURES OF THE VILLAGE THROUGH DECEMBER 31,
2023.**

WHEREAS, it is incumbent upon the Council to provide appropriations for the current expenses and other expenditures of the Village; and

WHEREAS, Council has previously done so for the fiscal year ending December 31, 2022; and

WHEREAS, Council has generally continued to review the prior appropriations, and also specifically considered changes necessitated by various issues and events in the operation of the Village, and modified the same;

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Plain City, Ohio, as follows:

Section 1. That the sum of 24 Million, 139 Thousand, 717 Dollars and 46 Cents (\$24,139,717.46) is necessary to be appropriated to meet the fiscal obligations of the Village of Plain City for fiscal year 2023 and such sums are hereby set aside and appropriated in accordance with the attached operating and capital improvement plan budgets referenced as Exhibit "C" attached hereto and incorporated by reference herein.

Section 2. That the Village Finance Director is hereby authorized to draw warrants on the Village treasury for payments from the foregoing appropriations upon receiving proper certificates and vouchers therefor, approved by the board or officers authorized by law to approve the same, or an ordinance or resolution of Council to make the expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of, and in accordance with, law or ordinance.
