

A RESOLUTION AMENDING CERTAIN PARK ADMINISTRATIVE CHARGES.

WHEREAS, it is deemed appropriate and necessary to amend administrative charges for the use of Village park properties and their facilities in order to continue to maintain and operate the parks and their facilities; and

WHEREAS, the Village Administrator and the Parks and Recreation Director have conducted a review of current administrative charges and have identified certain charges that are proposed for adjustment; and

WHEREAS, the Council of the Village of Plain City discussed these proposed adjustments previously in a work session.

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Plain City, Ohio, as follows:

Section 1. The following park administrative charges shall be amended as detailed in this Section and said amended charges shall become effective pursuant to Section 3 of this Resolution:

Pastime Park

Youth Building: \$75.00 per day, plus \$25.00 fee for prior-day set-up after 6:00 pm.

Camping: **Water Tank Fill Fee:** \$5.00.

Tent Sites: \$15.00 per day, two week per season maximum stay.

Full Hook-Up Site: \$38.00 regular rate/\$35.00 senior rate per day.

Improved Sites with Upgraded Pads, Electric, and Water: \$35.00 regular rate/\$32.00 senior rate per day. Monthly rate of \$950.00 regular rate/\$900.00 senior rate.

Unimproved Sites with Electric and Water: \$28.00 regular rate/\$25.00 senior rate per day. Monthly rate of \$800.00 regular rate/\$725.00 senior rate.

Section 2. All ordinances and resolutions, or parts thereof, in conflict with the provisions of this resolution are hereby repealed and of no further force or effect.

Section 3. This Resolution shall be effective from and after the earliest period provided by law.
