NOW THEREFORE BE IT RESOLVED by the Council of the Village of Plain City, Ohio, as follows:

Council hereby approves the appropriation of a total of \$131,500 from various Section 1. Village funds as detailed as follows:

General Fund - \$20,000 for inspections fees (Darby Fields)

General Fund - \$65,500 for new income tax office operations costs

Pool Fund - \$5,000 for wage adjustments resulting from State of Ohio minimum wage increase

Pool Fund - \$16,000 for pool operations costs (concessions)

Sewer Operating Fund - \$25,000 for sludge removal

Section 2. That the Village Fiscal Officer is hereby authorized and directed to make such appropriations and distribute funds in accordance with Section 1 above.

Section 3. This Resolution shall be effective from and after the earliest period provided by law.
