

**A RESOLUTION APPROVING A SUPPLEMENTAL APPROPRIATION OF FUNDS FOR VARIOUS MUNICIPAL PURPOSES AND DECLARING AN EMERGENCY.**

**WHEREAS**, it is incumbent upon the Council to provide appropriations for the current expenses and other expenditures of the Village; and

**WHEREAS**, the Village has encountered certain operational issues requiring an adjustment of 2019 appropriations; and

**WHEREAS**, the Village Council also recently passed certain legislation adjusting the wages and salaries of Village employees for which current 2019 appropriations for said operational costs were not included in the original 2019 budget, and

**WHEREAS**, the Village Council has determined that the appropriations are appropriate and necessary to ensure proper and quality service delivery to Plain City's residents, property owners, and businesses.

**NOW THEREFORE BE IT RESOLVED** by the Council of the Village of Plain City, Ohio, as follows:

**Section 1.** Council hereby approves the appropriation of a total of \$50,000 from various Village funds as detailed as follows:

- General Fund - \$25,000 for contractual service and utilities (IT, utility costs, and other expenses)
- Pool Fund - \$4,000 for concessions expenses
- Recreation Fund - \$4,000 additional contractual services and expenditure of donations received
- Park Fund - \$10,000 for wages and benefits
- Streets Operating Fund - \$7,000 for wages/benefits

**Section 2.** That the Village Fiscal Officer is hereby authorized and directed to make such appropriations and distribute funds in accordance with Section 1 above.

**Section 3.** This resolution is declared to be an emergency measure, effective immediately upon passage for the preservation of the public peace, health and safety of the Village. Such emergency exists as, time is of the essence to ensure that the Village has sufficient funds appropriated to fulfill its current and on-going financial obligations for 2019.
