

A RESOLUTION RESCINDING RESOLUTION 01-19.

WHEREAS, the Council of the Village of Plain City previously passed Resolution 01-19 that approved, with contingencies, the petition of the City of Columbus for an adjustment of the Columbus regional facility planning boundary and authorized the Village Administrator to execute the same; and

WHEREAS, the Village's approval under Resolution 01-19 was contingent upon the execution of a master service agreement between the Village and the City of Columbus upon terms satisfactory to the Village; and

WHEREAS, the Village and the City of Columbus have not been able to come to a mutually satisfactory agreement upon the terms and conditions of said master service agreement; and

WHEREAS, the Village does not believe that further negotiations with the City of Columbus will result in the successful resolution of the matter; and

WHEREAS, in order to protect the health, safety, and welfare of the residents of the Village of Plain City and to commence plans to provide water and sanitary sewer utility services as the Village continues to grow and develop by other means, the Village wishes to rescind its previous contingent approval of the City of Columbus' petition.

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Plain City, Ohio, as follows:

Section 1. Council hereby rescinds Resolution 01-19 in its entirety and revokes its contingent approval of the City of Columbus petition for an adjustment of the Columbus regional facility planning boundary.

Section 2. Council hereby authorizes the Village Administrator to take any and all necessary action to formally file the Village's revocation of its previous contingent approval with the City of Columbus, the Ohio Environmental Protection Agency, and any other party related to the matter.

Section 3. This Resolution shall be effective from and after the earliest period provided by law.
