

**RESOLUTION NO. 33-19**

**A RESOLUTION AUTHORIZING EXECUTION OF A CONTRACT WITH  
GOVDEALS, INC. FOR INTERNET-BASED AUCTION SERVICES.**

**WHEREAS**, the Village of Plain City has the need, from time to time, to sell unneeded and obsolete equipment; and

**WHEREAS**, Ohio Revised Code Section 721.15 provides that unneeded, obsolete or unfit vehicles, equipment or machinery may be sold by the officer having supervision or management over the property to be sold if its estimated value is less than \$1,000.00; and

**WHEREAS**, Ohio Revised Code Section 721.15 provides that unneeded, obsolete, or unfit vehicles, equipment or machinery may be sold by the officer having supervision or management over the property to be sold if its estimated value is greater than \$1,000.00 only with the approval of Council; and

**WHEREAS**, GovDeals, Inc. operates an internet-based auction that can be used by the Village to sell unneeded, obsolete or unfit vehicles, equipment, or machinery; and

**WHEREAS**, Council believes it is desirable to enter into contract with GovDeals, Inc. for the sale of unneeded, obsolete or unfit vehicles, equipment or machinery, as may be appropriate, during the calendar year 2020.

**BE IT RESOLVED** by the Council of the Village of Plain City, Ohio, as follows:

**Section 1.** That a contract be entered into with GovDeals, Inc., a Delaware corporation having its principal place of business at 5907 Carmichael Place, Montgomery, Alabama, for internet-based auction services.

**Section 2.** Said services shall be provided as set forth in the Online Auction Memo of Understanding attached hereto as Exhibit "A", the terms of which are incorporated by reference as if fully restated herein.

**Section 3.** That the Village Administrator is authorized and directed to complete and execute such Online Auction Memo of Understanding on behalf of the Village and take any and all action necessary to complete the Agreement.

**Section 4.** This resolution shall be effective from and after the earliest period provided by law.
