

Resolution No. 14-20

A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO ACCEPT THE BID OF, AND EXECUTE AN AGREEMENT WITH G&G ENTERPRISES, COMPLETE EXCAVATING SERVICES, LLC, FOR THE SOUTH CHILlicothe STREET WATER MAIN REPLACEMENT PROJECT, AND DECLARING AN EMERGENCY.

WHEREAS, Council has previously approved and authorized the advertising and acceptance of public bids for the South Chillicothe Street Water Main Replacement Project; and

WHEREAS, in accordance with R.C. 735.05, the Village advertised for not less than two nor more than four consecutive weeks in a newspaper of general circulation within the Village, or as provided in R.C. 7.16; and

WHEREAS, the Village of Plain City received bid responses; and

WHEREAS, having reviewed each bid, the Village's engineer has identified G&G Enterprises, Complete Excavating Services, Inc.'s bid as the best, lowest and responsible bid and recommends it be accepted; and

WHEREAS, the Village Administrator concurs with the Village Engineer's assessment and now seeks authority of the Village Council to award the bid to G&G Enterprises, Complete Excavating Services, Inc. in the amount of \$229,215.00; and,

WHEREAS, the Village Administrator requests authority, consistent with industry standards, of Village Council to approve, without the necessity of further Council action, change orders on the project not to exceed 10% of the bid; and,

WHEREAS, the Village Council has determined that the South Chillicothe Street Water Main Replacement Project is an infrastructure improvement that is necessary for the protection of the public health safety and welfare and that time is of the essence in order to complete this needed public improvement to provide adequate public water supply to its residents. As such, this Resolution must be passed as an emergency measure in the interest of the health, safety and general welfare of the residents of the Village.

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Plain City, Ohio, a majority of the members elected or appointed thereto concurring, as follows:

Section 1. The Village Administrator is hereby authorized and directed to accept the bid of, and execute an agreement with, G&G Enterprises, Complete Excavating Services, Inc. for the South Chillicothe Street Water Main Replacement Project in the amount of \$229,215.00.

Section 2. The Village Administrator is hereby authorized to approve requested change orders on this project not to exceed 10% of the total bid without the need of further approval of Council.

Section 3. The Village Fiscal Officer is authorized and directed to take all action necessary to appropriate and disburse funds in accordance with the contract.

Section 4. The Village Council has determined that this Resolution is an emergency measure necessary for the protection of the public health, safety and welfare of the residents of the Village of Plain City and this Resolution shall be in full force and effect from and immediately upon its adoption.
